A RESOLUTION

- 1 Redesignating portions of SR 154 and SR 10 as Memorial Drive; to repeal Part 4 of a
- 2 Resolution Act approved May 1, 2000 (Ga. L. 2000, p. 1894); and for other purposes.
- 3 WHEREAS, in light of the losses of life sustained by the United States of America on and
- 4 after September 11, 2001, as a result of attacks on this nation by foreign enemies and in
- 5 defense of this nation against further such attacks as part of Operation Enduring Freedom,
- 6 it is altogether fitting and proper that this state appropriately honor the memory of those who
- 7 perished in such attacks and who loyally and selflessly gave their own lives to rescue and
- 8 defend their fellow citizens.
- 9 NOW, THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY OF
- 10 GEORGIA that the portion of SR 154 in DeKalb County from its intersection with Candler
- 11 Road in Decatur, Georgia, to its intersection with SR 10 in DeKalb County; and that portion
- of SR 10 in DeKalb County from its intersection with SR 154 to its intersection with U.S.
- 13 Highway 78 in DeKalb County (Cynthia McKinney Parkway from Candler Road in Decatur
- 14 to U.S. Highway 78 in DeKalb County) is hereby redesignated and shall henceforth be
- 15 known again as Memorial Drive in honor and memory of all of those United States citizens
- who died on or after September 11, 2001, as a result of attacks on this nation by foreign
- 17 enemies and in defense of this nation against further such attacks as part of Operation
- 18 Enduring Freedom; and the Department of Transportation is authorized and directed to erect
- 19 and maintain appropriate signs identifying the same.
- 20 BE IT FURTHER RESOLVED that Part 4 of a Resolution Act approved May 1, 2000 (Ga.
- 21 L. 2000, p. 1894), is hereby repealed, which read as follows:
- 22 "Part 4
- NOW, THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY OF
- 24 GEORGIA that the portion of State Highway 154 in DeKalb County from its intersection
- with Candler Road in Decatur, Georgia, to its intersection with State Highway 10 in
- DeKalb County; and that portion of State Highway 10 in DeKalb County from its
- intersection with State Highway 154 to its intersection with U.S. Highway 78 in DeKalb

1 County (Memorial Drive from Candler Road in Decatur to U.S. Highway 78 in DeKalb

- 2 County) is designated and shall henceforth be known as the Cynthia McKinney Parkway.
- 3 The Department of Transportation is authorized and directed to place and 28 maintain signs
- 4 designating such parkway."
- 5 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized
- 6 and directed to transmit an appropriate copy of this resolution to the Department of
- 7 Transportation.
