A RESOLUTION

- 1 Commending the Presbytery of Greater Atlanta; and for other purposes.
- 2 WHEREAS, the Presbytery of Greater Atlanta is a supportive network of churches that
- 3 strives to help each church be the best congregation that it can be; and
- 4 WHEREAS, the Presbytery of Greater Atlanta serves to connect, equip, and empower
- 5 congregations to carry out their local missions and to facilitate the missions and objectives
- 6 of churches that cannot be accomplished alone; and
- 7 WHEREAS, the focus of the Presbytery of Greater Atlanta is connecting congregations to
- 8 each other and to the larger church; and
- 9 WHEREAS, the Presbytery of Greater Atlanta forms new congregations; helps find the
- 10 necessary financing to start new churches; enlists, provides supervision, and guides the
- 11 preparation of candidates for the ministry; works with local church pastor nominating
- 12 committees to assist in finding and calling pastoral leadership; and assists congregations in
- meeting the challenges of growth and mission opportunities; and
- 14 WHEREAS, there are 110 churches in the Presbytery of Greater Atlanta with 63,000
- 15 Presbyterian church members and 385 Presbyterian pastors; and
- 16 WHEREAS, the boundaries of the Presbytery of Greater Atlanta include 19 counties in the
- 17 metropolitan Atlanta area; and
- 18 WHEREAS, there are two Presbyterian seminaries within the boundaries of the Presbytery
- 19 of Greater Atlanta, Columbia Presbyterian Seminary and Johnson C. Smith Theological

- 2 Presbyterian Church, and the largest Presbyterian church with a female pastor, Trinity
- 3 Presbyterian Church, are a part of the Presbytery of Greater Atlanta; and
- 4 WHEREAS, the Presbytery of Greater Atlanta is the third largest presbytery in the United
- 5 States; and
- 6 WHEREAS, it is fitting and proper that this body recognize and commend the Presbytery of
- 7 Greater Atlanta.
