## A BILL TO BE ENTITLED AN ACT

- 2 the Board of Commissioners of Carroll County, approved February 28, 1989 (Ga. L. 1989,
- 3 p. 3546), as amended, so as to reconstitute the board of commissioners; to change the
- 4 descriptions of the commissioner districts; to provide for definitions and inclusions; to
- 5 provide for continuation in office of the current chairperson and members; to provide for the
- 6 election and terms of office of subsequent chairpersons and members; to provide for
- 7 eligibility and qualifications; to provide for submission of this Act for approval under the
- 8 federal Voting Rights Act of 1965, as amended; to provide for an effective date; to repeal
- 9 conflicting laws; and for other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

- 12 An Act amending, revising, superseding, and consolidating the laws pertaining to the Board
- of Commissioners of Carroll County, approved February 28, 1989 (Ga. L. 1989, p. 3546),
- 14 as amended, is amended by striking Sections 2, 3, and 4 and inserting in their places the
- 15 following:

16 "SECTION 2.

- 17 The Board of Commissioners of Carroll County which existed on December 31, 2001, is
- 18 continued in existence but on and after July 1, 2002, shall be constituted as provided in this
- 19 Act. The Board of Commissioners of Carroll County so continued and constituted,
- sometimes referred to in this Act as the 'board,' shall continue to have the powers, duties,
- 21 rights, obligations, and liabilities of that board as existed immediately prior to July 1, 2002.
- SECTION 3.
- 23 (a) Those members of the Board of Commissioners of Carroll County who are serving as
- such on June 30, 2002, and any person selected to fill a vacancy in any such office shall

1 continue to serve as such members until the regular expiration of their respective terms of 2 office and upon the election and qualification of their respective successors. On and after 3 July 1, 2002, the Board of Commissioners of Carroll County shall consist of seven 4 members six of whom shall be elected from commissioner districts described in subsection 5 (b) of this section and the member who is chairperson and who is elected at large as 6 provided in Section 4 of this Act. 7 (b) For purposes of electing members of the board of commissioners, other than the 8 chairperson, Carroll County is divided into six commissioner districts. One member of the 9 board shall be elected from each such district. The six commissioner districts shall be and correspond to those six numbered districts described in and attached to and made a part of 10 this Act and further identified as Plan Name: carrollccp4 Plan Type: LOCAL User: PaulH 11 12 Administrator: Carroll CC. 13 (c) When used in such attachment, the terms 'Tract' and 'BG' (Block Group) shall mean 14 and describe the same geographical boundaries as provided in the report of the Bureau of 15 the Census for the United States decennial census of 2000 for the State of Georgia. The 16 separate numeric designations in a Tract description which are underneath a 'BG' heading 17 shall mean and describe individual Blocks within a Block Group as provided in the report 18 of the Bureau of the Census for the United States decennial census of 2000 for the State of 19 Georgia. Any part of Carroll County which is not included in any such district described 20 in that attachment shall be included within that district contiguous to such part which 21 contains the least population according to the United States decennial census of 2000 for 22 the State of Georgia. Any part of Carroll County which is described in that attachment as 23 being in a particular district shall nevertheless not be included within such district if such 24 part is not contiguous to such district. Such noncontiguous part shall instead be included 25 within that district contiguous to such part which contains the least population according 26 to the United States decennial census of 2000 for the State of Georgia. Except as otherwise provided in the description of any commissioner district, whenever the description of such 27 district refers to a named city, it shall mean the geographical boundaries of that city as 28 29 shown on the census map for the United States decennial census of 2000 for the State of 30 Georgia.

32 (a) No person shall be a member of the board if that person is ineligible for such office 33 pursuant to Code Section 45-2-1 of the O.C.G.A. or any other general law applicable to that 34 office.

(b) In order to be elected as a member of the board from a commissioner district, a person must receive the number of votes cast as required by general law for that office in that

district only. Only electors who are residents of that commissioner district may vote for a member of the board for that district. At the time of qualifying for election as a member of the board from a commissioner district, each candidate for such office shall specify the commissioner district for which that person is a candidate. A person elected or appointed as a member of the board from a commissioner district must continue to reside in that district during that person's term of office or that office shall become vacant. (c) The member of the board who is chairperson of the board may reside anywhere within Carroll County and, if elected, must receive the number of votes cast for that office as required by general law in the entire county. The chairperson must continue to reside within the county during that person's term of office or that office shall become vacant. (d) The first members of the reconstituted Board of Commissioners of Carroll County from Commissioner Districts 2, 4, and 6 shall be elected at the general election on the Tuesday next following the first Monday in November, 2002. Those members of the board elected thereto from Commissioner Districts 2, 4, and 6 in 2002 shall take office the first day of January immediately following that election and shall serve for initial terms of office which expire December 31, 2006, and upon the election and qualification of their respective successors. The first members of the reconstituted Board of Commissioners of Carroll County from Commissioner Districts 1, 3, and 5 and the chairperson shall be elected at the general election on the Tuesday next following the first Monday in November 2004. The chairperson and those members of the board elected thereto from Commissioner Districts 1, 3, and 5 in 2004 shall take office the first day of January immediately following that election and shall serve for initial terms of office which expire December 31, 2008, and upon the election and qualification of their respective successors. Those and all future successors to the chairperson and the members of the board whose terms of office are to expire shall be elected at the time of the state-wide general election immediately preceding the expiration of such terms, shall take office the first day of January immediately following that election, and shall serve for terms of office of four years. The chairperson and members of the board shall serve for the terms of office specified therefor in this subsection and until their respective successors are elected and qualified. (e) All members of the board who are elected thereto shall be nominated and elected in accordance with Chapter 2 of Title 21 of the O.C.G.A., the 'Georgia Election Code.' (f) Commissioner Districts 1, 2, 3, 4, 5, and 6 as they exist on December 31, 2001, shall continue to be designated as Commissioner Districts 1, 2, 3, 4, 5, and 6, respectively, but as newly described under this Act, and on and after July 1, 2002, such members of the board serving from those former commissioner districts shall be deemed to be serving from

and representing their respective districts as newly described under this section."

SECTION 2.

- 2 Said Act is further amended by striking Section 18 and inserting in its place a new Section
- 3 18 to read as follows:
- 4 "SECTION 18.
- 5 Reserved."
- 6 SECTION 3.
- 7 It shall be the duty of the attorney of the Board of Commissioners of Carroll County to
- 8 submit this Act for approval pursuant to Section 5 of the federal Voting Rights Act of 1965,
- 9 as amended.
- 10 SECTION 4.
- 11 This Act shall become effective on July 1, 2002.
- 12 SECTION 5.
- 13 All laws and parts of laws in conflict with this Act are repealed.
