A BILL TO BE ENTITLED
AN ACT

1 To amend Title 43 of the Official Code of Georgia Annotated, relating to professions and
2 businesses, so as to substantially revise and restate the law governing the practice of
3 veterinary medicine and the licensure and regulation of veterinarians, veterinary technicians,
4 and veterinary facilities; to provide a short title; to define terms; to provide for the scope of
5 veterinary practice; to provide for the State Board of Veterinary Medicine and its powers and
6 duties, membership, selection, compensation, and service; to provide for standards and
7 requirements for licensing of veterinarians; to provide for regulation of veterinary practice;
8 to provide for expiration and renewal of licenses; to provide for sanctions and penalties and
9 practice and procedure in connection therewith; to prescribe criminal offenses and
10 punishment therefor; to provide for civil actions; to provide for the licensing and regulation
11 of veterinary technicians; to provide for standards, registration, inspection, enforcement, and
12 practices and procedures with respect to veterinary facilities; to provide for immunity from
13 civil liability under certain circumstances; to provide for other matters related to the
14 foregoing; to provide for an effective date and for applicability; to repeal conflicting laws;
15 and for other purposes.

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

17 **SECTION 1.**

18 Title 43 of the Official Code of Georgia Annotated, relating to professions and businesses,
19 is amended by striking Chapter 50 and inserting in its place a new chapter to read as follows:

20 "CHAPTER 50

21 ARTICLE 1

22 43-50-1.

23 This chapter shall be known and may be cited as the 'Georgia Veterinary Practice Act.'

1 43-50-2.

2 This chapter is enacted as an exercise of the powers of the state to promote the public
3 health, safety, and welfare by safeguarding the people of this state against incompetent,
4 dishonest, or unprincipled practitioners of veterinary medicine.

5 43-50-3.

6 As used in this chapter, the term:

7 (1) 'Accredited or approved college or school of veterinary medicine' means any
8 veterinary college or school or division of a university or college that offers the degree
9 of Doctor of Veterinary Medicine or its equivalent and that conforms to the standards
10 required for accreditation or approval by the American Veterinary Medical Association
11 Council on Education or its successor organization or is recognized by the board as
12 conforming to the standards of accreditation required of schools or colleges of veterinary
13 medicine in the United States or Canada.

14 ~~(1)~~(2) 'Animal' means any animal other than man and includes fowl, birds, fish, and
15 reptiles, wild or domestic, living or dead.

16 (3) 'AVMA accredited program in veterinary technology' means any postsecondary
17 educational program of two or more academic years that has fulfilled the essential criteria
18 established by the Committee on Veterinary Technician Education and Activities and
19 approved by the American Veterinary Medical Association.

20 ~~(2)~~(4) 'Board' means the State Board of Veterinary Medicine.

21 (5) 'Direct supervision' means that the licensed veterinarian is on the premises and is
22 quickly and easily available and that the animal patient has been examined by a licensed
23 veterinarian at such time as acceptable veterinary medical practice requires, consistent
24 with the particular delegated animal health care task.

25 (6) 'ECFVG certificate' means a certificate issued by the American Veterinary Medical
26 Association Educational Commission for Foreign Veterinary Graduates or its successor
27 organization indicating the holder has demonstrated knowledge and skill equivalent to
28 that possessed by a graduate of an accredited or approved college of veterinary medicine.

29 (7) 'Emergency' means an animal has been placed in a life-threatening condition and
30 immediate treatment is necessary to sustain life.

31 (8) 'Immediate supervision' means the licensed veterinarian is in audible and visual range
32 of the animal patient and the person treating the animal.

33 (9) 'Indirect supervision' means the licensed veterinarian is not on the premises but has
34 given either written or oral instructions for the treatment of the animal patient and the
35 animal has been examined by a licensed veterinarian at such times as acceptable

1 veterinary medical practice requires, consistent with the particular delegated health care
 2 task.

3 ~~(3) 'Licensed veterinarian' means a person who is validly and currently licensed to~~
 4 ~~practice veterinary medicine in this state.~~

5 (10) 'Licensed veterinarian' means a veterinarian, Doctor of Veterinary Medicine,
 6 D.V.M., V.M.D., or equivalently titled person who has received a doctor's degree from
 7 a college of veterinary medicine or holds an ECFVG certificate or its equivalent issued
 8 by the American Veterinary Medical Association, as determined by board rule, and is
 9 validly and currently licensed to practice veterinary medicine in this state.

10 ~~(4)~~(11) 'Person' means any individual, firm, partnership, limited liability company,
 11 association, joint venture, cooperative, and corporation or any other group or combination
 12 acting in concert; and whether or not acting as a principal, trustee, fiduciary, receiver, or
 13 as any other kind of legal or personal representative, or as the successor in interest,
 14 assignee, agent, factor, servant, employee, member, director, officer, or any other
 15 representative of such person.

16 ~~(5)~~(12) To 'practice veterinary medicine' means:

17 (A) To diagnose, treat, correct, change, relieve, or prevent animal disease, deformity,
 18 defect, injury, or other physical or ~~mental conditions~~ behavioral disease, including the
 19 prescription, ~~or~~ administration, or dispensing of any drug, medicine, biologic,
 20 apparatus, application, anesthetic, or other therapeutic or diagnostic substance or
 21 technique on, for, or to any animal, including but not limited to acupuncture, animal
 22 dentistry, homeopathic or manual or mechanical adjustment procedures, administer
 23 rabies vaccine, botanical medicine, physical or massage therapy, surgery, diagnostic
 24 veterinary pathology, implantation of microchips or similar devices, any manual,
 25 mechanical, biological, or chemical procedure used ~~testing~~ for pregnancy testing, or for
 26 correcting sterility or infertility, or to render advice or recommendations with regard
 27 to any of the above;

28 (B)(i) To apply or use any instrument or device on any portion of an animal's tooth,
 29 gum, or any related tissue for the prevention, cure, or relief of any wound, fracture,
 30 injury, disease, or other condition of an animal's tooth, gum, or related tissue.

31 (ii) To engage in preventive dental procedures on animals including, but not limited
 32 to, the removal of calculus, soft deposits, plaque, or stains or the smoothing, filing,
 33 or polishing of tooth surfaces.

34 (iii) Nothing in this subparagraph shall prohibit any person from utilizing cotton
 35 swabs, gauze, dental floss, dentifrice, toothbrushes, or similar items to clean an
 36 animal's teeth;

1 (C) To represent, directly or indirectly, publicly or privately, an ability and willingness
2 to do any act described in subparagraphs (A) and (B) of this paragraph; ~~and~~

3 (D) To use any title, words, abbreviation, or letters in a manner or under circumstances
4 which induce the belief that the person using them is legally authorized or qualified to
5 ~~do any perform an~~ act described in subparagraphs (A) and (B) of included in this
6 paragraph, ~~except where such person is a veterinarian. Such use shall be prima-facie~~
7 evidence of the intention to represent oneself as engaged in the practice of veterinary
8 medicine;

9 (E) To apply principles of environmental sanitation, food inspection, environmental
10 pollution control, zoonotic disease control, and disaster medicine in the promotion and
11 protection of public health as it specifically relates to animals;

12 (F) To collect blood or other samples for the purpose of diagnosing diseases or related
13 conditions. This subparagraph shall not apply to unlicensed professionals employed by
14 or under contract to the United States Department of Agriculture or the Georgia
15 Department of Agriculture who are engaged in their official duties; and

16 (G) To administer a rabies vaccination to any animal that the state requires to be
17 vaccinated.

18 (13) 'Prescription drug' includes any medicine, medication, or pharmaceutical or
19 biological product whose manufacturer's label must, pursuant to federal or state law, have
20 the following statement printed on its packaging: 'Federal law restricts this drug to use
21 by or on the order of a licensed veterinarian'; or any over-the-counter product that is used
22 in a manner different from the label directions and that by definition requires a valid
23 veterinarian-client-patient relationship for prescription or dispensing.

24 (14) 'Registered veterinary technician' means a graduate of an AVMA accredited
25 program in veterinary technology or a person so recognized by the board in rules and
26 regulations promulgated to regulate veterinary technicians that is validly and currently
27 registered to practice veterinary technology in this state.

28 ~~(6) 'School of veterinary medicine' means any veterinary college or division of a~~
29 ~~university or college that offers the degree of Doctor of Veterinary Medicine or its~~
30 ~~equivalent and that conforms to the standards required for accreditation by the American~~
31 ~~Veterinary Medical Association.~~

32 ~~(7)~~(15) 'Veterinarian' means a person who has received a doctor's degree in veterinary
33 medicine from a college or school of veterinary medicine.

34 (16) 'Veterinarian-client-patient relationship' means that:

35 (A) The licensed veterinarian or his or her licensed designee has assumed the
36 responsibility for making medical judgments regarding the health of the animal and the

1 need for medical treatment, and the client (owner or caretaker) has agreed to follow the
 2 instruction of the licensed veterinarian;

3 (B) There is sufficient knowledge of the animal by the licensed veterinarian to initiate
 4 at least a general or preliminary diagnosis of the medical condition of the animal. This
 5 means that the licensed veterinarian has recently seen and is personally acquainted with
 6 the keeping and care of the animal by the virtue of this examination of the animal or by
 7 medically appropriate and timely visits to the premises where the animal is kept; and
 8 (C) A licensed veterinarian is readily available for follow up in the case of adverse
 9 reactions or failure of the regimen of therapy.

10 (17) 'Veterinary facility' means any premises where the practice of veterinary medicine
 11 occurs including, but not limited to, veterinary hospitals, clinics, mobile clinics, or any
 12 other premises where a licensed veterinarian practices veterinary medicine. This
 13 provision does not include private property where the licensed veterinarian treats the
 14 clients' animals.

15 (8)(18) 'Veterinary medicine' includes veterinary surgery, obstetrics, dentistry, and all
 16 other branches or specialties of veterinary medicine.

17 (19) 'Veterinary technology' means the science and art of providing all aspects of
 18 professional medical care and treatment for animals with the exception of making a
 19 diagnosis or prognosis, performing surgery, and the administration of rabies vaccine to
 20 animals legally required to be vaccinated by the state, and the prescription of
 21 medications.

22 ARTICLE 2

23 43-50-20.

24 (a) The State Board of Veterinary Medicine is created, the members of which shall be
 25 appointed by the Governor with the approval of the Secretary of State and confirmed by
 26 the Senate. The board shall consist of ~~six~~ seven members, each appointed for a term of five
 27 years or until his successor is appointed. Five members of the board shall be duly licensed
 28 veterinarians actually engaged in active practice for at least five years prior to appointment.
 29 The sixth member shall be appointed from the public at large and shall in no way be
 30 connected with the practice of veterinary medicine. The initial appointment for the sixth
 31 member shall expire June 30, 1985; thereafter, successors shall be appointed for a term of
 32 five years. The seventh member shall be a duly registered veterinary technician who has
 33 been registered and actively engaged in the practice of veterinary technology for at least
 34 five years prior to appointment. The initial appointment of the veterinary technician shall

1 expire on June 30, 2007; thereafter, successors shall be appointed for a term of five years.

2 Those members of the Georgia State Board of Veterinary Examiners serving on July 1,
3 ~~1965~~ 2002, shall continue to serve as members of the board until the expiration of the term
4 for which they were appointed. Thereafter, successors to such board members shall be
5 appointed in accordance with this Code section.

6 (b) Vacancies due to death, resignation, removal, or otherwise shall be filled for the
7 remainder of the unexpired term in the same manner as regular appointments. No person
8 shall serve two consecutive five-year terms, but a person appointed for a term of less than
9 five years may succeed himself.

10 (c) No person may serve on the board who is, or was during the two years preceding his
11 appointment, a member of the faculty, trustees, or advisory board of a veterinary school.

12 (d) Each member of the board shall be reimbursed as provided for in subsection (f) of Code
13 Section 43-1-2.

14 (e) Any member of the board may be removed by the Governor after a hearing by the board
15 determines cause for removal.

16 (f) The board shall meet at least once each year at the time fixed by the board. Other
17 necessary meetings may be called by the president of the board by giving such notice as
18 shall be established by the board. Meetings shall be open and public except that the board
19 may meet in closed session to prepare, approve, administer, or grade examinations or to
20 deliberate the qualifications of an applicant for license or the disposition of a proceeding
21 to discipline a licensed veterinarian.

22 (g) At its annual meeting, the board shall organize by electing a president and such other
23 officers as may be required by the board. Officers of the board serve for terms of one year
24 and until a successor is elected, without limitation on the number of terms an officer may
25 serve. The president shall serve as ~~chairman~~ chairperson of board meetings.

26 43-50-21.

27 (a) The board shall have the power to:

28 (1) Examine and determine the qualifications and fitness of applicants for a license to
29 practice veterinary medicine and veterinary technology in this state;

30 (2) Issue, renew, refuse to renew, deny, suspend, or revoke licenses to practice veterinary
31 medicine and veterinary technology in this state or otherwise discipline licensed
32 veterinarians and registered veterinary technicians; and to issue, renew, deny, suspend,
33 or revoke veterinary faculty licenses, consistent with this article and the rules and
34 regulations adopted under this article;

35 (3) Conduct investigations for the purpose of discovering violations of this article or
36 grounds for disciplining licensed veterinarians;

1 (4) Hold hearings on all matters properly brought before the board; and, in connection
 2 therewith, to administer oaths, receive evidence, make the necessary determinations, and
 3 enter orders consistent with the findings. The board may designate one or more of its
 4 members to serve as its hearing officer;

5 (5) Appoint from its own membership one member to act as a representative of the board
 6 at any meeting within or outside the state where such representative is deemed desirable;

7 (6) Bring proceedings in the courts for the enforcement of this article or any regulations
 8 made pursuant to this article; and

9 (7) Adopt, amend, or repeal all rules necessary for its government and all regulations
 10 necessary to carry this article into effect, including the establishment and publication of
 11 standards of professional conduct for the practice of veterinary medicine.

12 (b) The powers enumerated in subsection (a) of this Code section are granted for the
 13 purpose of enabling the board to supervise effectively the practice of veterinary medicine
 14 and are to be construed liberally to accomplish this objective.

15 43-50-22.

16 (a) No person may practice veterinary medicine in this state who is not a licensed
 17 veterinarian or the holder of a valid temporary license issued by the division director
 18 pursuant to this article.

19 (b) A licensed veterinarian may practice veterinary medicine as an employee of a
 20 corporation, partnership, or other business organization only so long as the articles of
 21 incorporation, partnership, or business organization documents clearly state that the
 22 licensed veterinarian is not subject to the direction of anyone not licensed to practice
 23 veterinary medicine in Georgia in making veterinary medical decisions or judgments.

24 43-50-23.

25 (a) Any person desiring a license to practice veterinary medicine in this state shall make
 26 written application to the board. The application shall include evidence, satisfactory to the
 27 board, that:

28 (1) The applicant has attained the age of 18;

29 (2) The applicant is of good moral character;

30 (3) The applicant is a graduate of ~~a veterinary school~~ an accredited or approved college
 31 or school of veterinary medicine or possesses a foreign equivalency, as determined by
 32 board rule; provided, however, that a senior veterinary student may, in the discretion of
 33 the board, be allowed to sit for the examination during his senior year if he meets the
 34 other qualifications but shall not be issued a license unless and until he graduates; and

1 (4) Has never had his or her United States Drug Enforcement Administration privileges
 2 restricted or revoked; and

3 ~~(4)~~ (5) The applicant meets such other qualifications or provides such other information
 4 as the board may require by rule.

5 (b) The application shall be accompanied by a fee in the amount established by the board.

6 (c) If the board determines that an applicant possesses the proper qualifications, it shall
 7 admit the applicant to the next examination.

8 43-50-24.

9 (a) The board shall hold at least one examination during each year and may hold such
 10 additional examinations as are necessary.

11 (b) After each examination, the division director shall notify each examinee of the result
 12 of his examination, and the board shall issue licenses to the persons successfully
 13 completing the examination. The division director shall record the new licenses and issue
 14 a certificate of registration to the new licensees. ~~Any person failing an examination shall~~
 15 ~~be admitted to any subsequent examination on payment of the application fee. If an~~
 16 applicant fails an examination, the applicant may take a subsequent examination upon
 17 payment of the registration and examination fees. No person may take the examination
 18 more than three times without review and approval by the board. Approval may be
 19 provided under such circumstances as the board deems appropriate.

20 43-50-25.

21 Any person holding a valid license to practice veterinary medicine in this state on July 1,
 22 1965, shall be recognized as a licensed veterinarian and shall be entitled to retain this status
 23 so long as he complies with this article, including biennial renewal of the license.

24 43-50-26.

25 (a) All licenses shall be renewable biennially.

26 (b) Any person who shall practice veterinary medicine after the expiration of his license
 27 and willfully or by neglect fail to renew such license shall be practicing in violation of this
 28 article, provided that any person may renew an expired license within one year of the date
 29 of its expiration by making written application for renewal and paying the current renewal
 30 fee plus all delinquent renewal fees. After one year has elapsed from the date of the
 31 expiration, such license may be reinstated in accordance with the rules of the board.

32 (c) The board may by rule waive the payment of the registration renewal fee of a licensed
 33 veterinarian during the period when he or she is on active duty with any branch of the

1 armed forces of the United States, not to exceed the longer of three years or the duration
2 of a national emergency.

3 (d)(1) The board shall establish a program of continuing professional veterinary medical
4 education for the renewal of veterinarian licenses. Notwithstanding any other provision
5 of this article, beginning with the licenses which are to be renewed in 1990, no license
6 to practice veterinary medicine shall be renewed by the board or the division director
7 until the veterinarian submits to the board satisfactory proof of his or her participation,
8 during the biennium preceding his or her application for renewal, in approved programs
9 of continuing professional veterinary medical education, as defined in this Code section.
10 Veterinarians who have been licensed in this state for 40 years or more on December 31,
11 1988, shall not be required to participate in continuing education as a condition of license
12 renewal. The amount of continuing education required by the board under this paragraph
13 shall not ~~exceed~~ be less than 30 hours and shall be established by board rule.

14 (2) Continuing professional veterinary medical education shall consist of educational
15 programs providing training pertinent to the practice of veterinary medicine and approved
16 by the board under this Code section. The board ~~shall~~ may approve educational programs
17 for persons practicing veterinary medicine in this state on a reasonable nondiscriminatory
18 fee basis and may contract with institutions of higher learning, professional organizations,
19 or qualified individuals for the provision of approved programs. In addition to such
20 programs, the board ~~shall~~ may allow the continuing professional veterinary medical
21 education requirement to be fulfilled by the completion of approved ~~correspondence~~
22 distance learning courses ~~which provide the required hours of approved programs of~~
23 ~~continuing professional veterinary medical education or to be fulfilled by a combination~~
24 ~~of approved correspondence courses and other educational programs~~ with the number of
25 hours being established by board rule.

26 (3) The board may, consistent with the requirements of this Code section, promulgate
27 rules and regulations to implement and administer this Code section, including the
28 establishment of a committee to prescribe standards, approve and contract for educational
29 programs, and set the required minimum number of hours per year.

30 (e) The board shall provide by regulation for an inactive status license for those individuals
31 who elect to apply for such status. Persons who are granted inactive status shall not engage
32 in the practice of veterinary medicine and shall be exempt from the requirements of
33 continuing veterinary medical education.

34 43-50-27.

35 (a) The board is authorized to refuse to grant a license to an applicant, or to revoke the
36 license of a veterinarian licensed by the board, or to discipline a veterinarian licensed under

1 this chapter or any antecedent law, or to discipline a veterinary technician licensed under
2 this chapter or any antecedent law, upon a finding by a majority of the entire board that the
3 licensee, registrant, or applicant has:

4 (1) Failed to demonstrate the qualifications or standards for a license contained in this
5 chapter or in the rules and regulations issued by the board, pursuant to specific statutory
6 authority. It shall be incumbent upon the applicant to demonstrate to the satisfaction of
7 the board that he or she meets all the requirements for the issuance of a license, and, if
8 the board is not satisfied as to the applicant's qualifications, it may deny a license without
9 a prior hearing; provided, however, that the applicant shall be allowed to appear before
10 the board if he or she so desires;

11 (2) Knowingly made misleading, deceptive, untrue, or fraudulent representations in the
12 practice of veterinary medicine or on any document connected therewith; or practiced
13 fraud or deceit or intentionally made any false statement in obtaining a license to practice
14 veterinary medicine or veterinary technology; or made a false statement or deceptive
15 biennial registration with the board;

16 (3) Been convicted of any felony or of any crime involving moral turpitude in the courts
17 of this state or any other state, territory, or country or in the courts of the United States.
18 As used in this paragraph, the term 'felony' shall include any offense which, if committed
19 in this state, would be deemed a felony without regard to its designation elsewhere. As
20 used in this paragraph, the term 'conviction' shall include a finding or verdict of guilty or
21 a plea of guilty, regardless of whether an appeal of the conviction has been sought;

22 (4) Been arrested, charged, and sentenced for the commission of any felony, or any crime
23 involving moral turpitude, where:

24 (A) A plea of nolo contendere was entered to the charge;

25 (B) First offender treatment without adjudication of guilt pursuant to the charge was
26 granted; or

27 (C) An adjudication or sentence was otherwise withheld or not entered on the charge.

28 The plea of nolo contendere or the order entered pursuant to the provisions of Article 3
29 of Chapter 8 of Title 42 or other first offender treatment shall be conclusive evidence of
30 arrest and sentencing for such crime;

31 (5) Had his or her license to practice veterinary medicine or veterinary technology
32 revoked, suspended, or annulled by any lawful licensing veterinary medical authority
33 other than the board; or had other disciplinary action taken against him by any lawful
34 licensing veterinary medical authority other than the board; or was denied a license by
35 any lawful licensing veterinary medical authority other than the board, pursuant to
36 disciplinary proceedings; or was refused the renewal of a license by any lawful licensing
37 veterinary medical authority other than the board, pursuant to disciplinary proceedings;

1 (6) Engaged in any unprofessional, immoral, unethical, deceptive, or deleterious conduct
2 or practice harmful to the public, which conduct or practice materially affects the fitness
3 of the licensee, registrant, or applicant to practice veterinary medicine or veterinary
4 technology, or of a nature likely to jeopardize the interest of the public, which conduct
5 or practice need not have resulted in actual injury or be directly related to the practice of
6 veterinary medicine or veterinary technology but shows that the licensee, registrant, or
7 applicant has committed any act or omission which is indicative of bad moral character
8 or untrustworthiness. Unprofessional conduct shall also include any departure from, or
9 the failure to conform to, the minimal standards of acceptable and prevailing veterinary
10 medical practice. Unprofessional conduct shall also include, but not be limited to, the
11 following: failure to keep veterinary premises and equipment in a clean and sanitary
12 condition; dishonesty or gross negligence in the inspection of foodstuffs or the issuance
13 of health or inspection certificates; or cruelty to animals;

14 (7) Knowingly performed any act which in any way aids, assists, procures, advises, or
15 encourages any unlicensed person or any licensee or registrant whose license has been
16 suspended or revoked by the board to practice veterinary medicine or to practice outside
17 the scope of any disciplinary limitation placed upon the licensee or registrant by the
18 board;

19 (8) Violated a statute, law, or any rule or regulation of this state, any other state, the
20 board, the United States, or any other lawful authority (without regard to whether the
21 violation is criminally punishable), which statute, law, rule, or regulation relates to or in
22 part regulates the practice of veterinary medicine or veterinary technology, when the
23 licensee, registrant, or applicant knows or should know that such action violates such
24 statute, law, rule, or regulation; or violated the lawful order of the board previously
25 entered by the board in a disciplinary hearing, consent decree, or license reinstatement;

26 (9) Been adjudged mentally incompetent by a court of competent jurisdiction within or
27 without this state. Any such adjudication shall automatically suspend the license of any
28 such person and shall prevent the reissuance or renewal of any license so suspended for
29 as long as the adjudication of incompetence is in effect;

30 (10) Displayed an inability to practice veterinary medicine or veterinary technology with
31 reasonable skill and safety to patients or has become unable to practice veterinary
32 medicine or veterinary technology with reasonable skill and safety to patients by reason
33 of illness, use of alcohol, drugs, narcotics, chemicals, or any other type of material, or as
34 a result of any mental or physical condition, or by reason of displaying habitual
35 intoxication, addiction to, or recurrent personal misuse of alcohol, drugs, narcotics,
36 chemicals, or any other type of similar substances. In enforcing this paragraph, the board
37 may, upon reasonable grounds, require a licensee, registrant, or applicant to submit to a

1 mental or physical examination by physicians designated by the board. The results of
 2 such examination shall be admissible in any hearing before the board, notwithstanding

34 (13) Knowingly made any fraudulent, misleading, or deceptive statement in any form of
 35 advertising or made any statement in any advertisement concerning the quality of the
 36 veterinary services rendered by that licensed veterinarian or any licensed veterinarian
 37 associated with him or her. For purposes of this paragraph, 'advertising' shall include any

1 information communicated in a manner designated to attract public attention to the
2 practice of the licensee; or

3 (14) Used, prescribed, or sold any veterinary prescription drug or prescribed an
4 extralable use of any over-the-counter drug in the absence of a valid
5 veterinarian-client-patient relationship.

6 (b) The provisions of Chapter 13 of Title 50, the 'Georgia Administrative Procedure Act,'
7 with respect to emergency action by the board and summary suspension of a license or
8 registration are adopted and incorporated by reference into this chapter.

9 (c) For purposes of this Code section, the board may obtain, and is authorized to subpoena,
10 upon reasonable grounds, any and all records relating to the mental or physical condition
11 of a licensee, registrant, or applicant, and such records shall be admissible in any hearing
12 before the board.

13 (d) When the board finds that any person is unqualified to be granted a license or
14 registration or finds that any person should be disciplined pursuant to subsection (a) of this
15 Code section, the board may take any one or more of the following actions:

16 (1) Refuse to grant or renew a license or registration to an applicant;

17 (2) Administer a public or private reprimand, but a private reprimand shall not be

11 (a) Effective July 1, 2002, any veterinary facility shall be required to register with the
12 board. Any person who owns or operates any veterinary facility shall apply for and secure
13 a facility permit from the board prior to the commencement of any services that would
14 subject the provider of those services to licensing under this chapter.

15 (b) Each application for a facility permit shall set forth the name and address of the
16 licensed veterinarian in charge of the facility, who shall be responsible for the provision
17 of veterinary medical services at the facility, and the name and address of the owner of the
18 facility. No facility shall be permitted to operate unless it has a licensed veterinarian in
19 charge of the facility. The owner or licensed veterinarian in charge of a facility shall notify
20 the board in writing of any change of ownership or legal responsibility for the facility.

21 (c) Prior to the issuance of a facility permit, the board shall require the applicant facility
22 to submit a self-inspection form approved by the board. The board shall promulgate rules
23 and regulations which establish minimum standards for veterinary facilities including
24 sanitary conditions, record-keeping practices and procedures, equipment, radiation
25 monitoring, and physical plant. In lieu of a self-inspection form, the board may issue a
26 facility permit upon receipt of proof that the facility has been inspected and accredited by
27 an organization recognized by the board, the standards of which are found by the board to
28 meet or exceed the minimum standards established by the board.

29 (d) Upon complaint or on a periodic basis the board shall be authorized to make, or cause
30 to be made through licensed veterinarians that are employees or agents of the board, such
31 inspections of veterinary facilities as the board.

32 (e) All facility permits shall be renewed biennially. Any facility permit that is not renewed
33 within 90 days of the expiration of the permit shall be revoked by operation of law. A
34 revoked facility permit may be reinstated at the discretion of the board.

1 (f) The board shall have the authority to sanction a facility permit based on any ground or
2 violation enumerated in Code Section 43-50-27 or as a result of violations of rules and
3 regulations adopted by the board under subsection (c) of this Code section. The board shall
4 have the authority to establish a fine schedule for violations of minimum standards of
5 veterinary facilities. Such fines shall be listed in a schedule contained in the rules and
6 regulations of the board. A fine should not be deemed a contested case under Chapter 13
7 of Title 50, the 'Georgia Administrative Procedure Act'; however, the owner or licensed
8 veterinarian in charge of the facility shall be entitled to a personal appearance before the
9 board.

12 Any licensed veterinarian or registered veterinary technician duly registered with the state
13 who gratuitously and in good faith gives emergency treatment to a sick or injured animal
14 at the scene of an accident or emergency shall not be in violation of this chapter and shall
15 not be liable to the owner of such animal in any civil action for damages. This Code section
16 is not intended to provide immunity for acts of gross negligence."

17 **SECTION 2.**

18 This Act shall become effective on July 1, 2002. This Act does not affect rights and duties
19 that matured, penalties that were incurred, and proceedings that were begun before its
20 effective date.

22 All laws and parts of laws in conflict with this Act are repealed.
