## A RESOLUTION

- 1 Commending Reverend E. W. Lee; and for other purposes.
- 2 WHEREAS, Reverend E. W. Lee has long been recognized by the citizens of this state for  
3 the vital role that he has played in leadership and his deep personal commitment to the  
4 education and welfare of the citizens of Georgia; and
- 5 WHEREAS, he has served as the pastor of the Shiloh Baptist Church in Henry County for  
6 over 25 years and, through his innovative and progressive style of leadership, he has been  
7 a catalyst for new birth, both spiritual and physical, and has put into action the admonition  
8 that "without a vision, people perish" by his dreaming his dreams and putting his faith to

22 the citizens of his community have earned him the respect and admiration of his colleagues
