AS PASSED SENATE

**A BILL TO BE ENTITLED
AN ACT**

1 To amend an Act creating a Board of Commissioners of Walton County, approved August
2 1, 1929 (Ga. L. 1929, p. 747), as amended, so as to change the description of the
3 commissioner districts; to provide for definitions and inclusions; to provide for continuation
4 in office of current members; to provide for election and terms of office of subsequent
5 members; to provide for submission of this Act for approval under the federal Voting Rights
6 Act of 1965, as amended; to repeal conflicting laws; and for other purposes.

7 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

8 **SECTION 1.**

9 An Act creating a Board of Commissioners of Walton County, approved August 1, 1929 (Ga.
10 L. 1929, p. 747), as amended, is amended by striking Section 2 and inserting in its place a
11 new Section 2 to read as follows:

12 **"SECTION 2.**

13 (a) Those members of the Board of Commissioners of Walton County who are serving as
14 such immediately prior to the effective date of this Act, and any person selected to fill a
15 vacancy in any such office shall continue to serve as such members until the regular
16 expiration of their respective terms of office and upon the election and qualification of their
17 respective successors. On and after the effective date of this Act, the Board of
18 Commissioners of Walton County shall consist of seven members, six of whom shall be
19 elected from commissioner districts described in subsection (b) of this section and a
20 chairperson who is elected at large as provided in this Act.

21 (b) For purposes of electing members of the board of commissioners, other than the
22 chairperson, Walton County is divided into six commissioner districts. One member of the
23 board shall be elected from each such district. The six commissioner districts shall be and
24 correspond to those six numbered districts described in and attached to and made a part of

1 this Act and further identified as Plan Name: waltoncc3 Plan Type: Local User: Angela
2 Administrator: Walton.

3 (c) When used in such attachment, the terms 'Tract' and 'BG' (Block Group) shall mean
4 and describe the same geographical boundaries as provided in the report of the Bureau of
5 the Census for the United States decennial census of 2000 for the State of Georgia. The
6 separate numeric designations in a Tract description which are underneath a 'BG' heading
7 shall mean and describe individual Blocks within a Block Group as provided in the report
8 of the Bureau of the Census for the United States decennial census of 2000 for the State of
9 Georgia. Any part of Walton County which is not included in any such district described
10 in that attachment shall be included within that district contiguous to such part which
11 contains the least population according to the United States decennial census of 2000 for
12 the State of Georgia. Any part of Walton County which is described in that attachment as
13 being in a particular district shall nevertheless not be included within such district if such
14 part is not contiguous to such district. Such noncontiguous part shall instead be included
15 within that district contiguous to such part which contains the least population according
16 to the United States decennial census of 2000 for the State of Georgia. Except as otherwise
17 provided in the description of any commissioner district, whenever the description of such
18 district refers to a named city, it shall mean the geographical boundaries of that city as
19 shown on the census map for the United States decennial census of 2000 for the State of
20 Georgia.

21 (d) No person shall be a member of the board if that person is ineligible for such office
22 pursuant to Code Section 45-2-1 of the O.C.G.A. or any other general law applicable to that
23 office.

24 (e) In order to be elected as a member of the board from a commissioner district, a person
25 must be a resident of that commissioner district and must receive the number of votes cast
26 as required by general law for that office in that district only. Only electors who are
27 residents of that commissioner district may vote for a member of the board for that district.
28 At the time of qualifying for election as a member of the board from a commissioner
29 district, each candidate for such office shall specify the commissioner district for which
30 that person is a candidate. A person elected or appointed as a member of the board from
31 a commissioner district must continue to reside in that district during that person's term of
32 office or that office shall become vacant.

33 (f) The chairperson of the board may reside anywhere within Walton County and, if
34 elected, must receive the number of votes cast for that office as required by general law in
35 the entire county. The chairperson must continue to reside within the county during that
36 person's term of office or that office shall become vacant.

1 (g) The members of the board of commissioners shall be elected as provided in this
2 subsection. The first members from Commissioner Districts 1, 4, and 5 shall be elected at
3 the general election on the Tuesday next following the first Monday in November 2002.
4 Those members of the board elected thereto from Commissioner Districts 1, 4, and 5 in
5 2002 shall take office the first day of January immediately following that election and shall
6 serve for initial terms of office which expire December 31, 2006, and upon the election and
7 qualification of their respective successors. The chairperson and the first members from
8 Commissioner Districts 2, 3, and 6 shall be elected at the general election on the Tuesday
9 next following the first Monday in November 2004. The chairperson and those members
10 of the board elected thereto from Commissioner Districts 2, 3, and 6 in 2004 shall take
11 office the first day of January immediately following that election and shall serve for initial
12 terms of office which expire December 31, 2008, and upon the election and qualification
13 of their respective successors. Those and all future successors to the chairperson and the
14 members of the board whose terms of office are to expire shall be elected at the time of the
15 state-wide general election immediately preceding the expiration of such terms, shall take
16 office the first day of January immediately following that election, and shall serve for terms
17 of office of four years each. The chairperson and the members of the board shall serve for
18 the terms of office specified therefor in this subsection and until their respective successors
19 are elected and qualified.

20 (h) The chairperson and all members of the board who are elected thereto shall be
21 nominated and elected in accordance with Chapter 2 of Title 21 of the O.C.G.A., the
22 'Georgia Election Code.'

23 (i) Commissioner Districts 1, 2, 3, 4, 5, and 6, as they exist immediately prior to the
24 effective date of this Act, shall continue to be designated as Commissioner Districts 1, 2,
25 3, 4, 5, and 6, respectively, but as newly described under this Act, and on and after the
26 effective date of this Act, such members of the board serving from those former
27 commissioner districts shall be deemed to be serving from and representing their respective
28 districts as newly described under this Act."

29 SECTION 2.

30 It shall be the duty of the attorney of the Board of Commissioners of Walton County to
31 submit this Act for approval pursuant to Section 5 of the federal Voting Rights Act of 1965,
32 as amended.

33 SECTION 3.

34 All laws and parts of laws in conflict with this Act are repealed.
