A BILL TO BE ENTITLED
AN ACT

1 To amend an Act providing for the election of members to the Burke County board of
2 education, approved March 27, 1985 (Ga. L. 1985, p. 4481), as amended, so as to change the
3 description of the education districts; to provide for definitions and inclusions; to provide for
4 continuation in office of current members; to provide for election and terms of office of
5 subsequent members; to provide for submission of this Act for approval under the federal
6 Voting Rights Act of 1965, as amended; to repeal conflicting laws; and for other purposes.

7 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

8 **SECTION 1.**

9 An Act providing for the election of members to the Burke County board of education,
10 approved March 27, 1985 (Ga. L. 1985, p. 4481), as amended, is amended by striking
11 Section 1 and inserting in its place a new Section 1 to read as follows:

12 "SECTION 1.

13 (a) Those members of the Burke County board of education who are serving as such
14 immediately prior to the effective date of this Act and any person selected to fill a vacancy
15 in any such office shall continue to serve as such members until the regular expiration of
16 their respective terms of office and upon the election and qualification of their respective
17 successors. On and after the effective date of this Act, the Burke County board of
18 education shall consist of five members all of whom shall be elected from education
19 districts described in subsection (b) of this section.

20 (b) For purposes of electing members of the board of education, the Burke County School
21 District is divided into five education districts. One member of the board shall be elected
22 from each such district. The five education districts shall be and correspond to those five
23 numbered districts described in and attached to and made a part of this Act and further
24 identified as Plan Name: burkep1 Plan Type: Local User: Gina Administrator: Burke.

1 (c) When used in such attachment, the terms 'Tract' and 'BG' (Block Group) shall mean
2 and describe the same geographical boundaries as provided in the report of the Bureau of
3 the Census for the United States decennial census of 2000 for the State of Georgia. The
4 separate numeric designations in a Tract description which are underneath a 'BG' heading
5 shall mean and describe individual Blocks within a Block Group as provided in the report
6 of the Bureau of the Census for the United States decennial census of 2000 for the State of
7 Georgia. Any part of the Burke County School District which is not included in any such
8 district described in that attachment shall be included within that district contiguous to such
9 part which contains the least population according to the United States decennial census
10 of 2000 for the State of Georgia. Any part of the Burke County School District which is
11 described in that attachment as being in a particular district shall nevertheless not be
12 included within such district if such part is not contiguous to such district. Such
13 noncontiguous part shall instead be included within that district contiguous to such part
14 which contains the least population according to the United States decennial census of 2000
15 for the State of Georgia. Except as otherwise provided in the description of any education
16 district, whenever the description of such district refers to a named city, it shall mean the
17 geographical boundaries of that city as shown on the census map for the United States
18 decennial census of 2000 for the State of Georgia."

19 **SECTION 2.**

20 Said Act is further amended by striking Section 4 and inserting in its place a new Section 4
21 to read as follows:

22 "SECTION 4.

23 (a) The members of the Burke County board of education shall be elected as provided in
24 this subsection. The first members from Education Districts 1, 2, and 5 shall be elected at
25 the general election on the Tuesday next following the first Monday in November 2002.
26 Those members of the board elected thereto from Education Districts 1, 2, and 5 in 2002
27 shall take office the first day of January immediately following that election and shall serve
28 for initial terms of office which expire December 31, 2006, and upon the election and
29 qualification of their respective successors. The first members from Education Districts
30 3 and 4 shall be elected at the general election on the Tuesday next following the first
31 Monday in November 2004. Those members of the board elected thereto from Education
32 Districts 3 and 4 in 2004 shall take office the first day of January immediately following
33 that election and shall serve for initial terms of office which expire December 31, 2008, and
34 upon the election and qualification of their respective successors. Those and all future
35 successors to members of the board whose terms of office are to expire shall be elected at

1 the time of the state-wide general election immediately preceding the expiration of such
2 terms, shall take office the first day of January immediately following that election, and
3 shall serve for terms of office of four years each. Members of the board shall serve for the
4 terms of office specified therefor in this subsection and until their respective successors are
5 elected and qualified.

6 (b) Education Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective
7 date of this Act, shall continue to be designated as Education Districts 1, 2, 3, 4, and 5,
8 respectively, but as newly described under this Act, and on and after the effective date of
9 this Act, such members of the board serving from those former education districts shall be
10 deemed to be serving from and representing their respective districts as newly described
11 under this Act."

12 **SECTION 3.**

13 It shall be the duty of the attorney of the Burke County board of education to submit this Act
14 for approval pursuant to Section 5 of the federal Voting Rights Act of 1965, as amended.

15 **SECTION 4.**

16 All laws and parts of laws in conflict with this Act are repealed.
