## AS PASSED SENATE

## A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act entitled "Griffin-Spalding County School System," approved February 25,
- 2 1953 (Ga. L. 1953, Jan-Feb. Sess., p. 2563), as amended, particularly by a local
- 3 constitutional amendment (Ga. L. 1982, p. 2680), which was continued in force and effect
- 4 as a part of the Constitution of the State of Georgia by an Act approved February 18, 1987
- 5 (Ga. L. 1987, p. 3545), and by an Act approved April 9, 1993 (Ga. L. 1993, p. 5192), so as
- 6 to revise the districts for the election of members of the board of education; to provide for
- 7 definitions and inclusions; to provide for the manner of election; to provide for
- 8 qualifications; to provide for legislative authority; to provide for a referendum; to provide
- 9 for submission of this Act for preclearance pursuant to Section 5 of the federal Voting Rights
- 10 Act of 1965, as amended; to provide for related matters; to provide for effective dates; to
- 11 repeal conflicting laws; and for other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

13 SECTION 1A.

- 14 An Act entitled "Griffin-Spalding County School System," approved February 25, 1953
- 15 (Ga. L. 1953, Jan-Feb. Sess., p. 2563), as amended, particularly by a local constitutional
- amendment (Ga. L. 1982, p. 2680), which was continued in force and effect as a part of the
- 17 Constitution of the State of Georgia by an Act approved February 18, 1987 (Ga. L. 1987,
- 18 p. 3545), and by an Act approved April 9, 1993 (Ga. L. 1993, p. 5192), is amended by
- 19 striking Sections 2 and 3 and inserting in lieu thereof new Sections 2 and 3 to read as
- 20 follows:

- 21 "SECTION 2.
- 22 (a) The administration of the Griffin-Spalding County School System shall be vested in
- a board to be known and designated as the 'Griffin-Spalding County Board of Education.'
- Said board shall consist of five members, each of whom shall be a person of good moral
- character and at least 25 years of age at the time of assuming office as a member of said

board. Each of the five education districts hereinafter created and described shall be represented by one member of such board who shall have been a resident of the district he or she represents for at least six months prior to the date of his or her election or appointment to said board. Such members shall be elected in a nonpartisan general election held at the time of the general primary in each even-numbered year.

(b) For the purpose of electing members of the board from education districts, Spalding

County shall be divided into five education districts. One member of the board shall be elected from each such district. Those districts shall be and correspond to those five numbered districts described in and attached to and made a part of this Act and further identified as Plan Name: spaldcc5 Plan Type: Local User: Linda Administrator: Spalding. (c) When used in such attachment, the terms 'Tract' and 'BG' (Block Group) shall mean and describe the same geographical boundaries as provided in the report of the Bureau of the Census for the United States decennial census of 2000 for the State of Georgia. The separate numeric designations in a Tract description which are underneath a 'BG' heading shall mean and describe individual Blocks within a Block Group as provided in the report of the Bureau of the Census for the United States decennial census of 2000 for the State of Georgia. Any part of Spalding County which is not included in any such district described in that attachment shall be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2000 for the State of Georgia. Any part of Spalding County which is described in that attachment as being in a particular district shall nevertheless not be included within such district if such part is not contiguous to such district. Such noncontiguous part shall instead be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2000 for the State of Georgia. Except as otherwise provided in the description of any district, whenever the description of such district refers to a named city, it shall mean the geographical boundaries of that city as shown on the census map for the United States decennial census of 2000 for the State of Georgia.

29 SECTION 3.

(a) The members of the board who are in office on January 1, 2002, and any person selected to fill a vacancy on such board shall continue in office until December 31, 2002, and until successors are elected and qualified as provided herein and at that time such members' terms of office shall end.

(b) The first members of the reconstituted Griffin-Spalding County Board of Education from Education Districts 2 and 4 shall be elected in the nonpartisan general election held in conjunction with the general primary in 2002. Such members shall take office on January 1 following their election for terms of two years and until their successors are

1 elected and qualified. The first members of the reconstituted Griffin-Spalding County

2 Board of Education from Education Districts 1, 3, and 5 shall be elected in the nonpartisan

3 general election held in conjunction with the general primary in 2002. Such members shall

take office on January 1 following their election for a term of four years and until their

successors are elected and qualified.

6 (c) Successors to members elected under subsection (b) of this section shall be elected at

the nonpartisan general election next preceding the expiration of such terms of office and

shall take office on January 1 following their election for terms of four years and until their

successors are elected and qualified. All members of the board shall be nominated and

elected in accordance with the provisions of Chapter 2 of Title 21 of the O.C.G.A., the

'Georgia Election Code,' as now or hereafter amended."

## 12 SECTION 1B.

13 An Act entitled "Griffin-Spalding County School System," approved February 25, 1953

14 (Ga. L. 1953, Jan-Feb. Sess., p. 2563), as amended, particularly by a local constitutional

amendment (Ga. L. 1982, p. 2680), which was continued in force and effect as a part of the

16 Constitution of the State of Georgia by an Act approved February 18, 1987 (Ga. L. 1987,

17 p. 3545), and by an Act approved April 9, 1993 (Ga. L. 1993, p. 5192), is amended by

18 striking Sections 2 and 3 and inserting in lieu thereof new Sections 2 and 3 to read as

- 35 Administrator: Spalding. Education Districts 6 and 7 shall be and correspond to those two

districts numbered 001 and 002, respectively, described in and attached to and made a part 2 of this Act and further identified as Plan Name: SPALDCCALTSBR Plan Type: Local

(c) When used in such attachment, the terms 'Tract' and 'BG' (Block Group) shall mean and describe the same geographical boundaries as provided in the report of the Bureau of the Census for the United States decennial census of 2000 for the State of Georgia. > (b) The first members of the reconstituted Griffin-Spalding County Board of Education from Education Districts 2, 4, and 6 shall be elected in the nonpartisan general election held in conjunction with the general primary in 2002. Such members shall take office on January 1 following their election for terms of two years and until their successors are elected and qualified. The first members of the reconstituted Griffin-Spalding County Board of Education from Education Districts 1, 3, 5, and 7 shall be elected in the nonpartisan general election held in conjunction with the general primary in 2002. Such members shall take office on January 1 following their election for a term of four years and until their successors are elected and qualified.

> (c) Successors to members elected under subsections (b) of this section shall be elected at the nonpartisan general election next preceding the expiration of such terms of office and

shall take office on January 1 following their election for terms of four years and until their

- 2 successors are elected and qualified. All members of the board shall be nominated and
- 3 elected in accordance with the provisions of Chapter 2 of Title 21 of the O.C.G.A., the
- 4 'Georgia Election Code,' as now or hereafter amended."

5 SECTION 2.

- 6 This Act is passed pursuant to that local constitutional amendment (Ga. L. 1982, p. 2680)
- 7 which was ratified in 1982 and which was continued as a part of the Constitution of the State
- 8 of Georgia by an Act approved February 18, 1987 (Ga. L. 1987, p. 3545), and the
- 9 amendments herein shall supercede those provisions of such local constitutional amendment
- 10 to the extent that such provisions of such local constitutional amendment are inconsistent
- 11 with the provisions of this Act.

SECTION 3.

- 13 It shall be the duty of the attorney of the Griffin-Spalding County Board of Education to
- submit this Act for approval pursuant to Section 5 of the federal Voting Rights Act of 1965,
- 15 as amended.

SECTION 4.

- 17 Unless prohibited by the federal Voting Rights Act of 1965, as amended, the election
- superintendent of Spalding County shall call and conduct an election as provided in this
- 19 section for the purpose of submitting this Act to the electors of Spalding County for approval
- 20 or rejection. The election superintendent shall conduct this election on the first available
- 21 special election date authorized by Code Section 21-2-540 of the O.C.G.A. following the
- 22 effective date of this Act. The election superintendent shall issue the call and conduct the
- 23 election as provided by general law. The superintendent shall cause the date and purpose of
- 24 the election to be published once a week for two weeks immediately preceding the date of
- 25 the election in the official organ of Spalding County. The ballot shall have written or printed
- 26 thereon the words:
- 27 "QUESTION NO. 1
- 28 ( ) YES Shall the Griffin-Spalding County Board of Education be reduced from a
- 29 ( ) NO ten-member board to a five-member or seven-member board?
- 30 QUESTION NO. 2
- If a majority of the votes cast on Question No. 1 are in favor of reducing the
- number of members of the Griffin-Spalding County Board of Education, select
- 33 the type of board which you favor by placing a check  $(\checkmark)$  mark or (X) in the
- 34 appropriate space below. Vote for only one of the options below:

1 OPTION 1 2 A board of education composed of five members. 3 **OPTION 2** 4 A board of education composed of seven members." No voter shall vote for more than one of the options in Question No. 2. All persons desiring 5 to vote for approval of changing the composition of the Griffin-Spalding County Board of 6 7 Education to a five-member or seven-member board shall vote "Yes" on Question No. 1, and 8 those persons desiring to vote against changing the composition of the Griffin-Spalding 9 County Board of Education to a five-member or seven-member board shall vote "No" on 10 Question No. 1. If more than one-half of the votes cast on Question No. 1 are for approval 11 of changing the composition of the Griffin-Spalding County Board of Education to a five-member or seven-member board, then Section 1A or 1B and Section 2 shall become 12 13 effective as provided in this section; otherwise, neither Section 1A or 1B nor Section 2 shall 14 become effective and this Act shall be automatically repealed on the first day of January 15 following that election date. If more than one-half of the votes cast on Question No. 1 are 16 for approval of changing the composition of the Griffin-Spalding County Board of Education 17 to a five-member or seven-member board and more than one-half of the votes cast on 18 Question No. 2 are cast in favor of Option 1 or there is a tie vote between Option 1 and Option 2, then Section 1A of this Act shall become effective immediately for the sole 19 purpose of conducting the elections required by said section and for all purposes on January 20 21 1, 2003; Section 2 of this Act shall become effective on January 1, 2003; and Section 1B of 22 this Act shall be automatically repealed on January 1, 2003. If more than one-half of the 23 votes cast on Question No. 1 are for approval of changing the composition of the 24 Griffin-Spalding County Board of Education to a five-member or seven-member board and more than one-half of the votes cast on Question No. 2 are cast in favor of Option 2, then 25 26 Section 1B of this Act shall become effective immediately for the sole purpose of conducting 27 the elections required by said section and for all purposes on January 1, 2003; Section 2 of this Act shall become effective on January 1, 2003; and Section 1A of this Act shall be 28 automatically repealed on January 1, 2003. The expense of such election shall be borne by 29 Spalding County. It shall be the duty of the election superintendent to certify the results 30 thereof to the Secretary of State. 31

32 SECTION 5.

33 Except as otherwise provided in Section 4 of this Act, this Act shall become effective upon

34 its approval by the Governor or upon its becoming law without such approval.

1 SECTION 6.

2 All laws and parts of laws in conflict with this Act are repealed.
