

Senate Bill 542

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act creating a Board of Commissioners of Candler County, approved
2 March 23, 1933 (Ga. L. 1933, p. 430), as amended, so as to change the description of the
3 commissioner districts; to provide for definitions and inclusions; to provide for continuation
4 in office of current members; to provide for the selection, powers, and duties of the vice
5 chairperson; to change certain provisions regarding compensation of members of the board;
6 to provide for the selection, powers, and duties of the clerk of the board; to provide for the
7 exercise of powers, duties, and authority of the board; to provide for appointment of certain
8 officers; to provide for the powers, duties, and authority of the chairperson; to provide for
9 audits; to repeal certain provisions regarding a published statement of moneys; to provide for
10 submission of this Act for approval under the federal Voting Rights Act of 1965, as
11 amended; to repeal conflicting laws; and for other purposes.

12 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

13 **SECTION 1.**

14 An Act creating a Board of Commissioners of Candler County, approved March 23, 1933
15 (Ga. L. 1933, p. 430), as amended, is amended by striking subsections (a) and (b) of
16 Section 1, and inserting in their place new subsections (a), (b), and (b.1) to read as follows:

17 "(a) For purposes of electing members of the board of commissioners, other than the
18 chairperson, Candler County is divided into four commissioner districts. One member of
19 the board shall be elected from each such district. The four commissioner districts shall
20 be and correspond to those four numbered districts described in and attached to and made
21 a part of this Act and further identified as Plan Name: candlerccwk1 Plan Type: Local
22 User: Gina Administrator: Candler.

23 (b) When used in such attachment, the terms 'Tract' and 'BG' (Block Group) shall mean
24 and describe the same geographical boundaries as provided in the report of the Bureau of
25 the Census for the United States decennial census of 2000 for the State of Georgia. The
26 separate numeric designations in a Tract description which are underneath a 'BG' heading

1 shall mean and describe individual Blocks within a Block Group as provided in the report
 2 of the Bureau of the Census for the United States decennial census of 2000 for the State of
 3 Georgia. Any part of Candler County which is not included in any such district described
 4 in that attachment shall be included within that district contiguous to such part which
 5 contains the least population according to the United States decennial census of 2000 for
 6 the State of Georgia. Any part of Candler County which is described in that attachment as
 7 being in a particular district shall nevertheless not be included within such district if such
 8 part is not contiguous to such district. Such noncontiguous part shall instead be included
 9 within that district contiguous to such part which contains the least population according
 10 to the United States decennial census of 2000 for the State of Georgia. Except as otherwise
 11 provided in the description of any commissioner district, whenever the description of such
 12 district refers to a named city, it shall mean the geographical boundaries of that city as
 13 shown on the census map for the United States decennial census of 2000 for the State of
 14 Georgia.

15 (b.1) Commissioner Districts 1, 2, 3, and 4, as they exist immediately prior to the effective
 16 date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, and 4,
 17 respectively, but as newly described under this Act, and on and after the effective date of
 18 this Act, such members of the board serving from those former commissioner districts shall
 19 be deemed to be serving from and representing their respective districts as newly described
 20 under this Act."

21 **SECTION 2.**

22 Said Act is further amended by striking in their entirety subsections (c) and (d) of Section 4.

23 **SECTION 3.**

24 Said Act if further amended by striking Section 6 and inserting in lieu thereof a new
 25 Section 6 to read as follows:

26 **"SECTION 6.**

27 The compensation of the members of the board of commissioners, other than the chairperson,
 28 shall be at the rate of \$4,800.00 per annum for the term of office beginning January 1, 2001,
 29 and ending December 31, 2004. The chairperson shall be compensated at the rate of
 30 \$10,000.00 per annum for the term of office beginning January 1, 2001, and ending
 31 December 31, 2004. The compensation of the members of the board of commissioners and
 32 the chairperson shall be payable in equal monthly installments from the funds of Candler
 33 County; shall be subject to such increases as provided under Georgia law; and shall be

1 subject to amendment for any subsequent term by resolution or ordinance of the board of
2 commissioners."

3 **SECTION 4.**

4 Said Act if further amended by striking Section 7 and inserting in lieu thereof a new
5 Section 7 to read as follows:

6 "SECTION 7.

7 Said board of commissioners shall be authorized to appoint a clerk of said board. The clerk
8 shall be appointed by a majority vote of the board of commissioners to serve at the pleasure
9 of said board. It shall be the duty of the clerk to keep in permanent form a complete record
10 of the official acts of said board, including the receipt and disbursement of all county funds,
11 to perform generally the duties of the secretary to said board, and to perform such other
12 duties as may be required by said board. Said clerk shall report to and be under the
13 supervision and control of the county administrator. Said clerk shall receive such
14 compensation as may be fixed by said board, shall give bond with good security for the
15 faithful performance of his or her duties as such clerk as may be received by said board. The
16 compensation as set out in this section shall be fixed each year by the members of said
17 board."

18 **SECTION 5.**

19 Said Act if further amended by striking Section 9 and inserting in lieu thereof a new
20 Section 9 to read as follows:

21 "SECTION 9.

22 The board of commissioners shall exercise all powers now or hereafter vested in county
23 governing authorities by the Constitution and laws of this state, including, but not limited to,
24 the power to fix and establish, by appropriate resolution or ordinance entered on its minutes,
25 policies, rules, and regulations governing all matters which the board of commissioners has
26 authority as the governing authority of Candler County."

27 **SECTION 6.**

28 Said Act if further amended by striking Section 12 and inserting in lieu thereof a new
29 Section 12 to read as follows:

1 (2) To be the official spokesperson for the county governing authority and the chief
2 advocate of policy as established by the board of commissioners;

3 (3) To sign ordinances and resolutions upon their final passage and sign deeds, bonds,
4 contracts, and other instruments and documents in any case in which the general laws of
5 this state or any ordinance or resolution of the board of commissioners so requires and
6 authorizes;

7 (4) To call special meetings of the board of commissioners, but two members of the
8 board of commissioners shall also be authorized to call special meetings;

9 (5) To be recognized as the official head of the board of commissioners by the courts for
10 purposes of receiving civil process, by the Governor for purpose of the military law, and
11 for all ceremonial purposes;

12 (6) To assist as necessary the county administrator in preparing and organizing the
13 agenda for regular and special meetings;

14 (7) To represent the board of commissioners in matters not specifically assigned to the
15 county administrator involving the relationship of the county government with elected
16 county officers and in intergovernmental relations, particularly where questions of public
17 policy are at issue; and

18 (8) To perform such other duties as may be required by law or ordinances or resolutions
19 of the board of commissioners."

20 **SECTION 9.**

21 Said Act is further amended by adding a new section immediately following Section 13B,
22 to be designated Section 13C, to read as follows:

23 "SECTION 13C.

24 At the first regular meeting of the board of commissioners that is held in January following
25 each regular election of members of the board, the board shall elect one of its members to
26 serve as vice chairperson for such term as may be established by resolution or ordinance of
27 the board. When the vice chairperson serves in place of the chairperson, said officer may
28 exercise the powers of the chairperson, subject to any limitations provided by resolution or
29 ordinance of the board, but said officer shall not receive the compensation of the chairperson
30 while serving in the chairperson's place. The vice chairperson may serve as chairperson in
31 the absence of the chairperson as well as fill a vacancy in the office of chairperson in
32 accordance with the provisions of this Act."
