A BILL TO BE ENTITLED AN ACT

- 1 To amend Code Section 32-4-22 of the Official Code of Georgia Annotated, relating to
- 2 creation of the Developmental Highway System, so as to replace one of the road corridors
- 3 within such Developmental Highway System; to provide an effective date; to repeal
- 4 conflicting laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 SECTION 1.

- 7 Code Section 32-4-22 of the Official Code of Georgia Annotated, relating to creation of the
- 8 Developmental Highway System, is amended by striking subsection (a) and inserting in lieu
- 9 thereof a new subsection (a) to read as follows:
- 10 "(a) There is created as a part of the state highway system a system of public roads to be
- known as the Developmental Highway System which shall consist of the following road
- 12 corridors (not in order of priority):
- 13 (1) Appalachian;
- 14 (2) The South Georgia Parkway;
- 15 (3) U.S. 27;
- 16 (4) U.S. 82;
- 17 (5) Golden Isles;
- 18 (6) Savannah River;
- 19 (7) U.S. 441;
- 20 (8) Fall Line;
- 21 (9) U.S. 319;
- 22 (10) U.S. 19;
- 23 (11) U.S. 84;
- 24 (12) U.S. 1/SR 17;
- 25 (13) SR 72;

1 (14) Northern Arc further identified as the North Georgia Connector between the U.S.

- 2 Highway 411 and U.S. Highway 41 interchange in Bartow County to State Highway 316
- 3 in Gwinnett County Northern Network further identified as the existing system of roads
- 4 and highways in and about Gwinnett, Forsyth, and Cherokee counties including without
- 5 <u>limitation State Routes 9, 20, 141, 316, and 400; McGinnis Ferry Road; and those roads</u>
- 6 <u>and highways having interchanges with Georgia Route 400;</u>
- 7 (15) East-west Highway from I-59 North to I-85 North;
- 8 (16) Truck access routes, including without limitation:
- 9 (A) SR 133 from Albany to Valdosta;
- 10 (B) SR 40 from Folkston to St. Marys; and
- 11 (C) SR 125 from Fitzgerald to I-75;
- 12 (17) SR 32;
- 13 (18) Power Alley, U.S. 280 from Columbus to Savannah; and
- 14 (19) SR 125 from its intersection with SR 107 in Ben Hill County (Fitzgerald Bypass)
- to its intersection with SR 32 in Irwin County.
- Without limiting the foregoing, said system is further identified as including those roads
- and corridors referred to as 'the Governor's Road Improvement Program' in that resolution
- adopted by the State Transportation Board dated November 17, 1988."
- 19 SECTION 2.
- 20 This Act shall become effective upon its approval by the Governor or upon its becoming law
- 21 without such approval.
- SECTION 3.
- 23 All laws and parts of laws in conflict with this Act are repealed.
