### The House Committee on Motor Vehicles offers the following substitute to HB 1529:

# A BILL TO BE ENTITLED AN ACT

To amend Code Section 40-5-26 of the Official Code of Georgia Annotated, relating to applications of minors for drivers' licenses and distinctive licenses for persons under age 21, so as to provide for revocation of minors' permits and drivers' licenses upon requests by persons who signed and verified the minors' applications; to provide for issuance of new instruction permits and drivers' licenses following such revocations; to provide for insurance matters related to such revocations; to repeal conflicting laws; and for other purposes.

### BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

#### **SECTION 1.**

9 Code Section 40-5-26 of the Official Code of Georgia Annotated, relating to applications of
10 minors for drivers' licenses and distinctive licenses for persons under age 21, is amended by
11 striking subsection (a) and inserting in lieu thereof the following:

- 12 "(a)(1) The application of any person under the age of 18 years for an instruction permit 13 or driver's license shall be signed and verified by the father, mother, or guardian of the 14 applicant before a person authorized to administer oaths or, in the event there is no parent 15 or guardian, by another responsible adult.
- 16 (2)(A) A person who signed and verified a minor's successful application for an 17 instruction permit or driver's license may subsequently during such minority request revocation of the minor's instruction permit or driver's license by written notice to the 18 19 department on such form as specified thereby, signed and verified before a person 20 authorized to administer oaths. Upon receipt of such request and payment of a fee in 21 an amount equivalent to that which was required for issuance of the instruction permit or driver's license, the department shall revoke the minor's instruction permit or 22 23 driver's license. 24 (B) A minor whose instruction permit or driver's license has been revoked under this
- 25 paragraph shall not be eligible for issuance of another instruction permit or driver's
   26 license until he or she reaches 18 years of age, unless consent for issuance of an
