AS PASSED SENATE

A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act providing for the election of members of the Board of Education of
- 2 Toombs County, approved March 31, 1987 (Ga. L. 1987, p. 5121), as amended, so as to
- 3 change the description of the education districts; to provide for definitions and inclusions;
- 4 to provide for continuation in office of current members; to provide for election and terms
- 5 of office of subsequent members; to provide for submission of this Act for approval under
- 6 the federal Voting Rights Act of 1965, as amended; to provide for effective dates; to repeal
- 7 conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

- 10 An Act providing for the election of members of the Board of Education of Toombs County,
- approved March 31, 1987 (Ga. L. 1987, p. 5121), as amended, is amended by striking
- 12 Sections 1 and 2 and inserting in lieu thereof the following:
- "SECTION 1.
- 14 (a) Those members of the Board of Education of Toombs County who are serving as such
- on December 31, 2002, and any person selected to fill a vacancy in any such office shall
- 16 continue to serve as such members until the regular expiration of their respective terms of
- office and upon the election and qualification of their respective successors. On and after
- January 1, 2003, the Board of Education of Toombs County shall consist of six members
- all of whom shall be elected from education districts described in subsection (b) of this
- section except for the member who is chairperson and who is elected at large as provided
- in Section 5.

- 22 (b) For purposes of electing members of the board of education, other than the chairperson,
- the Toombs County School District is divided into six education districts. One member of
- the board shall be elected from each such district. The six education districts shall be and
- correspond to those six numbered districts described in and attached to and made a part of

this Act and further identified as Plan Name: toombssbwk2 Plan Type: Local User: Blake

(c) When used in such attachment, the terms 'Tract' and 'BG' (Block Group) shall mean and describe the same geographical boundaries as provided in the report of the Bureau of the Census for the United States decennial census of 2000 for the State of Georgia. The separate numeric designations in a Tract description which are underneath a 'BG' heading shall mean and describe individual Blocks within a Block Group as provided in the report of the Bureau of the Census for the United States decennial census of 2000 for the State of Georgia. Any part of the Toombs County School District which is not included in any such district described in that attachment shall be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2000 for the State of Georgia. Any part of the Toombs County School District which is described in that attachment as being in a particular district shall nevertheless not be included within such district if such part is not contiguous to such district. Such noncontiguous part shall instead be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2000 for the State of Georgia. Except as otherwise provided in the description of any education district, whenever the description of such district refers to a named city, it shall mean the geographical boundaries of that city as shown on the census map for the United States decennial census of 2000 for the State of Georgia.

21 SECTION 2.

22 (a) The members of the Board of Education of Toombs County shall be elected as provided in this subsection. The members from Education Districts 1, 3, and 5 shall be 23 24 elected at the general election on the Tuesday next following the first Monday in 25 November, 2002. The chairperson and those members of the board elected thereto from Education Districts 1, 3, and 5 in 2002 shall take office the first day of January 26 immediately following that election and shall serve for initial terms of office which expire 27 28 December 31, 2006, and upon the election and qualification of their respective successors. 29 The members from Education Districts 2, 4, and 6 shall be elected at the general election on the Tuesday next following the first Monday in November, 2004. Those members of 30 31 the board elected thereto from Education Districts 2, 4, and 6 in 2004 shall take office the 32 first day of January immediately following that election and shall serve for initial terms of office which expire December 31, 2008, and upon the election and qualification of their 33 34 respective successors. Those and all future successors to members of the board whose terms of office are to expire shall be elected at the time of the state-wide general election 35 immediately preceding the expiration of such terms, shall take office the first day of 36

1 January immediately following that election, and shall serve for terms of office of four

- 2 years each. Members of the board shall serve for the terms of office specified in this
- 3 subsection and until their respective successors are elected and qualified.
- 4 (b) Education Districts 2, 4, and 6, as they exist on December 31, 2002, shall continue to
- 5 be designated as Education Districts 2, 4, and 6, respectively, but as newly described under
- 6 this Act, and on and after January 1, 2003, such members of the board serving from those
- 7 former education districts shall be deemed to be serving from and representing their
- 8 respective districts as newly described under this Act."

9 SECTION 2.

10 Said Act is further amended by striking Sections 3 and 6.

11 SECTION 3.

- 12 It shall be the duty of the attorney of the Board of Education of Toombs County to submit
- 13 this Act for approval pursuant to Section 5 of the federal Voting Rights Act of 1965, as
- 14 amended.

15 **SECTION 4.**

- 16 This section and Section 3 of this Act and those provisions of this Act necessary for the
- 17 election of members of the Board of Education of Toombs County in 2002 shall become
- 18 effective upon the approval of this Act by the Governor or upon its becoming law without
- such approval. The remaining provisions of this Act shall become effective January 1, 2003.

20 SECTION 5.

21 All laws and parts of laws in conflict with this Act are repealed.
