- 15 February, 1966, to March, 1967, and was wounded in action; and
- 16 WHEREAS, the M/3/7 Vietnam Association has over 600 members and will hold its
- 17 twentieth annual reunion on July 11 through 14, 2002, at Lake Lanier Islands, with Tom
- 18 Carter serving as the host, organizer, and coordinator; and
