AS PASSED SENATE

A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act creating a Board of Commissioners of Treutlen County, approved March
- 2 12, 1935 (Ga. L. 1935, p. 807), as amended, so as to reconstitute the board of commissioners;
- 3 to change the description of the commissioner districts; to provide for definitions and
- 4 inclusions; to provide for continuation in office of current members; to provide for election
- 5 and terms of office of subsequent members; to provide for submission of this Act for
- 6 approval under the federal Voting Rights Act of 1965, as amended; to repeal conflicting
- 7 laws; and for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

- 10 An Act creating a Board of Commissioners of Treutlen County, approved March 12, 1935
- 11 (Ga. L. 1935, p. 807), as amended, is amended by striking Sections 1, 2, and 3 and inserting
- in their place new Sections 1, 2, and 3 to read as follows:
- "SECTION 1.
- 14 The Board of Commissioners of Treutlen County which existed immediately prior to the
- 15 effective date of this Act, is continued in existence but on and after the effective date of this
- Act, shall be constituted as provided in this Act. The Board of Commissioners of Treutlen
- 17 County so continued and constituted, sometimes referred to in this Act as the 'board', shall
- continue to have the powers, duties, rights, obligations, and liabilities of that board as
- 19 existed immediately prior to the effective date of this Act.
- SECTION 2.
- 21 (a) Those members of the Board of Commissioners of Treutlen County who are serving
- as such immediately prior to the effective date of this Act, and any person selected to fill
- a vacancy in any such office shall continue to serve as such members until the regular
- 24 expiration of their respective terms of office and upon the election and qualification of their

1 respective successors. On and after the effective date of this Act, the Board of

2 Commissioners of Treutlen County shall consist of five members all of whom shall be

- 3 elected from commissioner districts described in subsection (b) of this section.
- 4 (b) For purposes of electing members of the board of commissioners, Treutlen County is
- 5 divided into five commissioner districts. One member of the board shall be elected from
- 6 each such district. The five commissioner districts shall be and correspond to those five
- 7 numbered districts described in and attached to and made a part of this Act and further
- 8 identified as Plan Name: treutp2 Plan Type: Local User: Tara Administrator:
- 9 Treutlen Co.
- 10 (c) When used in such attachment, the terms 'Tract' and 'BG' (Block Group) shall mean
- and describe the same geographical boundaries as provided in the report of the Bureau of
- the Census for the United States decennial census of 2000 for the State of Georgia. The
- separate numeric designations in a Tract description which are underneath a 'BG' heading
- shall mean and describe individual Blocks within a Block Group as provided in the report
- of the Bureau of the Census for the United States decennial census of 2000 for the State of
- 16 Georgia. Any part of Treutlen County which is not included in any such district described
- in that attachment shall be included within that district contiguous to such part which
- contains the least population according to the United States decennial census of 2000 for
- the State of Georgia. Any part of Treutlen County which is described in that attachment
- as being in a particular district shall nevertheless not be included within such district if such
- 21 part is not contiguous to such district. Such noncontiguous part shall instead be included
- 22 within that district contiguous to such part which contains the least population according
- to the United States decennial census of 2000 for the State of Georgia. Except as otherwise
- provided in the description of any commissioner district, whenever the description of such
- district refers to a named city, it shall mean the geographical boundaries of that city as
- shown on the census map for the United States decennial census of 2000 for the State of
- 27 Georgia.
- 28 (d) No person shall be a member of the board if that person is ineligible for such office
- 29 pursuant to Code Section 45-2-1 of the O.C.G.A. or any other general law applicable to that
- 30 office.
- 31 (e) In order to be elected as a member of the board from a commissioner district, a person
- must receive the number of votes cast as required by general law for that office in that
- district only. Only electors who are residents of that commissioner district may vote for
- a member of the board for that district. At the time of qualifying for election as a member
- of the board from a commissioner district, each candidate for such office shall specify the
- 36 commissioner district for which that person is a candidate and must reside in that
- 37 commissioner district. A person elected or appointed as a member of the board from a

1 commissioner district must continue to reside in that district during that person's term of

2 office or that office shall become vacant.

3 SECTION 3.

4 (a) The members of the reconstituted Board of Commissioners of Treutlen County shall 5 be elected as provided in this subsection. The first members from Commissioner Districts 6 2 and 5 shall be elected at the general election on the Tuesday next following the first Monday in November, 2002. Those members of the board elected thereto from 7 8 Commissioner Districts 2 and 5 in 2002 shall take office the first day of January 9 immediately following that election and shall serve for initial terms of office which expire 10 December 31, 2006, and upon the election and qualification of their respective successors. The first members from Commissioner Districts 1, 3, and 4 shall be elected at the general 11 12 election on the Tuesday next following the first Monday in November, 2004. Those 13 members of the board elected thereto from Commissioner Districts 1, 3, and 4 in 2004 shall 14 take office the first day of January immediately following that election and shall serve for 15 initial terms of office which expire December 31, 2008, and upon the election and qualification of their respective successors. Those and all future successors to members 16 17 of the board whose terms of office are to expire shall be elected at the time of the 18 state-wide general election immediately preceding the expiration of such terms, shall take 19 office the first day of January immediately following that election, and shall serve for terms 20 of office of four years each. Members of the board shall serve for the terms of office 21 specified therefor in this subsection and until their respective successors are elected and 22 qualified.

- (b) All members of the board who are elected thereto shall be nominated and elected in accordance with Chapter 2 of Title 21 of the O.C.G.A., the 'Georgia Election Code'.
- (c) Commissioner Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, 4, and 5, respectively, but as newly described under this Act, and on and after the effective date of this Act, such members of the board serving from those former commissioner districts shall be deemed to be serving from and representing their respective districts as newly

described under this Act."

32 Said Act is further amended by striking Section 6 and inserting in its place a new Section 6

SECTION 2.

1 "SECTION 6.

2 (a) Any vacancy in office upon the board which occurs for any reason other than expiration of term shall be filled as follows:

- (1) If the vacancy occurs during the final 27 months of a term of office, within 30 days after such occurrence, the remaining members of the board shall appoint a person to fill such vacancy; or
- (2) If the vacancy occurs at any time prior to the time specified in paragraph (1) of this subsection, within 30 days after such occurrence, the remaining members of the board shall appoint a person to fill such vacancy until a successor is elected at a special election and qualified, which special election shall be held on the same date as the state-wide general election which is first held following the date of the vacancy.
- (b) Any person appointed to fill a vacancy in office pursuant to subsection (a) of this section shall meet the same eligibility requirements specified for persons who are elected to such office. Any person appointed to fill a vacancy under paragraph (1) of subsection (a) of this section or elected to fill a vacancy under paragraph (2) of subsection (a) of this section shall serve out the remainder of the unexpired term and until a successor is elected and qualified."

SECTION 3.

- 19 It shall be the duty of the attorney of the Board of Commissioners of Treutlen County to
- 20 submit this Act for approval pursuant to Section 5 of the federal Voting Rights Act of 1965,
- as amended.
