A BILL TO BE ENTITLED
AN ACT

1 To amend an Act reincorporating the City of Dillard, approved March 21, 1974 (Ga. L. 1974,
2 p. 2451), as amended, so as to change the corporate limits of said city; to provide for related
3 matters; to provide an effective date; to repeal conflicting laws; and for other purposes.

4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

5 style="text-align:center">**SECTION 1.**

6 An Act reincorporating the City of Dillard, approved March 21, 1974 (Ga. L. 1974, p. 2451),
7 as amended, is amended by designating the existing language of Section 1.02 as subsection
8 (a) and by inserting new subsections (b) through (d) to read as follows:

9 "(b) In addition to the present territory included within the corporate limits of said city, the
10 corporate limits of the City of Dillard shall specifically include the following described
11 roads, streets, and rights of way, all of which are located in Rabun County, Georgia:

12 (1) U.S. Highway 441 N - All that tract or parcel of land lying and being in Rabun
13 County, Georgia, and being more particularly described as follows: BEGINNING at the
14 intersection of U.S. Highway 441 and the corporate limits of the City of Dillard and
15 proceeding in a northerly direction, to boundary line of the State of Georgia and the State
16 of North Carolina, and containing all the property within the right of way of U.S.
17 Highway 441 as described herein.

18 (2) U.S. Highway 441 S - All that tract or parcel of land lying and being in Rabun
19 County, Georgia, and being more particularly described as follows: BEGINNING at the
20 intersection of U.S. Highway 441 and the corporate limits of the City of Dillard and
21 proceeding in a southerly direction to the intersection of U.S. 441 and Kelly's Creek
22 Road, and containing all of the property within the right of way of U.S. Highway 441 as
23 designated herein.

24 (3) Kelly's Creek Road - All that tract or parcel of land lying and being in Rabun
25 County, Georgia, and being more particularly described as follows: BEGINNING at the
26 intersection of U.S. 441 and Kelly's Creek Road, thence proceeding in a northeasterly

1 direction, to the intersection of Kelly's Creek Road and State Highway 246, containing
2 all of the property within the right of way of Kelly's Creek Road as described herein.

3 (4) Betty's Creek Road - All that tract or parcel of land lying and being in Rabun County
4 Georgia, and being more particularly described as follows: BEGINNING at the
5 intersection of Betty's Creek Road and the corporate limits of the City of Dillard, thence
6 continuing in a westerly direction to the intersection of Betty's Creek Road and O. V.
7 Justus Road and containing all of the property within the right of way of Betty's Creek
8 Road as described herein.

9 (5) State Highway 246 - All that tract or parcel of land lying and being in Rabun County
10 Georgia, and being more particularly described as follows: BEGINNING at the
11 intersection of State Highway 246 and U.S. Highway 441, thence continuing in an
12 easterly direction to the north Carolina state line, which lies southwest of Chastain Road,
13 containing all of the property within the right of way of State Highway 246 as described
14 herein.

15 (6) Franklin Street - All that tract or parcel of land lying and being in Rabun County
16 Georgia, and being more particularly described as follows: BEGINNING at the
17 intersection of Franklin Street and the corporate limits of the City of Dillard and thence
18 continuing in a southeasterly direction to the intersection of Franklin Street and Kelly's
19 Creek Road and containing all of the property within the right of way of Franklin Street
20 as described herein.

21 (c) All references to road, streets, highways, drives, circles, and other references to public
22 rights of way in subsection (b) of this section specifically include the current width of said
23 public road, street, highway, drive, circle, or other rights of way and specifically includes
24 the entire right of way.

25 (d) All references to roads, streets, highways, drives, circles, and other references to public
26 rights of way in subsections (b) and (c) of this section specifically include those roads,
27 streets, highways, drives, circles, and other public rights of way as the same currently exist
28 in the City of Dillard and Rabun County, Georgia, and as the same are a part of the City
29 of Dillard public street system, the public street and road system of Rabun County,
30 Georgia, the public street and road system of the State of Georgia and/or the United States,
31 and any other street or road which has been designated in subsections (b) and (c) of this
32 section and which has been dedicated to public purposes. A map, designated as 'Official
33 Map of the City of Dillard With Extended Boundaries - 2002' is on file in the office of the
34 Clerk of the Superior Court of Rabun County and the Office of the Clerk of the City
35 Commission of the City of Dillard and is specifically incorporated by reference for a more
36 complete and accurate description of the location of the extended corporate limits as set
37 forth in subsection (b) of this section."

1 **SECTION 2.**

2 This Act shall become effective upon its approval by the Governor or upon its becoming law
3 without such approval.

4 **SECTION 3.**

5 All laws and parts of laws in conflict with this Act are repealed.
