

ADOPTED SENATE

1 Senator Burton of the 5th offered the following amendment to the Senate State and Local
2 Governmental Operations Committee substitute to HB 1213:

3 Amend HB 1213 by inserting after "in voting;" on line 11 on page 1 "to change the forms of
4 identification authorized to identify electors at the polls;"; by redesignating Sections 14
5 through 20 as Sections 15 through 21, respectively; and by inserting between lines 6 and 7
6 on page 10 the following:

"SECTION 14.

8 Chapter 2 of Title 21 of the Official Code of Georgia Annotated, relating to primaries and
9 elections generally, is amended by striking Code Section 21-2-417, relating to presentation
10 of identification to poll workers, and inserting in lieu thereof a new Code Section 21-2-417
11 to read as follows:

12 '21-2-417.

13 (a) Each elector shall present proper identification to a poll worker at or prior to
14 completion of a voter's certificate at any polling place and prior to such person's admission
15 to the enclosed space at such polling place. Proper identification shall consist of any one
16 of the following:

17 (1) A valid Georgia driver's license;

18 (2) A valid identification card containing a photograph of the elector and issued by a
19 branch, department, agency, or entity of the State of Georgia, any other state, or the
20 United States authorized by law to issue personal identification;

21 (3) A valid United States passport;

22 (4) A valid employee identification card containing a photograph of the elector and issued
23 by any branch, department, agency, or entity of the United States government, this state,
24 or any county, municipality, board, authority, or other entity of this state;

25 (5) A valid employee identification card containing a photograph of the elector and issued
26 by any employer of the elector in the ordinary course of such employer's business;

27 (6) A valid student identification card containing a photograph of the elector from any
28 public or private college, university, or postgraduate technical or professional school
29 located within the State of Georgia; or

30 ~~(7) A valid Georgia license to carry a pistol or revolver;~~

31 ~~(8) A valid pilot's license issued by the Federal Aviation Administration or other~~
32 ~~authorized agency of the United States;~~

1 ~~(9)~~ (7) A valid United States military identification card containing a photograph of the
2 elector;

3 ~~(10)~~ A certified copy of the elector's birth certificate;

4 ~~(11)~~ A valid social security card;

5 ~~(12)~~ Certified naturalization documentation; or

6 ~~(13)~~ A certified copy of court records showing adoption, name, or sex change.

7 ~~(b) If an elector is unable to produce any of the items of identification listed in~~
8 ~~subsection (a) of this Code section, he or she shall sign a statement under oath in a form~~
9 ~~approved by the Secretary of State, separate and distinct from the elector's voter certificate,~~
10 ~~swearing or affirming that he or she is the person identified on the elector's voter~~
11 ~~certificate. Such person shall be allowed to vote without undue delay. Falsely swearing or~~
12 ~~affirming such statement under oath shall be punishable as a felony, and the penalty shall~~
13 ~~be distinctly set forth on the face of the statement."~~
