A RESOLUTION

- Creating the Investment Capital Study Committee; and for other purposes. 1
- 2 WHEREAS, small businesses with innovative ideas have few options for securing
- 3 investment capital in Georgia, and many leave Georgia in search of funding to continue their
- 4 innovative investigations on the road to commercial success; and
- 5 WHEREAS, while federal small business innovative research grants exist, Georgia does not
- 6 take full advantage of these programs as other states do; and
- 7 WHEREAS, even beyond federal programs, more action must be taken to ensure that the
- 8 next wave of economic growth does not pass by Georgia in search of more friendly
- 9 environments.

- 10 NOW, THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY OF
- 11 GEORGIA that there is created the Investment Capital Study Committee to be composed of
- 12 two members from the House Ways and Means Committee appointed by the Speaker of the
- 13 House of Representatives; two members from the Senate Finance and Public Utilities
- 14 Committee appointed by the President of the Senate; four members representing senior
- managers from innovative entrepreneurial companies, two to be appointed by the Speaker 15
- 16 of the House of Representatives and two to be appointed by the President of the Senate; two
- members from private equity or venture capital investment firms, one to be appointed by the 17
- Speaker of the House of Representatives and one to be appointed by the President of the 18
- 19 Senate; and two members with backgrounds in tax policy, one to be appointed by the Speaker
- of the House of Representatives and one to be appointed by the President of the Senate. The
- chairperson of the committee shall be one of the private sector appointments selected by a 21
- 22 majority of the members present at the first organizational meeting.
- 23 BE IT FURTHER RESOLVED that the committee shall undertake a study of the conditions,
- 24 needs, issues, and problems described in this resolution and issues related thereto and may

1 recommend any actions or legislation which the committee deems necessary or appropriate. 2 The committee may conduct such meetings at such times and places as it may deem 3 necessary or convenient to enable it to exercise fully and effectively its powers, perform its 4 duties, and accomplish the objectives and purposes of this resolution. The legislative members of the committee shall receive the allowances provided for in Code Section 28-1-8 5 of the Official Code of Georgia Annotated. The citizen members of the committee shall 6 7 receive a daily expense allowance in the amount specified in subsection (b) of Code Section 45-7-21 of the Official Code of Georgia Annotated as well as the mileage or transportation 8 9 allowance authorized for state employees. The funds necessary to carry out the provisions of this resolution shall come from funds appropriated to the Senate and the House of 10 Representatives. The expenses and allowances authorized by this resolution shall not be 11 12 received by any member of the committee for more than five days unless additional days are authorized. In the event the committee makes a report of its findings and recommendations, 13 14 with suggestions for proposed legislation, if any, such report shall be made on or before 15 December 31, 2002. The committee shall stand abolished on December 31, 2002.
