## A BILL TO BE ENTITLED AN ACT

- 1 To amend Article 1 of Chapter 4 of Title 46 of the Official Code of Georgia Annotated,
- 2 relating to general provisions applicable to the distribution, storage, and sale of gas, so as to
- 3 provide that whenever a gas utility company regulated by the Public Service Commission,
- 4 including a marketer, discovers or has called to its attention a billing error or other mistake
- 5 acknowledged or admitted to by the gas utility company and resulting in an overpayment by
- 6 a retail customer of the gas utility company, such gas utility company shall be required
- 7 automatically and immediately to provide a credit or refund of the amount of the
- 8 overpayment to the customer; to prohibit a gas utility company regulated by the Public
- 9 Service Commission from requiring a retail customer to whom it owes a credit or refund to
- submit in writing a request for such credit or refund before the gas utility company complies
- 11 with the provisions of this Act; to provide an effective date; to repeal conflicting laws; and
- 12 for other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

- 15 Article 1 of Chapter 4 of Title 46 of the Official Code of Georgia Annotated, relating to
- 16 general provisions applicable to the distribution, storage, and sale of gas, is amended by
- 17 adding at the end thereof a new Code Section 46-4-2 to read as follows:

- 19 (a) Whenever a gas utility company regulated by the Public Service Commission,
- including a marketer as defined in paragraph (13) of Code Section 46-4-152, discovers or
- 21 has called to its attention a billing error or other mistake acknowledged or admitted to by
- the gas utility company and resulting in an overpayment by a retail customer of said
- company, such gas utility company shall be required automatically and immediately to
- 24 provide:
- 25 (1) A credit of the amount of the overpayment to the account of the customer; or
- 26 (2) A refund of the amount of the overpayment to the customer.

1 (b) A gas utility company regulated by the Public Service Commission shall be prohibited

- 2 from requiring a retail customer to whom it owes a credit or refund to submit in writing a
- 3 request for such credit or refund before the gas utility company complies with the
- 4 provisions of subsection (a) of this Code section."

## 5 SECTION 2.

- 6 This Act shall become effective upon its approval by the Governor or upon its becoming law
- 7 without such approval.

## 8 SECTION 3.

9 All laws and parts of laws in conflict with this Act are repealed.
