A BILL TO BE ENTITLED

AN ACT

1 To amend an Act creating a new charter for the City of Norcross, Georgia, approved  
2 March 28, 1990 (Ga. L. 1990, p. 4934), as amended, particularly by an Act approved April 1,  
3 1996 (Ga. L. 1996, p. 3844), so as to change the corporate limits of the City of Norcross; to  
4 repeal conflicting laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 **SECTION 1.**

7 An Act creating a new charter for the City of Norcross, Georgia, approved March 28, 1990  
8 (Ga. L. 1990, p. 4934), as amended, particularly by an Act approved April 1, 1996 (Ga. L.  
9 1996, p. 3844), is amended by adding at the end of Section 1.12 a new subsection (e) to read  
10 as follows:

11 "(e) In addition to all other territory included within the corporate limits of said city, the  
12 corporate limits shall specifically include the following described property, all of which is  
13 located in Gwinnett County, Georgia:

14 All that tract or parcel of land lying and being in Land Lots 286 and 271 of the 6th  
15 District of Gwinnett County, Georgia, and being more particularly described as follows:

16 Beginning at the northwest corner of the intersection of Peachtree Industrial Boulevard  
17 and Medlock Bridge Road, said point being located in the City of Norcross, Georgia,  
18 and continuing along the westerly right-of-way of Medlock Bridge Road to the  
19 southwest corner of the intersection of Medlock Bridge Road and Spalding Drive, then  
20 continuing along the westerly right-of-way of Spalding Drive to the land lot line  
21 dividing Land Lots 285 and 286 of the 6th District, Gwinnett County, Georgia, and  
22 continuing southerly along the land lot line through the point at which the land lot line  
23 divides Land Lots 271 and 272 of the 6th District of Gwinnett County, Georgia, and  
24 continuing along the land lot line dividing Land Lots 271 and 272 to the right-of-way  
25 of Peachtree Industrial Boulevard then continuing northeasterly along the right-of-way  
26 of Peachtree Industrial Boulevard to the point of beginning at the intersection of

1 Peachtree Industrial Boulevard and Medlock Bridge Road, less and excepting and  
2 excluding specifically Parcel 52 of Land Lot 285 of the 6th District and Parcel 95 of  
3 Land Lot 286 of the 6th District."

4 **SECTION 2.**

5 All laws and parts of laws in conflict with this Act are repealed.
