

House Bill 832

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act establishing the State Court of Elbert County (formerly known as the City
2 Court of Elberton), approved December 19, 1896 (Ga. L. 1896, p. 287), as amended,
3 particularly by an Act approved February 6, 1952 (Ga. L. 1952, p. 2211), an Act approved
4 February 8, 1955 (Ga. L. 1955, p. 2117), an Act approved March 27, 1972 (Ga. L. 1972, p.
5 2396), an Act approved March 26, 1980 (Ga. L. 1980, p. 4199), an Act approved March 27,
6 1985 (Ga. L. 1985, p. 4188), and an Act approved March 25, 1996 (Ga. L. 1996, p. 3587),
7 so as to change the provisions relating to the salaries of the judge and solicitor; to provide
8 for related matters; to provide an effective date; to repeal conflicting laws; and for other
9 purposes.

10 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

11 **SECTION 1.**

12 An Act establishing the State Court of Elbert County (formerly known as the City Court of
13 Elberton), approved December 19, 1896 (Ga. L. 1896, p. 287), as amended, particularly by
14 an Act approved February 6, 1952 (Ga. L. 1952, p. 2211), an Act approved February 8, 1955
15 (Ga. L. 1955, p. 2117), an Act approved March 27, 1972 (Ga. L. 1972, p. 2396), an Act
16 approved March 26, 1980 (Ga. L. 1980, p. 4199), an Act approved March 27, 1985 (Ga. L.
17 1985, p. 4188), and an Act approved March 25, 1996 (Ga. L. 1996, p. 3587), is amended by
18 striking Section 1 of that amendatory Act approved February 6, 1952 (Ga. L. 1952, p. 2211),
19 as amended by an Act approved March 25, 1996 (Ga. L. 1996, p. 3587), and inserting in its
20 place the following:

21 "SECTION 1.

22 Be it enacted by the General Assembly of Georgia, and it is hereby enacted by authority
23 of the same, that the Act of the General Assembly of Georgia approved December 19, 1896
24 (Ga. L. 1896, p. 287), and all Acts amendatory thereof, shall be amended by increasing the
25 salary of the judge of said court as follows:

1	Effective July 1, 2001	\$6,000.00 per year
2	Effective July 1, 2002	\$3,000.00 per year
3	Effective July 1, 2003	\$3,000.00 per year
4	Effective July 1, 2004	\$3,000.00 per year

5 Said salary shall include compensation for all office expenses and shall be paid to him or
6 her each month out of the treasury of Elbert County."

7 **SECTION 2.**

8 Said Act is further amended by striking Section 3 of said amendatory Act and inserting in its
9 place the following:

10 "SECTION 3.

11 Be it enacted by the authority aforesaid, and it is hereby enacted by authority of the same,
12 that the Act of the General Assembly of Georgia establishing the City Court of Elberton,
13 in Elbert County, approved December 19, 1896 (Ga. L. 1896, p. 287) and all Acts
14 amendatory thereof, be further amended so as to increase the salary of the solicitor of the
15 said court as follows:

16	Effective July 1, 2001	\$6,000.00 per year
17	Effective July 1, 2002	\$3,000.00 per year
18	Effective July 1, 2003	\$3,000.00 per year
19	Effective July 1, 2004	\$3,000.00 per year

20 Said salary shall include compensation for all office expenses and shall be paid to him or
21 her each month out of the treasury of Elbert County."

22 **SECTION 3.**

23 This Act shall become effective on July 1, 2001.

24 **SECTION 4.**

25 All laws and parts of laws in conflict with this Act are repealed.
