A BILL TO BE ENTITLED
AN ACT

1 To amend an Act providing a new charter for the City of Fargo, approved April 1, 1992 (Ga.
2 L. 1992, p. 5183), so as to change the corporate limits of the city; to repeal conflicting laws;
3 and for other purposes.

4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

5 **SECTION 1.**

6 An Act providing a new charter for the City of Fargo, approved April 1, 1992 (Ga. L. 1992,
7 p. 5183), is amended by striking subsection (b) of Section 1.11 of said Act and inserting in
8 its place the following:

9 "(b) The corporate limits of the City of Fargo shall include: all that tract of land lying and
10 being within land lots 270, 271, 321, 322, 323, and 345 of the 13th land district of Clinch
11 County, Georgia. Begin at a point where the southern boundary of land lot 323 intersects
12 the centerline of the Suwannee River. Said point is the southeastern corner and the point
13 and place of beginning for the City Limits of Fargo, Georgia. Thence proceed westerly
14 along the southern boundary of said lot 323 to the southwest corner of said lot. Thence,
15 proceed in a southerly direction along the eastern boundary of land lot 345 for a distance
16 of 1,320 feet. Thence, proceed westerly and parallel with the northern boundary of said lot
17 345 to the point where said line intersects the western boundary of said lot 345. Thence,
18 proceed northerly along the western boundary of said lot 345 a distance of 1320 feet to the
19 northwest corner of said lot 345. Thence proceed westerly along the southern boundary
20 of land lot 321 to the point where said line intersects the centerline of Suwanoochee Creek.
21 Thence, proceed northerly along the run of said creek to a point where the western
22 boundary of land lot 271 intersects the centerline of said Suwanoochee Creek. Thence,
23 proceed North along western boundary of land lot 271 to the Northwest corner of land lot
24 271. Thence, proceed east along northern boundary of land lot 271 to the northeast corner
25 of land lot 271. Thence proceed east along northern line of land lot 270 to a point where
26 highway 441 intersects the northern boundary of land lot 270. Thence, proceed in a

1 southeasterly direction along highway 441 to a point where an east-west Mid-lot line,
2 dividing lot 170 into equal halves, intersects said highway. Thence, proceed easterly along
3 said mid-lot line to the eastern boundary of land lot 270. Thence, proceed southerly to a
4 point where the eastern boundary of land lot 270 intersects the Suwannee River. Thence
5 proceed along the run of said river to the point and place of beginning."

6 **SECTION 2.**

7 All laws and parts of laws in conflict with this Act are repealed.
