A BILL TO BE ENTITLED  
AN ACT

1 To amend Article 3 of Chapter 9 of Title 15 of the Official Code of Georgia Annotated,  
2 relating to costs and compensation for the probate courts, so as to revise comprehensively  
3 the costs and fees for the probate courts; to repeal conflicting laws; and for other purposes.

4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

5 SECTION 1.

6 Article 3 of Chapter 9 of Title 15 of the Official Code of Georgia Annotated, relating to costs  
7 and compensation for the probate courts, is amended by striking in its entirety Code Section  
8 15-9-60, relating to costs, and inserting in lieu thereof the following:
