

SENATE SUBSTITUTE TO HB538:

**AS PASSED SENATE**

**A BILL TO BE ENTITLED**

**AN ACT**

1 To provide for regulation of ticket brokers and professional boxing by the Georgia Athletic  
2 and Entertainment Commission; to amend Chapter 1 of Title 10 of the Official Code of  
3 Georgia Annotated, relating to selling and other trade practices, and Title 43 of the Official  
4 Code of Georgia Annotated, relating to professions and businesses, so as to repeal provisions  
5 prohibiting the sale or offer for sale of tickets to certain athletic contests and entertainment  
6 events for a price exceeding the face value of the ticket and providing a penalty for the  
7 violation of such prohibition; to delete provisions relating to the Georgia Boxing  
8 Commission from Chapter 8A of Title 43 of the Official Code of Georgia Annotated; to  
9 revise and move such provisions to Chapter 4B of such title; to change the name of the  
10 Georgia Boxing Commission to the Georgia Athletic and Entertainment Commission; to  
11 make editorial changes; to provide definitions; to provide for exemptions from the chapter;  
12 to provide for the commission membership and its appointment, terms, officers, vacancies,  
13 and reimbursement; to provide for the membership of a medical advisory panel and its  
14 qualifications, functions, meetings, and reimbursement; to provide for the duties, authority,  
15 and jurisdiction of the commission; to provide for inspectors and authorized representatives;  
16 to provide for investigations, activities which promote amateur boxing, and contracts; to  
17 provide for identification cards and a boxing registry; to provide for the commission's  
18 secretary, meetings, quorum, and rules and regulations; to prohibit certain relationships with  
19 or compensation from promoters or persons with a financial interest in activities regulated  
20 by the commission; to prohibit promoting or holding a professional match, contest, or  
21 exhibition of boxing by unlicensed persons or by persons without a match permit; to provide  
22 for licensing of promoters, referees, managers, judges, timekeepers, matchmakers, boxers,  
23 trainers, and certain other persons who assist boxers; to provide for fees, performance bonds,  
24 criteria for determining whether to issue a license, and authority to refuse to grant a license;  
25 to provide for disciplinary action against licensees and suspension or revocation of licenses  
26 or permits; to provide for safety requirements; to prohibit participation in professional  
27 matches, contests, or exhibitions of boxing by persons under 18; to prohibit persons other  
28 than ticket brokers from reselling or offering for resale any ticket for an athletic contest or  
29 entertainment event for a price exceeding the face value of the ticket; to provide for

1 exceptions; to provide for service charges in certain circumstances; to preserve certain  
 2 contractual rights; to provide for requirements for ticket brokers; to prohibit convicted felons  
 3 from engaging in the business of a ticket broker in certain circumstances; to provide for  
 4 certain disclosures by ticket brokers; to prohibit certain practices by ticket brokers; to provide  
 5 for refunds; to restrict the percentage of tickets to a contest or event which may be resold by  
 6 any ticket broker; to provide that a person who is the original purchaser for personal use of  
 7 one or more tickets may sell or offer for resale such tickets at any price under certain  
 8 circumstances; to exempt charitable organizations and their employees and volunteers from  
 9 provisions regulating ticket sales and resales in certain circumstances; to authorize more  
 10 restrictive regulation by ordinance of the applicable local government in certain  
 11 circumstances; to provide a criminal penalty; to provide for rules and regulations; to provide  
 12 for enforcement of provisions relating to ticket brokers by the commission; to provide for  
 13 relief by order of the superior court; to provide for notice and opportunity to execute an  
 14 assurance of voluntary compliance; to provide for procedures; to repeal conflicting laws; and  
 15 for other purposes.

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

17 **SECTION 1.**

18 Chapter 1 of Title 10 of the Official Code of Georgia Annotated, relating to selling and other  
 19 trade practices, is amended by striking in its entirety Article 12, relating to ticket scalping,  
 20 and inserting in lieu thereof the following:

21 "ARTICLE 12

22 10-1-310.

23 ~~(a) It shall be unlawful for any person to sell or offer for sale any ticket of admission or~~  
 24 ~~other evidence of the right of entry to any football game, basketball game, baseball game,~~  
 25 ~~soccer game, hockey game, or tennis or golf tournament for a price in excess of the price~~  
 26 ~~printed on the ticket; provided, however, that a service charge not to exceed \$3.00 may be~~  
 27 ~~charged when tickets or other evidences of the right of entry are sold by an authorized~~  
 28 ~~ticket agent through places of established business licensed to do business by the~~  
 29 ~~municipality or county, where applicable, in which such places of business are located.~~

30 ~~(b) It shall be unlawful for any person to sell or offer for sale any ticket of admission or~~  
 31 ~~other evidence of the right of entry to any entertainment event not covered by subsection~~  
 32 ~~(a) of this Code section, including but not limited to, athletic contests, concerts, theater~~  
 33 ~~performances, or other entertainments, amusements, or exhibitions to which the general~~

~~public is admitted, for a price in excess of the price printed on the ticket; provided, however, that the owner, operator, lessee, or tenant of the property on which such entertainment event is to be held or is being held may authorize, in writing, any person to charge a service charge for the sale or selling of such ticket, privilege, or license of admission in addition to the price printed on the ticket. Such writing shall specify the amount of the service charge to be charged for the sale or selling of each ticket, privilege, or license of admission.~~

~~(c) Any advertisement, announcement, or poster for any event covered by this Code section which includes the price of admission shall specify the amount of the service charge to be charged for the sale or selling of each ticket, privilege, or license of admission and such advertisement shall be clearly and conspicuously stated. Reserved.~~

~~Any person violating Code Section 10-1-310 shall be guilty of a misdemeanor. Reserved.~~

## SECTION 2.

Title 43 of the Official Code of Georgia Annotated, relating to professions and businesses is amended by striking in its entirety Chapter 8A, relating to professional boxing, and inserting a new Chapter 4B between Chapter 4A and Chapter 5 to read as follows:

### "CHAPTER 4B

#### ARTICLE 1

43-4B-1.

As used in this chapter, the term:

(1) 'Amateur' means a person who engages in a match, contest, or exhibition of boxing which is governed or authorized by:

(A) U.S.A. Boxing;

(B) The Georgia High School Athletic Association;

(C) The National Collegiate Athletic Association;

(D) Amateur Athletic Union;

(E) Golden Gloves; or

(F) The local affiliate of any organization listed in this paragraph.

(2) 'Boxing match' means a contest between two individuals in which contestants score points in rounds of two or three minutes by striking with padded fists the head and upper torso of the opponent or by knocking the opponent down and rendering the opponent

1 unconscious or incapable of continuing the contest by such blows, which contest is held  
2 in a square ring supervised by a referee and scored by three judges.

3 (3) 'Boxing registry' means a registry created or designated pursuant to subsection (j) of  
4 Code Section 43-4B-4.

5 (3.1) 'Charitable organization' means an entity described by:

6 (A) Section 501(c)(3), Internal Revenue Code of 1986 (26 U.S.C. Section 501(c)(3));

7 or

8 (B) Section 170(c), Internal Revenue Code of 1986 (26 U.S.C. Section 170(c)).

9 (4) 'Commission' means the Georgia Athletic and Entertainment Commission.

10 (5) 'Exhibition' means a contest where the participants engage in the use of boxing skills  
11 and techniques and where the objective is to display such skills and techniques without  
12 striving to win.

13 (6) 'Face value' means the dollar value of a ticket or order, which value shall reflect the  
14 dollar amount that the customer is required to pay or, for complimentary tickets, would  
15 have been required to pay to purchase a ticket with equivalent seating priority in order  
16 to view the match, contest, exhibition, or entertainment event. A complimentary ticket  
17 shall not have a face value of \$0.00. A complimentary ticket shall not have a face value  
18 of less than that of the least expensive ticket available for sale to the general public. Face  
19 value shall include any charges or fees, such as dinner, gratuity, parking, surcharges, or  
20 any other charges or fees which are charged to and must be paid by the customer in order  
21 to view the match, contest, exhibition, or entertainment event. It shall exclude any  
22 portion paid by the customer for federal, state, or local taxes.

23 (7) 'Gross proceeds' means the total revenue received solely from the sale of tickets used  
24 or intended to be used by the audience physically attending any event required to be  
25 licensed under this chapter.

26 (8) 'Gross receipts' means:

27 (A) The gross price charged for the sale or lease of broadcasting, television, closed  
28 circuit, or motion picture rights without any deductions for commissions, brokerage  
29 fees, distribution fees, production fees, advertising, or other expenses or charges; and

30 (B) The face value of all tickets sold and complimentary tickets redeemed.

31 (9) 'Local tax' means any occupation tax or other tax owed to a county or municipality  
32 in order to hold a professional match, contest, or exhibition of boxing or to carry on a  
33 business as a ticket broker within such county or municipality.

34 (10) 'Manager' means a person who under contract, agreement, or other arrangement with  
35 a boxer, undertakes to control or administer, directly or indirectly, a matter related to  
36 boxing on behalf of a boxer. Such term includes, but is not limited to, a person who  
37 functions as a booking agent, adviser, or consultant.

1 (11) 'Matchmaker' means a person who is employed by or associated with a promoter in  
2 the capacity of booking and arranging professional matches, contests, or exhibitions of  
3 boxing between opponents or who proposes professional matches, contests, or exhibitions  
4 of boxing and selects and arranges for the participants in such events and for whose  
5 activities in this regard the promoter is legally responsible.

6 (12) 'Person' means any individual, partnership, firm, association, corporation, or  
7 combination of individuals of whatever form or character.

8 (13) 'Physician' means a doctor of medicine or other medical professional legally  
9 authorized by any state to practice medicine.

10 (14) 'Professional' means a person who is participating or has participated in a match,  
11 contest, or exhibition of boxing which is not governed or authorized by one or more of  
12 the organizations listed in paragraph (1) of this Code section and:

13 (A) Has received or competed for or is receiving or competing for any cash as a salary,  
14 purse, or prize for participating in any match, contest, or exhibition of boxing;

15 (B) Is participating or has participated in any match, contest, or exhibition of boxing  
16 to which admission is granted upon payment of any ticket for admission or other  
17 evidence of the right of entry;

18 (C) Is participating or has participated in any match, contest, or exhibition of boxing  
19 which is or was filmed, broadcast, or transmitted for viewing; or

20 (D) Is participating or has participated in any match, contest, or exhibition of boxing  
21 which provides a commercial advantage by attracting persons to a particular place or  
22 promoting a commercial product or enterprise.

23 (15) 'Professional match, contest, or exhibition of boxing' means a boxing match, contest,  
24 or exhibition which is not governed or authorized by one or more of the organizations  
25 listed in paragraph (1) of this Code section and:

26 (A) Rewards a boxer participating with cash as a salary, purse, or prize for such  
27 participation;

28 (B) Requires for admission payment of a ticket for admission or other evidence of the  
29 right of entry;

30 (C) Is filmed, broadcast, or transmitted for viewing; or

31 (D) Provides a commercial advantage by attracting persons to a particular place or  
32 promoting a commercial product or enterprise.

33 (16) 'Promoter' means the person primarily responsible for organizing, promoting, and  
34 producing a professional match, contest, or exhibition of boxing and who is legally  
35 responsible for the lawful conduct of such professional match, contest, or exhibition of  
36 boxing.

1 (17) 'Purse' or 'ring earnings' means the financial guarantee or any other remuneration,  
2 or part thereof, for which professional boxers are participating in a match, contest, or  
3 exhibition and includes the boxer's share of any payment received for radio broadcasting,  
4 television, or motion picture rights.

5 (18) 'State' means any of the 50 states, Puerto Rico, the District of Columbia, and any  
6 territory or possession of the United States.

7 (19) 'Ticket broker' means any person who is involved in the business of reselling tickets  
8 of admission to athletic contests, concerts, theater performances, amusements,  
9 exhibitions, or other entertainment events to which the general public is admitted and  
10 who charges a premium in excess of the price of the ticket. The term ticket broker shall  
11 not include the owner, operator, lessee, or tenant of the property in which an athletic  
12 contest or entertainment event is being held or the sponsor of such a contest or event or  
13 the authorized ticket agent of such persons.

14 (20)(A) 'Unarmed combat' means any form of competition between human beings or  
15 one or more human beings and one or more animals in which:

16 (i) One or more blows are struck which may reasonably be expected to inflict injury  
17 on a human being; and

18 (ii) There is some compensation or commercial benefit arising from such  
19 competition, whether in the form of cash or noncash payment to the competitors or  
20 the person arranging the competition; the sale of the right to film, broadcast, transmit,  
21 or view the competition; or the use of the competition to attract persons to a particular  
22 location for some commercial advantage or to promote a commercial product or  
23 commercial enterprise.

24 (B) Unarmed combat shall include but shall not be limited to: tough man fights, bad  
25 man fights, nude boxing, and nude wrestling.

26 (C) Unarmed combat shall not include:

27 (i) Professional boxing;

28 (ii) Professional wrestling;

29 (iii) Amateur boxing;

30 (iv) Amateur wrestling;

31 (v) Any competition displaying the skills of a single form of an Oriental system of  
32 unarmed self-defense, including, but not limited to, kick boxing, karate, or  
33 full-contact karate, which is held pursuant to the rules of that form and governed or  
34 authorized by a nationally recognized organization; or

35 (vi) Mixed martial arts fighting when the competition is sanctioned, approved, or  
36 endorsed by the International Sport Combat Federation (ISCF).

1 (22) 'Wrestling' means a staged performance of fighting and gymnastic skills and  
2 techniques by two or more human beings who are not required to use their best efforts in  
3 order to win and for which the winner may have been selected before the performance  
4 commences.

5 43-4B-2.

6 The provisions of this chapter shall not be construed to apply to any match, contest, or  
7 exhibition of boxing:

8 (1) In which the contestants are all amateurs; and

9 (2) Which is governed or authorized by:

10 (A) U.S.A. Boxing;

11 (B) The Georgia High School Athletic Association;

12 (C) The National Collegiate Athletic Association;

13 (D) Amateur Athletic Union;

14 (E) Golden Gloves; or

15 (F) The local affiliate of any organization listed in this paragraph.

16 43-4B-3.

17 (a) The State Boxing Commission in existence immediately prior to the effective date of  
18 this chapter, is continued in existence subject to the provisions of this chapter. On and after  
19 the effective date of this chapter, the name of such commission shall be the Georgia  
20 Athletic and Entertainment Commission. The membership of the commission shall  
21 continue unchanged except as otherwise expressly provided by this chapter.

22 (b) The commission shall be composed of five members appointed by the Governor. All  
23 appointments shall be for terms of four years. Vacancies shall be filled for the unexpired  
24 terms under the same procedures and requirements as appointments for full terms.

25 (c) The commission shall elect a chairperson from among its membership for a term of one  
26 year. The commission may elect a vice chairperson from its membership for a term of one  
27 year. Any member serving as chairperson shall be eligible for successive election to such  
28 office by the commission.

29 (d) The commission's medical advisory panel, appointed by the Governor, shall consist  
30 of four persons licensed to practice medicine in Georgia pursuant to the provisions of  
31 Chapter 34 of this title. They shall represent the specialties of neurology, ophthalmology,  
32 sports medicine, and general medicine. The medical advisory panel shall advise and assist  
33 the commission and its staff regarding issues and questions concerning the medical safety  
34 of applicants or licensees, including, but not limited to, matters relating to medical  
35 suspensions. The medical advisory panel may meet separately from the commission to

1 discuss and formulate recommendations for the commission in connection with medical  
2 safety. Members of the medical advisory panel shall not be counted in determining a  
3 quorum of the commission and shall not vote as commission members.

4 (e) Each member of the commission and the medical advisory panel shall be reimbursed  
5 for expenses and travel as provided for members of various professional licensing boards  
6 in subsection (f) of Code Section 43-1-2.

7 43-4B-4.

8 (a) The commission is the sole regulator of professional boxing in Georgia and shall have  
9 authority to protect the physical safety and welfare of professional boxers and serve the  
10 public interest by closely supervising all professional boxing in Georgia.

11 (b) The commission shall have the sole jurisdiction to license the promotion or holding of  
12 each professional match, contest, or exhibition of boxing promoted or held within this  
13 state.

14 (c) The commission shall have the sole authority to license participants in any professional  
15 match, contest, or exhibition of boxing held in this state.

16 (d) The commission has the authority to direct, manage, control, and supervise all  
17 professional matches, contests, or exhibitions of boxing. It may adopt bylaws for its own  
18 management and promulgate and enforce rules and regulations consistent with this  
19 chapter.

20 (e) The commission may appoint one or more inspectors as duly authorized representatives  
21 of the commission to ensure that the rules are strictly observed. Such inspectors shall be  
22 present at all professional matches, contests, or exhibitions of boxing.

23 (f) The commission may designate physicians as duly authorized representatives of the  
24 commission to conduct physical examinations of boxers licensed under this chapter and  
25 shall designate a roster of physicians authorized to conduct prefight physicals and serve as  
26 ringside physicians in all professional boxing matches held in this state.

27 (g) The commission or any agent duly designated by the commission may make  
28 investigations. The commission may hold hearings; issue subpoenas to compel the  
29 attendance of witnesses and the production of books, papers, and records; and administer  
30 oaths to and examine any witnesses for the purpose of determining any question coming  
31 before it under this chapter or under the rules and regulations adopted pursuant to this  
32 chapter. During an investigation of any allegation which, if proven, would result in  
33 criminal or civil sanctions as provided in this chapter, the commission may withhold all or  
34 a portion of the gross receipts to which the person under investigation is entitled until such  
35 time as the matter has been resolved.

1 (h) The commission shall be authorized to engage in activities which promote amateur  
2 boxing in this state and to contract with any nonprofit organization which is exempted from  
3 the taxation of income pursuant to Code Section 48-7-25 for the provision of services  
4 related to the promotion of amateur boxing in this state. To support amateur boxing in this  
5 state, the commission may promote voluntary contributions through the application process  
6 or through any fund raising or other promotional technique deemed appropriate by the  
7 commission.

8 (i) Pursuant to 15 U.S.C.A. Section 6301, et seq., the commission is authorized to issue to  
9 each boxer who is a resident of this state an identification card bearing the boxer's  
10 photograph and in such form and containing such information as the commission deems  
11 necessary and appropriate. The commission is expressly authorized to ensure that the form  
12 and manner of issuance of such identification cards comply with any applicable federal law  
13 or regulation. The commission is authorized to charge an amount not to exceed \$100.00  
14 per card for the issuance or replacement of each identification card.

15 (j) The commission is authorized to create a boxing registry or to designate a nationally  
16 recognized boxing registry and to register each boxer who is a resident of this state or who  
17 is a resident of another state which has no boxing registry.

18 (k) The commission is authorized to inquire into the financial backing of any professional  
19 match, contest, or exhibition of boxing and obtain answers to written or oral questions  
20 propounded to all persons associated with such professional event.

21 43-4B-5.

22 The Secretary of State shall designate the secretary of the commission, who shall issue  
23 licenses and identification cards and perform such other duties as the commission may  
24 direct to carry out the provisions of this chapter.

25 43-4B-6.

26 (a) The commission shall meet upon the call of the chairperson or upon the call of any two  
27 members. The business of the commission shall be conducted by a majority vote of the  
28 members present. A majority of the commission members shall constitute a quorum.

29 (b) The chairperson, if necessary, may within ten days of receiving an application and  
30 license fee call a meeting of the commission for the purpose of approving or rejecting an  
31 application for a license or match permit which has been submitted to the commission. The  
32 meeting shall be held within 20 days of the chairperson's call at a place designated by the  
33 chairperson.

1 43-4B-7.

2 The commission shall adopt rules and regulations governing professional boxing to  
3 establish the following:

4 (1) Procedures to evaluate the professional records and physicians' certifications of each  
5 boxer participating in a professional match, contest, or exhibition of boxing and to deny  
6 authorization for a professional boxer to fight where appropriate;

7 (2) Procedures to ensure that, except as otherwise provided in subsection (c) of Code  
8 Section 43-4B-14, no professional boxer is permitted to box while under suspension from  
9 any state boxing commission because of:

10 (A) A recent knockout, technical knockout, or series of consecutive losses;

11 (B) An injury, requirement for a medical procedure, or physician's denial of  
12 certification;

13 (C) Failure of a drug test; or

14 (D) The use of false aliases or falsifying official identification cards or documents; and

15 (3) Procedures to report to the boxing registry the results of all professional matches,  
16 contests, or exhibitions of boxing held in this state or being supervised by the commission  
17 and any related suspensions.

18 43-4B-8

19 No member or employee of the commission and no person who administers or enforces the  
20 provisions of this chapter or rules promulgated in accordance with this chapter may belong  
21 to, contract with, or receive any compensation from any person or organization who  
22 authorizes, arranges, or promotes professional matches, contests, or exhibitions of boxing  
23 or who otherwise has a financial interest in any activity or licensee regulated by this  
24 commission. The term 'compensation' does not include funds held in escrow for payment  
25 to another person in connection with a professional match, contest, or exhibition of boxing.

26 ARTICLE 2

27 43-4B-10.

28 (a) No person shall promote or hold a professional match, contest, or exhibition of boxing  
29 within this state without first applying for and obtaining a promoter's license from the  
30 commission. Licenses shall be issued annually and shall expire on December 31 of each  
31 calendar year.

32 (b) Promoters shall apply to the commission for a license required by subsection (a) of this  
33 Code section on a form provided by the commission. The application shall be  
34 accompanied by a nonrefundable fee not to exceed \$250.00 in the form of a cashier's check

1 made out to the commission. The application shall also be accompanied by a performance  
2 bond in an amount and under such conditions as the commission may require.

3 (c) No person shall promote or hold a professional match, contest, or exhibition of boxing  
4 within this state without first applying for and obtaining a match permit from the  
5 commission for such professional match, contest, or exhibition of boxing in addition to the  
6 license required by subsection (a) of this Code section. Each application for a match  
7 permit shall be on a form provided by the commission and shall be accompanied by a  
8 nonrefundable application fee not to exceed \$250.00 in the form of a cashier's check made  
9 out to the commission. The commission may charge an additional match fee in accordance  
10 with rules and regulations promulgated by the commission to implement the provisions of  
11 this article.

12 (d) The commission may, prior to issuing any match permit, require a performance bond  
13 in addition to that required in subsection (b) of this Code section.

14 (e) The commission may refund any portion of the match permit fee in excess of \$250.00  
15 to any person who paid such excess fee in the event the professional match, contest, or  
16 exhibition of boxing for which such fees were paid is not held.

17 43-4B-11.

18 (a) Prior to participating in a professional match, contest, or exhibition of boxing  
19 supervised by the commission, referees, judges, timekeepers, matchmakers, boxers,  
20 managers, trainers, and each person who assists a boxer immediately before and after a  
21 match, contest, or exhibition of boxing and between rounds during a match, contest, or  
22 exhibition of boxing shall apply for and be issued licenses. Licenses shall be issued  
23 annually and shall expire on December 31 of each calendar year. Each applicant shall  
24 make application on a form provided by the commission and pay an annual license fee not  
25 to exceed \$250.00.

26 (b) The commission shall issue a license under this Code section only if:

27 (1) The commission has determined to the best of its ability that the applicant has the  
28 training or skills necessary to perform in a manner appropriate to the license;

29 (2) The applicant has complied with all applicable requirements of this chapter and any  
30 rules and regulations promulgated pursuant to this chapter; and

31 (3) The commission or its designated representative has determined from information  
32 provided by the applicant and from any medical evaluation required by the commission  
33 that the health, welfare, and physical safety of the applicant will not be unduly  
34 jeopardized by the issuance of the license.

1 43-4B-12.

2 In addition to the license required in Code Section 43-4B-12, each professional boxer who  
3 is a resident of this state or another state which has no state boxing commission is required  
4 to register with a boxing registry created or designated by the commission and renew his  
5 or her registration as prescribed by rules of the commission. At the time of registration and  
6 renewal, the boxer shall provide the boxing registry with a recent photograph of the boxer  
7 and the social security number of the boxer or, in the case of a foreign boxer, any similar  
8 citizen identification number or boxer number from the country of residence of the boxer,  
9 along with any other information the commission requires. The boxing registry shall issue  
10 a personal identification number to each boxer and such number shall appear on the  
11 identification card issued to the boxer as a result of registration. Each boxer is required to  
12 present to the boxing commission an identification card issued by the state in which he or  
13 she resides not later than the time of the weigh-in for a professional match, contest, or  
14 exhibition. The commission may charge a registration fee in an amount calculated to cover  
15 the administrative expense of such registration.

16 43-4B-13.

17 (a) The commission shall have the authority to refuse to grant a license to an applicant  
18 upon a finding by a majority of the entire commission that the applicant has failed to  
19 demonstrate the qualifications or standards for a license contained in this Code section or  
20 under the laws, rules, and regulations under which licensure is sought. It shall be  
21 incumbent upon the applicant to demonstrate to the satisfaction of the commission that he  
22 or she meets all the requirements for the issuance of a license, and, if the commission is not  
23 satisfied as to the applicant's qualifications, it may deny a license without a prior hearing;  
24 provided, however, that the applicant shall be allowed to appear before the commission if  
25 he or she so desires.

26 (b) The commission may, by majority vote, after prior notice to the holder of any state  
27 license and after affording such a holder an opportunity to be heard, fine the license holder,  
28 revoke or suspend a state license, or take other disciplinary action against the licensee, and:

29 (1) The commission shall, upon the recommendation of any officially designated  
30 representative for reasons involving the medical or physical safety of any professional  
31 boxer licensed by the commission, summarily suspend any license previously issued by  
32 the commission or take other disciplinary action against any licensee; provided, however,  
33 that such licensee shall, after such summary suspension, be afforded an opportunity to be  
34 heard, in accordance with the rules of the commission and Chapter 13 of Title 50, the  
35 'Georgia Administrative Procedure Act.' Any such summary suspension imposed against  
36 such a licensee may include, but shall not be limited to:

1 (A) Prohibiting any boxer from competing, appearing in, or participating in any  
 2 professional match, contest, or exhibition within 60 days of having suffered a knockout;  
 3 or

4 (B) Prohibiting any boxer from competing, appearing in, or participating in any  
 5 professional match, contest, or exhibition within 30 days of having suffered a technical  
 6 knockout where evidence of head trauma has been determined by the attending ringside  
 7 physician.

8 The length of any summary suspension invoked pursuant to subparagraph (A) or (B) of  
 9 this paragraph, upon recommendation of the ringside physician, may be extended to any  
 10 number of days. Terms and conditions of the suspension or revocation may require that  
 11 the boxer submit to further medical evaluation as determined by the ringside physician;  
 12 and

13 (2) The commission, its secretary, or its duly authorized representative may, at any time  
 14 prior to the completion of a permitted professional match, contest, or exhibition of  
 15 boxing, summarily suspend or revoke the match permit or the license of any specific  
 16 boxer should it be determined by such person that the continuation of said professional  
 17 match, contest, or exhibition of boxing may jeopardize the health, welfare, morals, or  
 18 safety of the citizens of this state or may jeopardize the health or personal safety of any  
 19 participant of such professional match, contest, or exhibition of boxing; provided,  
 20 however, that such licensee shall, after such summary suspension, be afforded an  
 21 opportunity to be heard, in accordance with the rules of the commission and Chapter 13  
 22 of Title 50, the 'Georgia Administrative Procedure Act.'

23 (c) The commission may revoke a suspension of a boxer if:

24 (1) The boxer was suspended pursuant to rules and regulations adopted pursuant to  
 25 subparagraph (A) or (B) of paragraph (2) of Code Section 43-4B-7 and has furnished  
 26 proof of a sufficiently improved medical or physical condition; or

27 (2) The boxer furnishes proof that a suspension pursuant to subparagraph (D) of  
 28 paragraph (2) of Code Section 43-4B-7 was not or is no longer merited by the facts.

29 43-4B-14.

30 No person may arrange, promote, organize, produce, or participate in a professional match,  
 31 contest, or exhibition of boxing without meeting the following requirements:

32 (1) Each boxer must be examined by a physician who must then certify that the boxer  
 33 is physically fit to compete safely. Copies of each such certificate shall be provided to  
 34 the commission prior to the professional match, contest, or exhibition of boxing. The  
 35 commission is authorized at any time to require a boxer to undergo a physical  
 36 examination, including neurological or neuropsychological tests and procedures;

1 (2) A physician approved by the commission must be continuously present at ringside  
2 during every professional match, contest, or exhibition of boxing. The physician shall  
3 observe the physical condition of the boxers and advise the referee with regards thereto;

4 (3) One or more inspectors appointed by the commission as duly authorized  
5 representatives of the commission shall be present at each professional match, contest,  
6 or exhibition of boxing to ensure that the rules are strictly observed. An inspector or  
7 other duly authorized representative of the commission must be present at the weigh-in  
8 and at the ring during the conduct of the professional match, contest, or exhibition of  
9 boxing. Inspectors and other duly authorized representatives of the commission shall  
10 have free access to the dressing rooms of the boxers;

11 (4) Each boxer shall be covered by health insurance which will cover injuries sustained  
12 during the professional match, contest, or exhibition of boxing; and

13 (5) An ambulance and medical personnel with appropriate resuscitation equipment must  
14 be continuously present at the site during any professional match, contest, or exhibition  
15 of boxing.

16 43-4B-15.

17 It shall be unlawful for any boxer to participate or attempt to participate in a professional  
18 match, contest, or exhibition of boxing while under the influence of alcohol or any drug.  
19 A boxer shall be deemed under the influence of alcohol or a drug for the purposes of this  
20 Code section if a physical examination made during a period of time beginning not more  
21 than six hours prior to the beginning of the professional match, contest, or exhibition of  
22 boxing and ending not more than one hour after the completion of the professional match,  
23 contest, or exhibition of boxing reveals that the boxer's mental or physical ability is  
24 impaired in any way as a direct result of the use of alcohol or a drug.

25 43-4B-16.

26 All buildings or structures used or intended to be used for holding or giving professional  
27 matches, contests, or exhibitions of boxing shall be safe and shall in all manner conform  
28 to the laws, ordinances, and regulations pertaining to buildings in the city or unincorporated  
29 area of the county where the building or structure is situated.

30 43-4B-17.

31 No person under the age of 18 years shall participate as a contestant in any professional  
32 match, contest, or exhibition of boxing.

1 43-4B-18.

2 The commission shall have jurisdiction over any professional match, contest, or exhibition  
3 of boxing which occurs or is held within this state, is filmed in this state, or is broadcast or  
4 transmitted from this state.

5 ARTICLE 3

6 43-4B-25.

7 (a) Except as otherwise provided in Code Section 43-4B-29, it shall be unlawful for any  
8 person other than a ticket broker to resell or offer for resale any ticket of admission or other  
9 evidence of the right of entry to any athletic contest, concert, theater performance,  
10 amusement, exhibition, or other entertainment event to which the general public is admitted  
11 for a price in excess of the face value of the ticket. Notwithstanding any other provision of  
12 this article to the contrary, a service charge not to exceed \$5.00 may be charged when  
13 tickets or other evidences of the right of entry are sold by an authorized ticket agent  
14 through places of established business licensed to do business by the municipality or  
15 county, where applicable, in which such places of business are located. Notwithstanding  
16 any other provision of this article to the contrary, the owner, operator, lessee, or tenant of  
17 the property on which such athletic contest or entertainment event is to be held or is being  
18 held or the sponsor of such contest or event may charge or may authorize, in writing, any  
19 person to charge a service charge for the sale of such ticket, privilege, or license of  
20 admission in addition to the face value of the ticket. Such writing granting authority to  
21 another shall specify the amount of the service charge to be charged for the sale of each  
22 ticket, privilege, or license of admission.

23 (b) Notwithstanding any other provision of this article to the contrary, in the case of any  
24 athletic contest or entertainment event that is described in Code Section 43-4B-30, a  
25 sponsor of such a contest or event may contractually restrict the resale of a ticket to such  
26 contest or event by giving notice of such restriction on the back of the ticket.  
27 Notwithstanding any other provision of this article to the contrary, in the case of any  
28 athletic contest or entertainment event, an owner, operator, lessee, or tenant of the property  
29 on which such contest or event is to be held or is being held may contractually restrict the  
30 resale of the right of occupancy of any specific suite, seat, or seating area by giving notice  
31 in writing of such restriction.

32 43-4B-26.

33 In order to engage in the practice or business of a ticket broker a person shall be required  
34 to:

- 1 (1) Maintain a permanent office or place of business in this state, excluding a post office  
 2 box, for the purpose of engaging in the business of a ticket broker;
- 3 (2) Apply to the commission for a ticket broker's license on a form designated by the  
 4 commission, pay an annual license fee of \$400.00, and renew the license annually;
- 5 (3) Pay any local tax required by a local government;
- 6 (4) Register for sales and use tax purposes pursuant to Article 1 of Chapter 8 of Title 48;  
 7 and
- 8 (5) Provide satisfactory evidence to the commission that the ticket broker has posted or  
 9 has made provision for the posting of a bond. The required bond shall be executed in  
 10 favor of the state, in the amount of \$100,000.00, with a surety company authorized to do  
 11 business in this state and conditioned to pay damages not to exceed the amount of such  
 12 bond to any person aggrieved by any act of the principal named in such bond, which act  
 13 is in violation of this Code section.

14 43-4B-27.

15 No person shall engage in the practice or business of a ticket broker, or be employed as  
 16 general manager for a person engaged in the practice or business of a ticket broker, who  
 17 has been convicted of a felony and who has not been pardoned or had his or her civil rights  
 18 restored.

19 43-4B-28.

20 (a) The ticket broker shall be required to:

- 21 (1) Post at its established place of business the terms of the purchaser's right to cancel  
 22 the purchase of a ticket from a ticket broker;
- 23 (2) Disclose to the purchaser the refund policy of the ticket broker should an athletic  
 24 contest or entertainment event be canceled;
- 25 (3) Disclose to the purchaser in writing the difference between the face value of the  
 26 ticket and the amount which the ticket broker is charging for such ticket; and
- 27 (4) Sell tickets only at its permanent office or place of business; provided, however, that  
 28 delivery of one or more tickets after the transaction is completed to a place other than the  
 29 ticket broker's office or place of business shall not violate this paragraph.

30 (b)(1) A ticket broker shall be prohibited from employing any agent or employee for the  
 31 purpose of making future purchases of tickets from the owner, operator, lessee, or tenant  
 32 of the property on which an athletic contest or entertainment event is to be held.

33 (2) Each ticket broker, including any affiliated group of ticket brokers, shall be  
 34 prohibited from acquiring and reselling in excess of 1 percent of the total tickets allocated  
 35 for any contest or event.

1 (3) Unless otherwise provided in a written agreement between a ticket broker and the  
2 purchaser, a ticket broker shall be required to refund any payment received for the  
3 purchase of a ticket under this article if the purchaser returns the ticket and requests a  
4 cancellation of the sale thereof within 36 hours from the time of purchase of the ticket  
5 and if such return is made more than 72 hours preceding the athletic contest or  
6 entertainment event.

7 (4) A ticket broker shall be required to refund any payment received for the purchase of  
8 a ticket under this article if the athletic contest or entertainment event is canceled and not  
9 rescheduled.

10 (5) If a ticket broker guarantees in writing delivery of a ticket or tickets to an athletic  
11 contest or entertainment event as provided under this article to a purchaser and fails to  
12 complete such delivery, the ticket broker shall be required to provide within 15 days a full  
13 refund of any amount paid by the purchaser and, in addition, shall pay the purchaser a  
14 refund fee of three times the amount paid by the purchaser for each such ticket.

15 (c) A ticket broker and its employees, agents, and assigns are criminally prohibited from  
16 reselling or offering for resale any ticket within 1,500 feet from the venue where an event  
17 or contest is to be held or is being held.

18 43-4B-29.

19 (a) No provision of this article or any other provision of law shall criminally prohibit any  
20 person who is the original purchaser for personal use of one or more tickets to an athletic  
21 contest or entertainment event covered under this article from reselling or offering for  
22 resale any of such tickets for any price, provided that such person does not sell or offer to  
23 sell such tickets within 1,500 feet of a ticket office for such a contest or event or a public  
24 entrance to such a contest or event. No provision of this article or any other provision of  
25 law shall criminally prohibit the purchaser for personal use of one or more tickets to an  
26 athletic contest or entertainment event from reselling or offering for resale any of such  
27 tickets in any zone or zones within the restricted areas, as provided in this subsection or  
28 subsection (b) of Code Section 43-4B-30, where such activity is authorized by the sponsor  
29 of the contest or event and the owner or operator of the venue where such contest or event  
30 is being held or to be held.

31 (b) Charitable organizations and their employees and volunteers shall not be subject to the  
32 provisions of this article when offering for sale any tickets of admission in a raffle, auction,  
33 or similar fund-raising activity for the benefit of the organization's charitable purposes.

1 43-4B-30.

2 (a) With regard to any single athletic contest or entertainment event which occurs no more  
3 often than once annually and with regard to any series of athletic contests which occur no  
4 more often than once annually and which occur within a time period not exceeding ten  
5 days, the municipal corporation in which such contest, event, or series of contests is to be  
6 held, or if the contest, event, or series of contests is to be held in an unincorporated area,  
7 the county of such unincorporated area, is authorized to enact by ordinance regulations  
8 governing ticket brokers for such contest, event, or series of contests which are more  
9 restrictive than the provisions of this article.

10 (b) The municipal corporation in which an athletic contest or entertainment event is to be  
11 held, or if the contest or entertainment event is to be held in an unincorporated area, the  
12 county of such unincorporated area, is authorized to enact an ordinance prohibiting the  
13 resale or offering for resale of one or more tickets by a ticket broker or by a person who is  
14 the original purchaser for personal use of one or more tickets within 2,700 feet of a venue  
15 which seats or admits 15,000 or more persons.

16 43-4B-31.

17 Any person who violates this article is guilty of a misdemeanor of a high and aggravated  
18 nature.

19 43-4B-32.

20 (a) In addition to the powers and duties set out in Code Section 43-4B-3, the commission  
21 is authorized to promulgate rules and regulations to accomplish the purposes of this article  
22 in accordance with Chapter 13 of Title 50, the 'Georgia Administrative Procedure Act.'  
23 The commission shall enforce the provisions of this article. The enforcement powers of  
24 the commission set out in this Code section shall be in addition to the criminal penalty  
25 provided by Code Section 43-4B-31.

26 (b) Whenever it may appear to the commission that any person is violating or has violated  
27 any provision of this article and that proceedings would be in the public interest:

28 (1) Subject to notice and opportunity for hearing in accordance with Chapter 13 of Title  
29 50, the 'Georgia Administrative Procedure Act,' unless the right to notice is waived by the  
30 person against whom the sanction is imposed, the commission may:

31 (A) Issue a cease and desist order prohibiting any violation of this article;

32 (B) Issue an order against a person who violates this article, imposing a civil penalty  
33 up to a maximum of \$1,000.00 per violation; or

34 (C) Issue an order suspending or revoking the ticket broker's license; or

1 (2) Upon a showing by the commission in any superior court of competent jurisdiction  
 2 that a person has violated or is about to violate this article, a rule promulgated under this  
 3 article, or an order of the commission, the court may enter or grant any or all of the  
 4 following relief:

5 (A) A temporary restraining order or a temporary or permanent injunction;

6 (B) A civil penalty up to a maximum of \$2,000.00 per violation of this article;

7 (C) A declaratory judgment;

8 (D) Restitution to any person or persons adversely affected by a defendant's action in  
 9 violation of this article; or

10 (E) Other relief as the court deems just or reasonable.

11 (c) Unless the commission determines that a person subject to this article intends to depart  
 12 quickly from this state or to remove his or her property from this state or to conceal his or  
 13 her person or property in this state or that there is immediate danger of harm to citizens of  
 14 this state or another state, the commission shall give notice in writing that such proceedings  
 15 are contemplated and allow such person a reasonable opportunity to appear before the  
 16 commission and execute an assurance of voluntary compliance. The determination of the  
 17 commission under this subsection shall be final and not subject to review.

18 (d) Procedures relating to hearings, notice, counsel, subpoenas, records, enforcement  
 19 powers, intervention, rules of evidence, decisions, exceptions, review of initial decisions,  
 20 final decisions, and judicial review of decisions shall be governed by Chapter 13 of Title  
 21 50, the 'Georgia Administrative Procedure Act,' unless the provisions of such chapter are  
 22 contrary to the express provisions of this article.

24 43-4B-40.

25 (a) Whenever the Attorney General has reasonable cause to believe that a person is  
 26 engaged in a violation of Article 2 of this chapter, the Attorney General may bring a civil  
 27 action requesting such relief, including a permanent or temporary injunction, restraining  
 28 order, or other order against such person as the Attorney General determines to be  
 29 necessary to restrain the person from continuing to engage in, sanction, promote, or  
 30 otherwise participate in a professional match, contest, or exhibition of boxing in violation  
 31 of Article 2 of this chapter.

32 (b)(1) Any manager, promoter, matchmaker, or licensee who knowingly violates or  
 33 coerces or causes any other person to violate any provision of Article 2 of this chapter  
 34 shall, upon conviction, be imprisoned for not more than one year or fined not more than  
 35 \$20,000.00, or both.

1 (2) Any member or employee of the commission or any person who administers or  
2 enforces this chapter or rules and regulations promulgated pursuant to this chapter who  
3 knowingly violates Code Section 43-4B-15 or Code Section 43-4B-16 shall, upon  
4 conviction, be imprisoned for not more than one year or fined not more than \$20,000.00,  
5 or both.

6 (3) Any professional boxer who knowingly violates any provision of this chapter except  
7 Code Section 43-4B-16 shall, upon conviction, be fined not more than \$1,000.00 for each  
8 violation.

9 (4) Any professional boxer who violates the provisions of Code Section 43-4B-16 may  
10 be punished by a fine not to exceed \$25,000.00 together with a percentage of the purse  
11 not to exceed 15 percent for each violation.

12 (c) Unarmed combat, as defined in Code Section 43-4B-1, is a misdemeanor of a high and  
13 aggravated nature."

14 **SECTION 3.**

15 All laws and parts of laws in conflict with this Act are repealed.
