

## House Resolution 453 (AS PASSED HOUSE AND SENATE)

## A RESOLUTION

1 Designating a portion of SR 83 in Monticello as the Trisha Yearwood Parkway; designating  
2 the Dr. Jimmy W. Waters Interchange; designating the Representative Debra Mills  
3 Commemorative Bridge; designating certain parts of the state highway system; and for other  
4 purposes.

**PART 1**

6 WHEREAS, Trisha Yearwood, a Monticello native, has become an internationally  
7 recognized recording star known for her beautiful voice and sincere manner; and

8 WHEREAS, Ms. Yearwood's accomplishments include several Grammy Awards and  
9 Female Vocalist of the Year from the Country Music Association as well as performing in  
10 the closing ceremonies for the 1996 Atlanta Olympics, performing with Pavarotti in Italy in  
11 1998, and performing at the White House for America's Millennium Celebration; and

12 WHEREAS, Trisha Yearwood has been a splendid ambassador for the City of Monticello  
13 and the State of Georgia by always recognizing her hometown, emphasizing her family's  
14 roots in Monticello, and speaking positively of her small town experience.

15 NOW, THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY OF  
16 GEORGIA that the portion of SR 83 north from the Monticello Square to the city limits is  
17 hereby designated as the Trisha Yearwood Parkway and that the Department of  
18 Transportation is authorized and directed to erect and maintain signs so identifying the  
19 highway.

20 BE IT FURTHER RESOLVED that the highway interchange at I-75 and Bass Road in Bibb  
21 County is redesignated the Dr. Jimmy W. Waters Interchange and the Department of  
22 Transportation is authorized and directed to erect and maintain signs so identifying the  
23 interchange.

1 BE IT FURTHER RESOLVED that the bridge on Interstate Highway 20 crossing the  
2 Chattahoochee River in Cobb County is designated the Representative Debra Mills  
3 Commemorative Bridge.

4 **PART 11**

5 BE IT FURTHER RESOLVED that the bridge over Brazell Creek on U.S. Highway 280  
6 West outside the city limits of Reidsville in Tattnall County is designated the Jesse O.  
7 Kennedy, Jr., Memorial Bridge, and the Department of Transportation is authorized and  
8 directed to erect and maintain appropriate signs so designating the bridge.

9 BE IT FURTHER RESOLVED that the bridge on State Highway 20 crossing Interstate 75  
10 in Henry County, Georgia is designated the Ed and Harold McGarity Memorial Bridge.

11 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized  
12 and directed to transmit an appropriate copy of this resolution to the Department of  
13 Transportation and to Ms. Trisha Yearwood.
