

The House Committee on Judiciary offers the following substitute to HB 104:

A BILL TO BE ENTITLED
AN ACT

1 To amend the Official Code of Georgia Annotated, so as to correct typographical, stylistic,
2 capitalization, punctuation, and other errors and omissions in the Official Code of Georgia
3 Annotated and in Acts of the General Assembly amending the Official Code of Georgia
4 Annotated; to reenact the statutory portion of the Official Code of Georgia Annotated, as
5 amended; to provide for necessary or appropriate revisions and modernizations of matters
6 contained in the Official Code of Georgia Annotated; to repeal portions of the Code and Acts
7 amendatory thereof which have become obsolete; to delete portions of the Code which have
8 been superseded by subsequent state laws; to provide for and to correct citations in the
9 Official Code of Georgia Annotated and other codes and laws of the state; to rearrange,
10 renumber, and redesignate provisions of the Official Code of Georgia Annotated; to provide
11 for other matters relating to the Official Code of Georgia Annotated; to provide an effective
12 date; to repeal conflicting laws; and for other purposes.

214 subsection (b) of Code Section 26-2-231, relating to definitions in regard to milk and milk
215 products.

216 (8) By striking the quotation marks from "'Grade A Pasteurized Milk Ordinance'" in Code
217 Section 26-2-238, relating to standards and requirements generally in regard to milk and milk
218 products.

219 (9) By striking "301 et seq" and "1040 et seq" and inserting in their respective places "301,
220 et seq" and "1040, et seq" in paragraph (7) and by striking "containers," and inserting in its
221 place "containers" in subparagraph (A) of paragraph (10) of Code Section 26-3-2, relating
222 to definitions in regard to standards, labeling, and adulteration of drugs and cosmetics.

223 (10) By striking "state board of pharmacy" and inserting in its place "State Board of
224 Pharmacy" in the introductory language of subsection (a) of Code Section 26-4-49, relating
225 to drug researcher permits, application for registration, fees, suspension or revocation, and
226 penalty for violations.

411 statutes by the provisions of this Act. Material which has been added in brackets or
412 parentheses and editorial, delayed effective date, effect of amendment, or other similar notes
413 within the text of a Code section by the editorial staff of the publisher in order to explain or
414 to prevent a misapprehension concerning the contents of the Code section and which is
415 explained in an editorial note is not enacted by the provisions of this section and shall not be
416 considered a part of the Official Code of Georgia Annotated. The reenactment of the
417 statutory portion of the Official Code of Georgia Annotated by this Act shall not affect,
418 supersede, or repeal any Act of the General Assembly, or portion thereof, which is not
419 contained in the Official Code of Georgia Annotated and which was not repealed by Code
420 Section 1-1-10, specifically including those Acts which have not yet been included in the text
421 of the Official Code of Georgia Annotated because of effective dates which extend beyond
422 the effective date of the Code or the publication date of the Code or its supplements. The
423 provisions contained in other sections of this Act and in the other Acts enacted at the 2003
424 regular session of the General Assembly of Georgia shall supersede the provisions of the
425 Official Code of Georgia Annotated reenacted by this section.
