## A RESOLUTION

- 1 Creating the Senate Music Industry Committee, an interim study committee, and a citizens'
- 2 advisory council thereto; and for other purposes.
- 3 WHEREAS, the music industry annually is one of this nation's fastest growing and most
- 4 prosperous businesses and professions, producing sales in the millions of dollars and
- 5 employing thousands of workers throughout the United States; and
- 6 WHEREAS, it is to the economic advantage of the State of Georgia that the many talented
- 7 musicians and music industry executives throughout this nation be made aware of the
- 8 excellent opportunities available in the State of Georgia for the location of music studios and
- 9 be encouraged to join the international recording artists, major booking agencies, promoters,
- 10 giant publishing companies, record labels, distribution centers, renowned entertainment
- attorneys and producers, and the world's largest record pressing plant that are already in
- 12 Georgia, all of which promote the economic and cultural advancement of the citizens of this
- 13 state; and
- 14 WHEREAS, the above-noted musicians, music industry executives, and musical facilities
- 15 have enjoyed unparalleled success in the music industry and have created numerous jobs for
- 16 citizens of this state and provided valuable contributions to revenue collections of municipal,
- 17 county, and state governmental authorities; and
- 18 WHEREAS, upon the attraction of additional professionals in this industry to the State of
- 19 Georgia, many new jobs would be created for citizens of this state; and
- 20 WHEREAS, in order to determine the most viable and efficient means by which this industry
- 21 can be attracted and encouraged to locate in Georgia, it is necessary to examine methods and
- 22 alternatives closely and comprehensively to accomplish this desire; and

1 WHEREAS, the Senate at its 1978 session first created the Senate Music Recording Industry

- 2 Study Committee, which rendered outstanding service to the State of Georgia, particularly
- 3 by giving birth to, sponsoring, promoting, and presenting the first "Georgia Music Week"
- 4 which was an unqualified success; and
- 5 WHEREAS, similar committees have been created every year subsequent to 1978, which
- 6 have carried on and expanded the work of the original committee, particularly in the area of
- 7 promoting and presenting the "Georgia Music Festival"; and
- 8 WHEREAS, it is imperative that the work of all those previous committees be continued and
- 9 that the "Georgia Music Festival" be celebrated each year on a permanent basis; and
- 10 WHEREAS, in order to accomplish these objectives, a similar committee should be
- 11 established at this time.
- 12 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that there is created an interim
- 13 study committee to be called the Senate Music Industry Committee to be composed of five
- members of the Senate to be appointed by the Senate Committee on Assignments, one of
- 15 whom shall be designated as chairperson. The committee is authorized to conduct a
- 16 continuing study of methods for attracting the music industry and related fields to the State
- of Georgia, to continue its assistance and support of the "Georgia Music Festival," and to
- 18 study all facets of the music industry and all matters relative thereto which would be
- 19 beneficial to the State of Georgia. The committee is authorized to seek the advice and
- 20 counsel of persons knowledgeable in the music industry and related fields and other persons,
- 21 groups, and organizations which the committee feels will be able to assist it in its endeavors.
- 22 The legislative members of the committee shall receive the allowances provided by law for
- 23 legislative members of interim legislative committees. The committee shall meet upon the
- 24 call of the chairperson, and it is authorized to hold meetings and conduct studies at such
- 25 times and places as the committee deems advisable in carrying out its duties.
- 26 BE IT FURTHER RESOLVED that the Senate Committee on Assignments is further
- 27 authorized to appoint a citizens' advisory council to assist the committee and to appoint one
- 28 of its members as chairperson of the council. Members of the council shall receive no
- 29 compensation or allowances for their services thereon, except that the chairperson of the
- 30 council shall receive the same allowances provided for the legislative members of the
- 31 committee. The committee and council shall stand abolished on December 31, 2004.
