- 17 Representative Connell was very effective in bringing growth and development to the City
- 18 of Augusta's infrastructure; and
- 19 WHEREAS, he was solely responsible for obtaining \$50 million for the design and
- 20 construction of the Riverwatch Parkway; and
- 21 WHEREAS, he is a devoted husband to his wife, the former Nanette Jean Anderson, and
- 22 takes great delight in four children and six grandchildren; and
