A BILL TO BE ENTITLED AN ACT

- 1 To amend Article 5 of Chapter 3 of Title 47 of the Official Code of Georgia Annotated,
- 2 relating to service creditable toward retirement benefits under the Teachers Retirement
- 3 System of Georgia, so as to provide that members of such retirement system may obtain
- 4 creditable service for prior service in public schools; to provide for conditions; to provide for
- 5 the payment of employer and employee contributions; to provide conditions for an effective
- 6 date and automatic repeal; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 Article 5 of Chapter 3 of Title 47 of the Official Code of Georgia Annotated, relating to
- 10 service creditable toward retirement benefits under the Teachers Retirement System of
- 11 Georgia, is amended by striking in its entirety Code Section 47-3-95, relating to creditable
- service for service in private schools, and inserting in lieu thereof the following:
- 13 "47-3-95.

- 14 A member who has completed at least five consecutive years of membership service in the
- public schools of Georgia or the University System of Georgia immediately prior to
- applying may obtain up to ten years of creditable service for service as a teacher in a
- private elementary or secondary school or any private college or university located in the state accredited by the Southern Association of Colleges and Schools, the Georgia
- 19 Accrediting Association, or a nationally recognized accrediting agency by the State Board
- of Education. Such service credit shall be allowed on the basis of one year of credit for
- such service for each additional year of membership service in the public schools of
- Georgia or the University System of Georgia. A member wishing to obtain such creditable
- service shall provide documentation and pay to the board of trustees such amount as
- 24 determined by the actuary as necessary to grant such benefit without creating any accrued
- 25 actuarial liability as to this retirement system the employer and employee contributions
- 26 which would have been paid to the retirement system during the period of time claimed as

1 <u>creditable service based on the member's earnable compensation at the time of making</u>

- 2 application for creditable service plus regular interest thereon compounded annually from
- 3 the time the service as a visiting scholar was rendered until the date of payment."

4 SECTION 2.

- 5 This Act shall become effective on July 1, 2004, only if it is determined to have been
- 6 concurrently funded as provided in Chapter 20 of Title 47 of the Official Code of Georgia
- 7 Annotated, the "Public Retirement Systems Standards Law"; otherwise, this Act shall not
- 8 become effective and shall be automatically repealed in its entirety on July 1, 2004, as
- 9 required by subsection (a) of Code Section 47-20-50.

SECTION 3.

11 All laws and parts of laws in conflict with this Act are repealed.
