A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act establishing a municipal court of the City of Atlanta (now a division of the  
2 State Court of Fulton County), approved August 20, 1913 (Ga. Laws 1913, p. 145), as  
3 amended, so as to change certain fees charged by the clerk and marshal of said court; to  
4 repeal conflicting laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 SECTION 1.

7 An Act establishing a municipal court of the City of Atlanta (now a division of the State  
8 Court of Fulton County), approved August 20, 1913 (Ga. Laws 1913, p. 145), as amended,  
9 is amended by striking in their entirety subsections (a), (b), and (c) and Table A of subsection  
10 (d) and inserting in lieu thereof the following:
