A BILL TO BE ENTITLED
AN ACT

1 To amend Article 3 of Chapter 7 of Title 16 of the Official Code of Georgia Annotated,
2 relating to arson and explosives, so as to provide for additional offenses constituting the
3 crimes of arson in the first, second, and third degree; to provide an effective date; to provide
4 for applicability; to repeal conflicting laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 style="text-align:center">**SECTION 1.**

7 Article 3 of Chapter 7 of Title 16 of the Official Code of Georgia Annotated, relating to arson
8 and explosives, is amended by striking Code Section 16-7-60, relating to arson in the first
9 degree, and inserting in its place a new Code Section 16-7-60 to read as follows:

10 "16-7-60.

11 (a) A person commits the offense of arson in the first degree when, by means of fire or
12 explosive, he or she knowingly damages or knowingly causes, aids, abets, advises,
13 encourages, hires, counsels, or procures another to damage:

14 (1) Any dwelling house of another without his or her consent or in which another has a
15 security interest, including but not limited to a mortgage, a lien, or a conveyance to secure
16 debt, without the consent of both, whether it is occupied, unoccupied, or vacant;

17 (2) Any building, vehicle, railroad car, watercraft, or other structure of another without
18 his or her consent or in which another has a security interest, including but not limited to
19 a mortgage, a lien, or a conveyance to secure debt, without the consent of both, if such
20 structure is designed for use as a dwelling, whether it is occupied, unoccupied, or vacant;

21 (3) Any dwelling house, building, vehicle, railroad car, watercraft, aircraft, or other
22 structure whether it is occupied, unoccupied, or vacant and when such is insured against
23 loss or damage by fire or explosive and such loss or damage is accomplished without the
24 consent of both the insurer and the insured;

1 (4) Any dwelling house, building, vehicle, railroad car, watercraft, aircraft, or other
 2 structure whether it is occupied, unoccupied, or vacant with the intent to defeat,
 3 prejudice, or defraud the rights of a spouse or co-owner; or

4 (5) Any building, vehicle, railroad car, watercraft, aircraft, or other structure under such
 5 circumstances that it is reasonably foreseeable that human life might be endangered.

6 (b) A person also commits the offense of arson in the first degree when, in the commission
 7 of a felony, by means of fire or explosive, he or she knowingly damages or knowingly
 8 causes, aids, abets, advises, encourages, hires, counsels, or procures another to damage
 9 anything included or described in subsection (a) of this Code section.

10 ~~(b)~~(c) A person convicted of the offense of arson in the first degree shall be punished by
 11 a fine of not more than \$50,000.00 or by imprisonment for not less than one nor more than
 12 20 years, or both."

13 SECTION 2.

14 Said article is further amended by striking Code Section 16-7-61, relating to arson in the
 15 second degree, and inserting in its place a new Code Section 16-7-61 to read as follows:

16 "16-7-61.

17 (a) A person commits the offense of arson in the second degree as to any building, vehicle,
 18 railroad car, watercraft, aircraft, or other structure not included or described in Code
 19 Section 16-7-60 when, by means of fire or explosive, he or she knowingly damages or
 20 knowingly causes, aids, abets, advises, encourages, hires, counsels, or procures another to
 21 damage any building, vehicle, railroad car, watercraft, aircraft, or other structure of another
 22 without his or her consent or in which another has a security interest, including but not
 23 limited to a mortgage, a lien, or a conveyance to secure debt, without the consent of both.

24 (b) A person also commits the offense of arson in the second degree as to any building,
 25 vehicle, railroad car, watercraft, aircraft, or other structure not included or described in
 26 Code Section 16-7-60 when, in the commission of a felony, by means of fire or explosive,
 27 he or she knowingly damages or knowingly causes, aids, abets, advises, encourages, hires,
 28 counsels, or procures another to damage any building, vehicle, railroad car, watercraft,
 29 aircraft, or other structure of another without his or her consent or in which another has a
 30 security interest, including but not limited to a mortgage, a lien, or a conveyance to secure
 31 debt, without the consent of both.

32 ~~(b)~~(c) A person convicted of the offense of arson in the second degree shall be punished
 33 by a fine of not more than \$25,000.00 or by imprisonment for not less than one nor more
 34 than ten years, or both."
