

## Senate Resolution 49

**ADOPTED SENATE**

## A RESOLUTION

1 Requesting that the United States Congress enact a Medicare prescription drug benefit; and  
2 for other purposes.

3 WHEREAS, the use of prescription drugs improves the quality of care and helps patients live  
4 healthier, longer, and more productive lives while keeping them out of more costly acute care  
5 settings in the long term; and

6 WHEREAS, the increased use of new and improved prescription drugs has changed the  
7 delivery of health care in the United States since Medicare was enacted, and while two-thirds  
8 of the Medicare population has some form of prescription drug coverage, although it many  
9 times is inadequate, one-third of Medicare beneficiaries have no coverage at all; and

10 WHEREAS, Congress did not enact a drug benefit in the Medicare program; therefore, the  
11 program is inadequate in providing the elderly and disabled the most appropriate drug  
12 therapies and prevents the delivery of quality health care at an affordable cost; and

13 WHEREAS, the private sector provides affordable coverage by negotiating discounts on  
14 drugs and meeting the needs of special populations with chronic diseases and comorbidities  
15 through coordinating care with disease management, drug utilization review, and patient  
16 education programs, all of which aid in ameliorating medical errors; and

17 WHEREAS, comprehensive reform of the Medicare program would utilize the successful  
18 tools of the private sector in coordinating care for these populations and use the marketplace  
19 to foster competition among private plans, resulting in more choices of quality coverage for  
20 seniors and the disabled while maintaining the financial sustainability of the program; and

21 WHEREAS, Congress' inaction has failed to provide for comprehensive reform of Medicare,  
22 encouraging states to use their own resources to ease the burden of their elderly and disabled  
23 populations and effectively assume an unfunded informal mandate; and

1 WHEREAS, in implementing state programs to assist the Medicare population, state  
2 budgetary constraints can often result in the restriction and limitation of patients' access to  
3 needed prescription drugs and the enactment of anticompetitive price controls.

4 NOW, THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY OF  
5 GEORGIA that the members of this body request that the United States Congress enact  
6 financially sustainable, voluntary, universal, and privately administered outpatient  
7 prescription drug coverage as part of the federal Medicare program.

8 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed  
9 to transmit an appropriate copy of this resolution to the Georgia congressional delegation.
