A RESOLUTION

- 1 Establishing the Senate Commission on Georgia State Government Cost Control and the
- 2 Senate Private Sector Advisory Committee on Georgia State Government Cost Control; and
- 3 for other purposes.

4 BE IT RESOLVED BY THE SENATE:

5 SECTION 1.

- 6 (a) There is established the Senate Commission on Georgia State Government Cost Control.
- 7 The commission shall consist of nine members as follows:
- 8 (1) The director of the Office of Planning and Budget or his or her designee;
- 9 (2) The commissioner of administrative services or his or her designee;
- 10 (3) The inspector general or his or her designee;
- 11 (4) The state auditor or his or her designee; and
- 12 (5) Five members of the Senate appointed by the Senate Committee on Assignments, one
- of whom shall be designated by the Senate Committee on Assignments as the chairperson
- of the commission. The legislative members shall serve for terms of office concurrent with
- their terms as members of the Senate.
- 16 (b) Members of the commission shall serve without compensation except that members of
- 17 the Senate serving on the commission may receive expense reimbursement from legislative
- 18 funds in the same manner as for service on legislative committees.

19 SECTION 2.

- 20 Every agency and department of state government is requested to provide assistance and
- 21 cooperation to the commission in the performance of its duties.
- SECTION 3.
- 23 The general purpose of the commission shall be to develop plans for coordinated state
- 24 government-wide activities that attack fraud and waste and promote economy and efficiency
- 25 in government programs and operations. The commission may itself undertake such activities

and shall also seek to receive such plans through the activities of the Senate Private Sector

2 Advisory Committee on Georgia State Government Cost Control.

3 SECTION 4.

4 The commission shall exist for an indefinite period of time until dissolved by further

5 resolution of the Senate.

6 SECTION 5.

- 7 (a) The commission shall establish the Senate Private Sector Advisory Committee on
- 8 Georgia State Government Cost Control. The commission shall establish the number and
- 9 method of selection of the members of the advisory committee and its officers. All members
- 10 of the advisory committee shall be private citizens or members of the business community
- and shall not be public employees or the holders of public office.
- 12 (b) The advisory committee shall conduct a review of the operations of state government and
- develop proposals for the control of costs in state government. Without limiting the
- 14 generality of the foregoing, the advisory committee shall consider providing
- 15 recommendations in the following areas:
- 16 (1) Opportunities for increased efficiency and reduced costs in state government that can
- be realized by executive action or legislation;
- 18 (2) Areas where managerial accountability can be enhanced and administrative control can
- 19 be improved;
- 20 (3) Opportunities for long-term and short-term managerial improvements;
- 21 (4) Specific areas where further study can be justified by potential savings; and
- 22 (5) Information and data relating to governmental expenditures, indebtedness, and
- personnel management.
- 24 (c) All agencies and departments of state government are requested to provide to the
- 25 advisory committee to the maximum extent permitted by law such information as may be
- 26 requested by the advisory committee for purposes of its functions.
- 27 (d) Members of the advisory committee shall serve without compensation. The advisory
- 28 committee is to be funded, staffed, and equipped, to the extent practicable and permitted by
- 29 law, by the private sector without cost to state government. To accomplish this objective it
- 30 is expected that the commission will engage in a joint project with one or more nonprofit
- 31 organizations for the purpose of providing staff support to the advisory committee.
- 32 (e) The advisory committee shall function for such period of time as shall be specified, or
- from time to time extended, by the commission. The advisory committee shall periodically
- 34 report to the commission as agreed by the commission and the advisory committee.
