

## Senate Resolution 271

## A RESOLUTION

1 Creating the Joint Port Authority for the Port of Savannah Study Committee; and for other  
2 purposes.

3 WHEREAS, the Port of Savannah was the site of the establishment of the Colony of Georgia;  
4 and

5 WHEREAS, the Savannah River is the navigable river that serves the Port of Savannah; and

6 WHEREAS, the State of South Carolina borders the northern side of the Savannah River;  
7 and

8 WHEREAS, Jasper County, South Carolina, borders the Savannah River on the north; and

9 WHEREAS, both the State of Georgia and the State of South Carolina have established port  
10 authorities to govern all port related activities in their states; and

11 WHEREAS, competition for shipping business has been a long accepted tradition between  
12 the Port of Savannah and the Port of Charleston; and

13 WHEREAS, both states are intent on supporting the future development of their respective  
14 ports; and

15 WHEREAS, both the State of Georgia and the State of South Carolina are dependent on the  
16 economic benefits derived from the activities of each respective port authority; and

17 WHEREAS, the ever increasing size of ships is requiring both ports to continually deepen  
18 the respective rivers which serve their ports; and

1 WHEREAS, the environmental factors affected by such river deepening is becoming a major  
2 obstacle to be overcome by each port prior to deepening their respective port rivers; and

3 WHEREAS, there may be certain benefits to be realized by both states sharing information  
4 regarding a proposed port operation on both the north and south sides of the Savannah River;  
5 and

6 WHEREAS, it is in the best interest of both states to cooperate with each other's economic  
7 activities along their common border.

8 NOW, THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY OF  
9 GEORGIA that there is created the Joint Port Authority for the Port of Savannah Study  
10 Committee to be composed of three members of the Senate to be appointed by the Senate  
11 Committee on Assignments and three members of the House of Representatives to be  
12 appointed by the Speaker of the House of Representatives.

13 BE IT FURTHER RESOLVED that the committee shall undertake a study of the conditions,  
14 needs, issues, and problems mentioned above or related thereto and recommend any action  
15 or legislation the committee deems necessary or appropriate. The committee may conduct  
16 such meetings at such places and at such times as it may deem necessary or convenient to  
17 enable it to exercise fully and effectively its powers, perform its duties, and accomplish the  
18 objectives and purposes of this resolution. The members of the committee shall receive the  
19 allowances provided for in Code Section 28-1-8 of the Official Code of Georgia Annotated.  
20 All funds necessary to carry out the provisions of this resolution shall come from funds  
21 appropriated to the House of Representatives and the Senate. The expenses and allowances  
22 authorized by this resolution shall not be received by any member of the committee for more  
23 than five days unless additional days are authorized. In the event the committee makes a  
24 report of its findings and recommendations, with suggestions for proposed legislation, if any,  
25 such report shall be made on or before December 1, 2003. The committee shall stand  
26 abolished on December 1, 2003.
