## A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act creating the Board of Commissioners of Troup County, approved March
- 2 25, 1958 (Ga. L. 1958, p. 3068), as amended, particularly by an Act approved February 27,
- 3 1992 (Ga. L. 1992, p. 4796), so as to reconstitute the Board of Commissioners; to change the
- 4 description of the commissioner districts; to provide for definitions and inclusions; to provide
- 5 for continuation in office of current members; to provide for election and terms of office of
- 6 subsequent members; to provide for submission of this Act for approval under the federal
- 7 Voting Rights Act of 1965, as amended; to provide effective dates; to repeal conflicting laws;
- 8 and for other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

- An Act creating the Board of Commissioners of Troup County, approved March 25, 1958
- 12 (Ga. L. 1958, p. 3068), as amended, particularly by an Act approved February 27, 1992 (Ga.
- 13 L. 1992, p. 4796), is amended by striking Section 2 and inserting in lieu thereof the
- 14 following:

15 "SECTION 2.

- 16 (a)(1) The Board of Commissioners of Troup County which existed on December 31,
- 17 2003, is continued in existence but on and after the effective date of this Act, shall be
- constituted as provided in this Act. The Board of Commissioners of Troup County so
- continued and constituted, sometimes referred to in this Act as the 'board,' shall continue
- 20 to have the powers, duties, rights, obligations, and liabilities of that board as existed
- immediately prior to January 1, 2004.
- 22 (2) Those members of the Board of Commissioners of Troup County who are serving as
- such on December 31, 2003, and any person selected to fill a vacancy in any such office
- shall continue to serve as such members until the regular expiration of their terms of
- office, and upon the election and qualification of their respective successors. On and

after the effective date of this Act, the Board of Commissioners of Troup County shall consist of five members all of whom shall be elected from commissioner districts described in subsection (b) of this section.

(b) For purposes of electing members of the board of commissioners, Troup County is divided into five commissioner districts. One member of the board shall be elected from each such district. Commissioner District No. 1 shall consist of the entire county of Troup. Commissioner Districts No. 2 through 5 shall be and correspond to those numbered districts described in and attached to and made a part of this Act and further identified as Plan Name: troupccwk3 Plan Type: LOCAL User: Shantee Administrator: TROUP. (c) When used in such attachment, the terms 'Tract' and 'BG' (Block Group) shall mean and describe the same geographical boundaries as provided in the report of the Bureau of the Census for the United States decennial census of 2000 for the State of Georgia. The separate numeric designations in a Tract description which are underneath a "BG" heading shall mean and describe individual Blocks within a Block Group as provided in the report of the Bureau of the Census for the United States decennial census of 2000 for the State of Georgia. Any part of Troup County which is not included in any such district described in that attachment shall be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2000 for the State of Georgia. Any part of Troup County which is described in that attachment as being in a particular district shall nevertheless not be included within such district if such

part is not contiguous to such district. Such noncontiguous part shall instead be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2000 for the State of Georgia. Except as otherwise

provided in the description of any commissioner district, whenever the description of such district refers to a named city, it shall mean the geographical boundaries of that city as

shown on the census map for the United States decennial census of 2000 for the State of

(d)(1) No person shall be a member of the board if that person is ineligible for such office pursuant to Code Section 45-2-1 of the O.C.G.A. or any other general law applicable to that office.

(2) In order to be elected as a member of the board from a commissioner district, a person must receive the number of votes cast as required by general law for that office in that district only. Only electors who are residents of that commissioner district may vote for a member of the board for that district. At the time of qualifying for election as a member of the board from a commissioner district, each candidate for such office shall specify the commissioner district for which that person is a candidate. A person elected or appointed as a member of the board from a commissioner district must continue to

1 reside in that district during that person's term of office or that office shall become

2 vacant.

(3) The commissioner elected from Commissioner District No. 1 shall be the chairperson of the board of commissioners. The chairperson of the board may reside anywhere within Troup County and, if elected, must receive the number of votes cast for that office, as required by general law in the entire county. The chairperson must continue to reside within the county during that person's term of office, or that office shall become vacant."

8 **SECTION 2.** 

9 Said Act is further amended by striking Section 3 and inserting in lieu thereof the following:

10 "SECTION 3.

> (a)(1) The first members of the reconstituted Board of Commissioners of Troup County from Districts 2, 3, and 4 shall be elected at the general election on the Tuesday next following the first Monday in November 2004. Those members of the board elected thereto from Commissioner Districts 2, 3, and 4 in 2004 shall take office the first day of January immediately following that election and shall serve for initial terms of office which expire December 31, 2008, and upon the election and qualification of their respective successors. The first members of such board from Districts 1 and 5 shall be elected at the general election on the Tuesday next following the first Monday in November 2006. Those members of the board elected thereto from Commissioner Districts 1 and 5 in 2006 shall take office the first day of January immediately following that election and shall serve for initial terms of office which expire December 31, 2010, and upon the election and qualification of their respective successors. Those and all future successors to members of the board whose terms of office are to expire shall be elected at the time of the state-wide general election immediately preceding the expiration of such terms, shall take office the first day of January immediately following that election, and shall serve for terms of office of four years each. Members of the board shall serve for the terms of office specified therefor in this subsection and until their respective successors are elected and qualified.

> (2) Commissioner Districts 1, 2, 3, 4, and 5 as they exist on December 31, 2003, shall continue to be designated as Commissioner Districts 1, 2, 3, 4, and 5, respectively, but as newly described under this Act, and on and after the effective date of this Act, such members of the board serving from those former commissioner districts shall be deemed to be serving from and representing their respective districts as newly described under this section."

SECTION 3.

- 2 The governing authority of Troup County shall through its legal counsel cause this Act to be
- 3 submitted for preclearance under the federal Voting Rights Act of 1965, as amended; and
- 4 such submission shall be made to the United States Department of Justice or filed with the
- 5 appropriate court no later than 45 days after the date on which this Act is approved by the
- 6 Governor or otherwise becomes law without such approval.

7 SECTION 4.

- 8 This section and Section 3 of this Act shall become effective upon approval of this Act by
- 9 the Governor or upon its becoming law without such approval; all other sections of this Act
- shall become effective on January 1, 2004.

SECTION 5.

12 All laws and parts of laws in conflict with this Act are repealed.
