

The Senate Committee on Economic Development and Tourism offered the following substitute to SB 131:

A BILL TO BE ENTITLED  
AN ACT

1 To amend Chapter 10 of Title 25 of the Official Code of Georgia Annotated, relating to the  
2 regulation of fireworks, so as to change the definition of the term "fireworks"; to prohibit the  
3 sale of certain combustible or explosive compositions to persons under 16 years of age; to  
4 provide for a monetary penalty for sales made in violation of such prohibition; to provide an  
5 effective date; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

**SECTION 1.**

7 Chapter 10 of Title 25 of the Official Code of Georgia Annotated, relating to the regulation  
8 of fireworks, is amended by striking Code Section 25-10-1, relating to definition of  
9 "fireworks," and inserting in lieu thereof a new Code Section 25-10-1 to read as follows:

10 "25-10-1.

11 As used in this chapter, the term 'fireworks' means any combustible or explosive  
12 composition or any substance or combination of substances or article prepared for the  
13 purpose of producing a visible or audible effect by combustion, explosion, deflagration, or  
14 detonation, including blank cartridges, balloons requiring fire underneath to propel them,  
15 firecrackers, torpedos, skyrockets, Roman candles, bombs, sparklers, and other  
16 combustibles and explosives of like construction, as well as articles containing any  
17 explosive or flammable compound and tablets and other devices containing an explosive  
18 substance. The term 'fireworks' shall not include model rockets and model rocket engines,  
19 designed, sold, and used for the purpose of propelling recoverable aero models; wire or  
20 wood sparklers of not more than 100 grams of mixture per item; other sparkling items  
21 which are nonexplosive and nonaerial and contain 75 grams or less of chemical compound  
22 per tube or a total of 200 grams or less for multiple tubes; snake and glow worms; trick  
23 noise makers which include paper streamers, party poppers, string poppers, snappers, and  
24 drop pops each consisting of 0.25 grains or less of explosive mixture; toy pistol paper caps  
25 in which the explosive content does not average more than 0.25 grains of explosive mixture

1 per paper cap; nor toy pistols, toy cannons, toy canes, toy guns, or other devices using such  
 2 paper caps; nor shall the term 'fireworks' include ammunition consumed by weapons used  
 3 for sporting and hunting purposes."

#### 4 SECTION 2.

5 Said chapter is further amended by striking Code Section 25-10-2, relating to prohibited acts  
 6 with respect to fireworks, and inserting in lieu thereof a new Code Section 25-10-2 to read  
 7 as follows:

8 "25-10-2.

9 (a) It shall be unlawful for any person, firm, corporation, association, or partnership to  
 10 offer for sale at retail or wholesale, to use or explode or cause to be exploded, or to possess,  
 11 manufacture, transport, or store any fireworks, except as otherwise provided in this chapter.

12 (b) Notwithstanding any provision of this chapter to the contrary, it shall be unlawful for  
 13 any person, firm, corporation, association, or partnership to sell to any person under 16  
 14 years of age any wire or wood sparklers of not more than 100 grams of mixture per item,  
 15 other sparkling items which are nonexplosive and nonaerial and contain 75 grams or less  
 16 of chemical compound per tube or a total of 200 grams or less for multiple tubes, snake and  
 17 glow worms, or trick noise makers which include paper streamers, party poppers, string  
 18 poppers, snappers, and drop pops each consisting of 0.25 grains or less of explosive  
 19 mixture."

#### 20 SECTION 3.

21 Said chapter is further amended by adding a new Code Section 25-10-9 to read as follows:

22 "25-10-9.

23 Notwithstanding any provision of this chapter to the contrary, any person, firm,  
 24 corporation, association, or partnership who or which knowingly violates subsection (b)  
 25 of Code Section 25-10-2 may be punished by a fine not to exceed \$100.00. Each sales  
 26 transaction in violation of subsection (b) of Code Section 25-10-2 shall be a separate  
 27 offense."

#### 28 SECTION 4.

29 This Act shall become effective upon its approval by the Governor or upon its becoming law  
 30 without such approval.

#### 31 SECTION 5.

32 All laws and parts of laws in conflict with this Act are repealed.
