1 Recognizing the Epilepsy Foundation of Georgia's Zero Lunches/Zero Nos Day; and for

WHEREAS, epilepsy affects 100,000 people in Georgia and is one of the most common
disabling neurological disorders; and

5 WHEREAS, the seizures that occur in persons with epilepsy make finding a job very difficult
6 and even acceptance in society becomes a hurdle, causing people with epilepsy to be isolated
7 from many facets of life; and

8 WHEREAS, the purpose of the Epilepsy Foundation of Georgia's Zero Lunches/Zero Nos 9 Day is to request that each Georgian give up lunch that one day and for not a single person 10 to say "No" to this request and to contribute to the Epilepsy Foundation of Georgia an 11 average of \$10.00 that would otherwise have been spent on lunch, with half of the donation 12 being used to fund vital services of the foundation and the other half being placed in the 13 foundation's endowment fund for investment and future use; and

14 WHEREAS, the Epilepsy Foundation of Georgia sponsors a job seeking and job retention 15 program that helps people find and keep employment; hosts education programs to teach 16 students and teachers about seizures, the proper response to seizures, and how to keep the classroom safe and conducive for keeping children with epilepsy on par with the class; 17 maintains an emergency medication fund to bridge the financial gap for people without jobs 18 19 or insurance who are in need of medication to prevent or control seizures; and provides 20 partial and full scholarships to children with epilepsy so that they can attend camps with 21 medical personnel and specially trained counselors who teach independence, self-reliance, and self-worth; and 22
