## A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act creating the Dougherty County school system, approved February 5, 1951
- 2 (Ga. L. 1951, p. 2233), as amended, particularly by an Act approved April 5, 1993 (Ga. L.
- 3 1993, p. 4749), so as to change the description of the education districts of the board of
- 4 education of such school system; to provide for definitions and inclusions; to provide for
- 5 elections; to provide for terms; to provide for submissions; to repeal conflicting laws; and for
- 6 other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act creating the Dougherty County school system, approved February 5, 1951 (Ga. L.
- 10 1951, p. 2233), as amended, particularly by an Act approved April 5, 1993 (Ga. L. 1993, p.
- 4749), is amended by striking in their entirety subsections (d), (e), and (f) of Section 5 and
- 12 inserting in their place the following:
- ''(d)(1) For the purpose of electing the members of the board of education of Dougherty
- 14 County, other than the at-large member, the Dougherty County School District is divided
- into six education districts. The six education districts shall be composed of and
- 16 correspond to those six numbered districts described in and attached to and made a part
- of this Act and further identified as Plan Name: dough03p1 Plan Type: Local User: Gina
- 18 Administrator: Dougherty Co.
- 19 (2) When used in such attachment, the terms 'Tract' and 'BG' (Block Group) shall mean
- and describe the same geographical boundaries as provided in the report of the Bureau
- of the Census for the United States decennial census of 2000 for the State of Georgia.
- The separate numeric designations in a Tract description which are underneath a 'BG'
- heading shall mean and describe individual Blocks within a Block Group as provided in
- the report of the Bureau of the Census for the United States decennial census of 2000 for
- 25 the State of Georgia. Any part of the Dougherty County School District which is not
- 26 included in any such district described in that attachment shall be included within that

district contiguous to such part which contains the least population according to the United States decennial census of 2000 for the State of Georgia. Any part of the Dougherty County School District which is described in that attachment as being in a particular district shall nevertheless not be included within such district if such part is not contiguous to such district. Such noncontiguous part shall instead be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2000 for the State of Georgia. Except as otherwise provided in the description of any education district, whenever the description of such district refers to a named city, it shall mean the geographical boundaries of that city as shown on the census map for the United States decennial census of 2000 for the State of Georgia.

(e)(1) Education Districts 1, 2, 3, 4, 5, and 6, as those districts existed immediately prior to the date this Act becomes effective in 2003, shall continue to be designated as

(e)(1) Education Districts 1, 2, 3, 4, 5, and 6, as those districts existed immediately prior to the date this Act becomes effective in 2003, shall continue to be designated as Education Districts 1, 2, 3, 4, 5, and 6, respectively, but as newly described under paragraph (1) of subsection (d) of this section. On and after the date this Act becomes effective in 2003, those members of the board of education serving from those education districts shall be deemed to be serving from and representing their respective districts as newly described under paragraph (1) of subsection (d) of this section.

(2) The at-large member and those members of the board representing Education Districts 1, 3, and 5 on the date this Act becomes effective in 2003, and any person selected to fill a vacancy in such position, shall continue to serve out their respective terms of office, which shall expire December 31, 2004, and until their respective successors are elected from newly described districts as provided in paragraph (1) of subsection (d) of this section and are qualified. Those members of the board representing Education Districts 2, 4, and 6 on the date this Act becomes effective in 2003, and any person selected to fill a vacancy in such position, shall continue to serve out their respective terms of office, which shall expire December 31, 2006, and until their respective successors are elected from newly described districts as provided in paragraph (1) of subsection (d) of this section and are qualified.

(f) The first general election at which members of the board of education are elected from Education Districts 1, 3, and 5, as newly described in paragraph (1) of subsection (d) of this section, shall be that election conducted in 2004. The first general election at which members of the board of education are elected from Education Districts 2, 4, and 6, as newly described in paragraph (1) of subsection (d) of this section, shall be that election conducted in 2006. Successors to members of the board whose terms of office are to expire shall be elected at the general election immediately preceding the expiration of such terms

and shall take office the first day of January immediately following that election for terms

of four years and until their successors are elected and qualified."

## 3 SECTION 2.

- 4 The board of education of Dougherty County shall through its legal counsel cause this Act
- 5 to be submitted for preclearance under the federal Voting Rights Act of 1965, as amended;
- 6 and such submission shall be made to the United States Department of Justice or filed with
- 7 the appropriate court no later than 45 days after the date on which this Act is approved by the
- 8 Governor or otherwise becomes law without such approval.

## 9 **SECTION 3.**

10 All laws and parts of laws in conflict with this Act are repealed.
