

The Senate State and Local Governmental Operations Committee offered the following substitute to SB 231:

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act providing for the establishment of a county-wide library system in Fulton
2 County, approved April 12, 1982 (Ga. L. 1982, p. 4174), as amended, particularly by an Act
3 approved April 5, 1995 (Ga. L. 1995, p. 4084), an Act approved April 1, 1996 (Ga. L. 1996,
4 p. 3859), and an Act approved April 4, 1997 (Ga. L. 1997, p. 3635), so as to specify a name
5 for the county-wide library system; to change membership, the number of members, and the
6 selection of members of the library board of trustees; to provide for vacancies and related
7 matters; to provide for the selection of the executive director of the library system and to
8 whom the executive director shall report; to provide an effective date; to repeal conflicting
9 laws; and for other purposes.

10 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

11 An Act providing for the establishment of a county-wide library system in Fulton County,
12 approved April 12, 1982 (Ga. L. 1982, p. 4174), as amended, particularly by an Act approved
13 April 5, 1995 (Ga. L. 1995, p. 4084), an Act approved April 1, 1996 (Ga. L. 1996, p. 3859),
14 and an Act approved April 4, 1997 (Ga. L. 1997, p. 3635), is amended by striking Section
15 4 and inserting in lieu thereof a new Section 4 to read as follows:

"SECTION 4.

17 (a) The county-wide library system shall be named the Atlanta-Fulton County Library
18 System. Responsibility for constructing, operating, and maintaining all library facilities and
19 services within the above named portions of Fulton County shall hereinafter be vested in
20 the county-wide library system which shall be administered by the library board of trustees.

22 (b)(1) The term of office of each member of the library board of trustees serving as such
23 trustee on June 30, 2003, shall expire upon July 1, 2003. On and after July 1, 2003, the
24 library board of trustees shall consist of 11 members as provided in this section.

1 (2) The mayor of the City of Atlanta or his or her designee shall serve on the library
2 board of trustees ex officio. The chairperson of the Fulton County board of
3 commissioners or his or her designee shall serve on the board of trustees ex officio.

4 (3) There shall be seven Fulton County appointed members, with one such member
5 appointed by each member of the Fulton County board of commissioners. Each member
6 of the board of trustees appointed by a member of the board of commissioners shall serve
7 at the pleasure of the appointing member of the board of commissioners. Each member
8 of the board of trustees appointed by a member of the board of commissioners shall
9 reside within the same commissioner district as the appointing member of such board of
10 commissioners and shall continue to reside in such district during his or her service on
11 the board of trustees or that office shall become vacant. A member of the board of
12 trustees appointed by an at-large member of the board of commissioners may reside
13 anywhere in Fulton County and shall continue to reside in Fulton County during his or
14 her service on the board of trustees or that office shall become vacant.

15 (4) There shall be two City of Atlanta appointed members. These two members shall be
16 selected from a list of no more than three candidates provided by the three council
17 members who are elected at large. Such list of candidates shall be agreed to by said three
18 council members and presented to the mayor for his or her selection and nomination to
19 the city council of two library board members. In the event that a list is not received
20 within 60 days of the mayor's request, the mayor shall proceed to nominate for the library
21 board members' positions. Said nominations shall be confirmed by majority vote of
22 council members present and voting on these nominations. The City of Atlanta appointed
23 board members shall serve for terms of two years commencing July 1 of each
24 odd-numbered year.

25 (c) Except with respect to the ex officio members, no person may be appointed or serve
26 as a member of the library board of trustees who holds any elective office.

27 (d) Any vacancy on the library board of trustees shall be filled in the same manner as the
28 initial appointment.

29 (e) Members of the library board of trustees shall be removed for cause or for failure to
30 attend three consecutive meetings pursuant to the bylaws of the library board of trustees.

31 (f) Members of the library board of trustees may receive a per diem allowance for each
32 meeting of the board of trustees which they attend. Such allowance shall be in such
33 amount as may be fixed from time to time by the Board of Commissioners of Fulton
34 County.

35 (g) There shall be an executive director of the library system who shall be hired by and
36 serve at the pleasure of the Fulton County manager and shall report directly to the county
37 manager for purposes of job performance, evaluation, and budgeting."
