- 7 extent possible, any election previously held in conformity with the provisions of this Act;
- 8 to provide for related matters; to repeal conflicting laws; and for other purposes.

9 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

- An Act reconstituting the Board of Education of Harris County, approved January 15, 1993
- 12 (Ga. L. 1993, p. 3538), as amended, particularly by an Act approved April 11, 2002 (Ga. L.
- 13 2002, p. 3927) and an Act approved April 25, 2002 (Ga. L. 2002, p. 4268), is amended by
- striking subsection (e) of Section 4 in its entirety and inserting in its place the following:
- 15 "(e) All members of the board shall be nominated and elected in accordance with Chapter
- 2 of Title 21 of the O.C.G.A., the 'Georgia Election Code,' in nonpartisan primaries and
- elections as provided in Code Section 21-2-139 of the O.C.G.A."

18 SECTION 2.

- 19 The amendatory Act, reconstituting the Board of Education of Harris County, approved April
- 20 25, 2002 (Ga. L. 2002, p. 4268), which Act was not approved pursuant to Section 5 of the
- 21 federal Voting Rights Act of 1965, is repealed in its entirety.
- SECTION 3.
- 23 The purpose of this Act is to replace language that was unintentionally and erroneously
- omitted from the amendatory Act, reconstituting the Board of Education of Harris County,

1 approved April 25, 2002 (Ga. L. 2002, p. 4268). It was the intention of the 2002 Act to

2 revise district lines only and not the method of election.

3 SECTION 4.

- 4 This Act is intended, to the maximum extent possible, to ratify and confirm any election
- 5 previously held in conformity with the provisions of this Act.

7 All laws and parts of laws in conflict with this Act are repealed.
