A RESOLUTION

- 1 Creating the Blue Ribbon Commission on Response, Investigation, and Prosecution of
- 2 Sexual Offenses; to provide for the commission's membership, powers, duties, mission,
- 3 compensation, and expenses; to provide for related matters; and for other purposes.
- 4 WHEREAS, it is the expressed will of the General Assembly to address the serious problems
- 5 faced by victims, law enforcement, and prosecutors on the occurrence of sexual assault; and
- 6 WHEREAS, occurrences of sexual assault continue to escalate against women and men with
- 7 long lasting detrimental effects on the victim, his or her family, and the community; and
- 8 WHEREAS, the Criminal Justice Coordinating Council has found that victims of sexual
- 9 assault may often receive incomplete or no information regarding their rights as victims; and
- 10 WHEREAS, the local investigating law enforcement agencies bear the cost of investigation,
- 11 often challenged by limited funding, resource options, and training; and
- 12 WHEREAS, the absence of physical evidence often hampers prosecution efforts; and
- 13 WHEREAS, nonprofit organizations currently play an essential and active role in the support
- 14 of criminal investigations and prosecution of sexual assault offenses and provide educational
- 15 resources to medical professions and law enforcement on issues related to sexual offenses
- 16 throughout Georgia; and
- 17 WHEREAS, the current economic circumstances demand coordination of funding,
- 18 investigation, and education efforts on state and local levels to maximize resources available
- 19 to respond to sexual assault offenses; and
- 20 WHEREAS, an opportunity should be provided for public debate and consideration of
- 21 options for improving the response to sexual assault offenses in Georgia; to make specific

1 recommendations for improving education, training, victim care, investigation, and

- 2 prosecution; to develop benchmarks for assessing progress toward such goals; to consider
- 3 whether a state sponsored program of Sexual Assault Nurse Examiners can be implemented;
- 4 and to consider what measures can be taken to ensure a better response to sexual assault
- 5 offenses in Georgia in the future.
- 6 NOW, THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY OF
- 7 GEORGIA that there is created the Blue Ribbon Commission on Response, Investigation,
- 8 and Prosecution of Sexual Offenses to be composed of 15 members, as follows: two
- 9 members appointed by the Governor, three members of the Senate to be appointed by the
- 10 Lieutenant Governor, three members of the House of Representatives to be appointed by the
- 11 Speaker of the House of Representatives, the director of the Georgia Bureau of Investigation
- 12 or his or her designee, the director of the Georgia Public Safety Training Center or his or her
- 13 designee, the director of the Prosecuting Attorney's Council of Georgia or his or her
- 14 designee, the commissioner of the Department of Community Health or his or her designee,
- 15 the director of the Criminal Justice Coordinating Council or his or her designee, the President
- 16 of the Georgia Board of Nursing or his or her designee, and the director of the Georgia
- 17 Network to End Sexual Assault or his or her designee. If an elected or appointed public
- 18 officer leaves office, a vacancy shall be created in such position on the commission. Such a
- 19 vacancy and any other vacancy shall be filled in the same manner as the initial designation
- 20 or appointment. The Lieutenant Governor and the Speaker of the House of Representatives
- 21 shall each designate a member of the commission to serve as cochairpersons of the
- 22 commission. The commission shall meet at the call of the cochairpersons.
- 23 BE IT FURTHER RESOLVED that in addition to normal legislative support services, the
- 24 commission shall make use of staff support services provided by the Department of
- 25 Community Health.
- 26 BE IT FURTHER RESOLVED that the commission shall undertake a study of the
- 27 conditions, needs, issues, and problems mentioned above or related thereto and recommend
- 28 any actions or legislation which the commission deems necessary or appropriate. The
- 29 commission may conduct such meetings at such places and at such times as it may deem
- 30 necessary or convenient to enable it to exercise fully and effectively its powers, perform its
- 31 duties, and accomplish the objectives and purposes of this resolution. The legislative
- 32 members of the commission shall receive the allowances provided for in Code Section
- 33 28-1-8, but shall receive the same for not more than five days unless additional days are
- 34 authorized. The members of the commission who are not legislative members and who are

1 not public employees shall receive no compensation for their services on the commission,

2 but they shall receive a daily expense allowance in the amount specified in subsection (b) of

3 Code Section 45-7-21. The members of the commission who are public employees shall

4 receive no compensation for their services on the commission but may be reimbursed for

5 expenses by their respective employers. The funds necessary to carry out the provisions of

6 this resolution shall come from the funds appropriated to or otherwise available to the Senate

7 and House of Representatives. The commission shall publish a written report on its progress

8 on or before December 1, 2003, for the 2004 session of the General Assembly and shall

9 include any recommendations of any actions or legislation which the commission deems

10 necessary or appropriate. This commission shall stand abolished on July 1, 2004.
