2 BE IT RESOLVED BY THE GENERAL ASSEMBLY OF GEORGIA that, unless otherwise  
3 provided by subsequent resolution of the General Assembly, the meeting dates and dates of  
4 adjournment for the 2004 regular session of the General Assembly for the period of January  
5 12, 2004, through February 16, 2004, shall be as follows:

1 BE IT FURTHER RESOLVED that on and after February 16, 2004, the periods of  
2 adjournment of the 2004 session, if any, shall be as specified by subsequent resolution of the  
3 General Assembly, except that for the remainder of the 2004 regular session, unless  
4 otherwise provided by subsequent resolution, the General Assembly shall adjourn at the close  
5 of the legislative day on each Friday on which the General Assembly is in session and shall  
6 reconvene on the following Monday.

7 BE IT FURTHER RESOLVED that, as authorized by Code Section 28-1-2, the hours for  
8 closing and convening the Senate on each day may be as ordered by the Senate; and the  
9 hours for closing and convening the House on each day may be as ordered by the House.
