## A RESOLUTION

1 Expressing regret at the passing of Honorable William G. "Bill" Hasty, Sr.; and for other  
2 purposes.

3 WHEREAS, on November 5, 2003, the State of Georgia lost one of its finest and most  
4 distinguished citizens in the untimely passing of Honorable William G. "Bill" Hasty, Sr.; and

5 WHEREAS, he served with unparalleled ability as a member of the House of Representatives  
6 for 12 years and as a member of the Senate for two years and faithfully represented the  
7 citizens of Cherokee County with great distinction, dedication, and ability; and

8 WHEREAS, his consistently thorough consideration of the issues presented to this  
9 deliberative body and his integrity and reliability earned him the honor, respect, and trust of  
10 his colleagues over the years; and

11 WHEREAS, he consistently demonstrated a solid commitment to the careful study of  
12 sensitive issues and proposed solutions and quickly developed a reputation as an equitable,  
13 impartial leader whose decisions were governed by the rules of honesty and fair play; and

14 WHEREAS, he exhibited the level of political activism and unselfish leadership ideally  
15 expected of public trustees in an effective, representative democracy, and his stewardship in  
16 the General Assembly was marked by unmatched dignity, grace, and wisdom; and

17 WHEREAS, this native son of Cherokee County diligently and conscientiously served his  
18 country with honor and distinction during World War II as a member of the United States  
19 Navy; and

20 WHEREAS, this generous and humble man spent his entire life working for the public good  
21 as evidenced dramatically by service as a teacher, principal, school superintendent, deputy

1 director of probation and parole for the Department of Corrections, and a member and  
2 chairperson of the State Transportation Board; and

3 WHEREAS, his unselfish nature was exemplified further by his decades of service as a  
4 deacon of First Baptist Canton and as a member of the Masons, the Cherokee County Shrine  
5 Club, the American Legion, and the Canton Lions Club; and

6 WHEREAS, the untimely passing of this beloved individual leaves an unfillable void in the  
7 hearts and lives of his family and friends; and

8 WHEREAS, his foresight and forthright determination have brought unparalleled progress  
9 and a sense of destiny to the citizens of Cherokee County and the State of Georgia and it is  
10 abundantly fitting and proper that the members of this body, most especially those to whom  
11 he so freely imparted advice, encouragement, and friendship and who regard him with much  
12 admiration and respect, pay appropriate tribute to one of their finest and most distinguished  
13 colleagues for the many years of impartial, well-reasoned, and enlightened service he has  
14 rendered on behalf of this state and its citizens.

15 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that  
16 the members of this body express their deepest and most sincere regret at the untimely  
17 passing of Honorable William G. "Bill" Hasty, Sr., and commend him for serving as an  
18 unmatched example of enlightened government and statesmanship.
