A RESOLUTION

- 1 Commending Dr. Olivia Smith Swanson; and for other purposes.
- 2 WHEREAS, the great State of Georgia is proud to call Dr. Olivia Smith Swanson, a native
3 of Savannah, one of its own; and
- 4 WHEREAS, the impeccable academic credentials of this graduate of Beach-Cuyler High
5 School include a bachelor's degree in home economics and certification in elementary
6 education from Savannah State College and a master's degree in special education from
7 Long Island University; and
- 8 WHEREAS, to address the needs of dyslexic and learning disabled students, Dr. Swanson
9 continued her postgraduate education as a student of the Orton-Gillingham Program in
10 Techniques in Teaching Language Skills from St. Joseph College and Hofstra University;

- 12 WHEREAS, in responding to a Christian call to service, she earned a doctorate in Christian
13 education at Jacksonville Theological Seminary; and
- 14 WHEREAS, she left Savannah to pursue her education and teaching career in New York and
15 returned to Savannah in 1986, returning to the Cuyler-Brownsville neighborhood home her
16 great-grandfather bought in the 1870's; and
- 17 WHEREAS, she has become active in the Cuyler-Brownsville community and has diligently
18 fought to revitalize the neighborhood that she knew as a child to be a warm, close-knit,
19 family oriented, and upwardly mobile community; and
- 20 WHEREAS, to restore the fallen Cuyler-Brownsville area she had returned to, Dr. Swanson,
21 with the help of a neighbor and a police officer, organized and was president of the Harden
22 and 38th Streets Block Association; and

1 WHEREAS, through her tireless efforts and community involvement she was able to restore
2 some of the warm, family oriented qualities Cuyler-Brownsville had lost; and

3 WHEREAS, Dr. Swanson is involved in many civic and social organizations in her
4 community and is president of the Cuyler-Brownsville Neighborhood Association, on the
5 advisory board of Mercy Housing, Inc., Southeast, a member of the Inter-Neighborhood
6 Council, an organizer of the Concerned Citizens for Library Preservation, a board member
7 of Historic Savannah Foundation, a member of the NAACP, and a faithful member of St.
8 Philip AME Church.

9 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
10 this body commends Dr. Olivia Smith Swanson for her dedicated work and community
11 service.
