A BILL TO BE ENTITLED
AN ACT

1 To amend Article 1 of Chapter 2 of Title 46 of the Official Code of Georgia Annotated,
2 relating to the organization and members of the Public Service Commission, so as to provide
3 for certain fees to be collected by the commission; to provide for the disposition of such fees;
4 to repeal conflicting laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 SECTION 1.

7 Article 1 of Chapter 2 of Title 46 of the Official Code of Georgia Annotated, relating to the
8 organization and members of the Public Service Commission, is amended by inserting at the
9 end thereof the following:

10 "46-2-11.

11 (a) The Public Service Commission shall charge and collect the following administrative
12 fees:

13 (1) For filing a rate-making proceeding under Code Section 46-2-25:

14 (A) For electric utilities with one million or more
15 retail customers \$400,000.00

16 (B) For electric utilities with less than one million
17 retail customers 200,000.00

18 (C) For natural gas electing distribution companies 300,000.00

19 (D) For natural gas local distribution companies 100,000.00

20 (E) For other utilities 35,000.00

21 (2) For filing a fuel cost recovery proceeding under
22 Code Section 46-2-26 20,000.00

23 (3) For filing a gas supply plan proceeding under Code
24 Section 46-2-26 120,000.00

25 (4) For filing a territorial dispute under Chapter 3 of this title 10,000.00

1	(5) For filing a capacity supply plan proceeding under	
2	subsection (e) of Code Section 46-4-155	20,000.00
3	(6) For filing an application for arbitration of terms and	
4	conditions of telecommunications interconnection	20,000.00
5	(7) For filing an application for financing authority under	
6	Code Section 46-2-28	1,000.00
7	(8) For filing an application for certificate of authority or	
8	certificate of public convenience and necessity:	
9	(A) For a certificate of authority as a natural gas marketer	
10	under Code Section 46-4-153	5,000.00
11	(B) For a certificate of authority to provide local exchange	
12	service under Code Section 46-5-163	1,000.00
13	(C) For all other certificates of authority and certificates	
14	of public convenience and necessity	200.00
15	(b) All fees collected by the Public Service Commission pursuant to this Code section shall	
16	be paid into the general fund of the state treasury."	

SECTION 2.

18 All laws and parts of laws in conflict with this Act are repealed.
