

Senate Bill 502

A BILL TO BE ENTITLED
AN ACT

1 To amend Code Section 16-13-71 of the Official Code of Georgia Annotated, relating to the
2 definition of dangerous drug, so as to change certain provisions relating to Schedule II; to
3 change certain provisions relating to general registration requirements; to regulate certain
4 opioid treatments; to change certain provisions relating to the definition of dangerous drug;
5 to provide for exceptions; to provide an effective date; to repeal conflicting laws; and for
6 other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 Code Section 16-13-71 of the Official Code of Georgia Annotated, relating to the definition
10 of dangerous drug, is amended by striking paragraphs (509.1), (573), (641.1), (663.5),
11 (931.9), and (931.85) of subsection (b) and inserting in lieu thereof the following:

12 "(509.1) Ketoconazole; — See exceptions;"

13 "(573) ~~Methachloine~~ Methacholine;"

14 "(641.1) ~~Nicotin~~ Nicotine resin complex (polacrilex) — See exceptions;"

15 "(663.5) Omeprazole — See exceptions;"

16 "~~(931.9)~~(931.85) Terazosin;

17 "~~(931.85)~~(931.9) Tenofovir;"

18 **SECTION 2.**

19 Said Code section is further amended in subsection (b) by inserting new paragraphs to read
20 as follows:

21 "(.035) Abarelix;"

22 "(19.65) Alfuzosin;"

23 "(62.4) Aprepitant;"

24 "(63.5) Aripiprazole;"

25 "(67.72) Atazanavir;"

24 **SECTION 3.**

25 Said Code section is further amended in subsection (c) by inserting a new paragraph to read
 26 as follows:

27 "(16.9) Omeprazole — when a single dosage unit is 20 mg. or less;".

28 **SECTION 4.**

29 Said Code section is further amended in subsection (c) by striking paragraph (28.5) and
 30 inserting in lieu thereof the following:

31 "(28.5) Triprolidine — when a single dose is 5 mg. or less when combined in the same
 32 preparation as one or more other drug products for use as an antihistamine or
 33 decongestant or an ~~antihistamine~~ antihistamine and decongestant;".

1 **SECTION 5.**

2 This Act shall become effective upon its approval by the Governor or upon its becoming law
3 without such approval.

4 **SECTION 6.**

5 All laws and parts of laws in conflict with this Act are repealed.
