A RESOLUTION

1 Rescinding, repealing, canceling, voiding, nullifying, and superseding any and all prior
2 applications by the General Assembly heretofore made during any session thereof to the
3 Congress of the United States of America to call a convention pursuant to the terms of
4 Article V of the United States Constitution for proposing one or more amendments to that
5 Constitution and urging the legislatures of other states to do the same; and for other purposes.

6 WHEREAS, the General Assembly of the State of Georgia, acting with the best of intentions,
7 has, at various times and during various sessions, previously made applications to the
8 Congress of the United States of America to call one or more conventions to propose either
9 a single amendment concerning a specific subject or to call a general convention to propose
10 an unspecified and unlimited number of amendments to the United States Constitution,
11 pursuant to the provisions of Article V thereof; and

12 WHEREAS, the General Assembly during its 1952 Regular Session passed Resolution Act
13 No. 53 (Ga. L. 1952, p. 472), applying to Congress for a constitutional convention for the
14 limited purpose of proposing an amendment to the Constitution concerning treaty powers;
15 and

16 WHEREAS, the General Assembly during its 1952 Regular Session passed Resolution Act
17 No. 61 (Ga. L. 1952, p. 480), applying to Congress for a constitutional convention for the
18 limited purpose of proposing an amendment to the Constitution concerning limiting taxation;
19 and

20 WHEREAS, the General Assembly during its 1955 Regular Session passed Resolution Act
21 No. 2 (Ga. L. 1955, p. 4), applying to Congress for a constitutional convention for the limited
22 purpose of proposing an amendment to the Constitution concerning the independence of state
23 schools; and

1 WHEREAS, the General Assembly during its 1959 Regular Session passed Resolution Act
2 No. 45 (Ga. L. 1959, p. 383), applying to Congress for a constitutional convention for the
3 limited purpose of proposing an amendment to the Constitution concerning the independence
4 of state schools; and

5 WHEREAS, the General Assembly during its 1961 Regular Session passed Senate
6 Resolution No. 39, applying to Congress for a constitutional convention for the limited
7 purpose of proposing an amendment to the Constitution concerning the authority of the
8 Supreme Court; and

9 WHEREAS, the General Assembly during its 1965 Regular Session passed Resolution Act
10 No. 89 (Ga. L. 1965, p. 559), applying to Congress for a constitutional convention for the
11 limited purpose of proposing an amendment to the Constitution concerning the independence
12 of state schools; and

13 WHEREAS, the General Assembly during its 1967 Regular Session passed Resolution Act
14 No. 96 (Ga. L. 1967, p. 894), applying to Congress for a constitutional convention for the
15 limited purpose of proposing an amendment to the Constitution concerning refunds of
16 federal taxes to the states; and

17 WHEREAS, the General Assembly during its 1976 Regular Session passed Resolution Act
18 No. 93 (Ga. L. 1976, p. 184), applying to Congress for a constitutional convention for the
19 limited purpose of proposing an amendment to the Constitution concerning a federal
20 balanced budget; and

21 WHEREAS, the General Assembly during its 1991 Regular Session passed House
22 Resolution No. 105 (Ga. L. 1991, p. 2041), applying to Congress for a constitutional
23 convention for the limited purpose of proposing an amendment to the Constitution with
24 respect to disrespectful actions involving the United States flag and the flags of the several
25 states; and

26 WHEREAS, former Chief Justice of the United States Supreme Court Warren E. Burger,
27 former Associate Justice of the United States Supreme Court Arthur J. Goldberg, and other
28 leading constitutional scholars agree that such a convention may propose sweeping changes
29 to the Constitution, any limitations or restrictions purportedly imposed by the states in
30 applying for such a convention or conventions to the contrary notwithstanding, thereby

1 creating an imminent peril to the well-established rights of the citizens and the duties of
2 various levels of government; and

3 WHEREAS, the Constitution of the United States of America has been amended many times
4 in the history of this nation and may be amended many more times without the need to resort
5 to a constitutional convention, and has been interpreted for more than two hundred years and
6 has been found to be a sound document which protects the lives and liberties of the citizens;
7 and

8 WHEREAS, there is no need for and there is in fact great danger in a new constitution or in
9 opening the Constitution to sweeping changes, the adoption of which would only create legal
10 chaos in this nation and only begin the process of another two centuries of litigation over its
11 meaning and interpretation.

12 NOW, THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY OF
13 GEORGIA that the General Assembly does hereby rescind, repeal, cancel, void, nullify, and
14 supersede, to the same effect as if they had never been passed, any and all prior applications
15 by the General Assembly to the Congress of the United States of America to call a
16 convention to propose amendments to the Constitution of the United States of America,
17 pursuant to the terms of Article V thereof, regardless of when and regardless of whether such
18 applications were for a more limited convention to propose one or more amendments
19 regarding one or more specific subjects and purposes or for a general convention to propose
20 an unlimited number of amendments upon an unlimited number of subjects.

21 BE IT FURTHER RESOLVED that the General Assembly hereby specifically repeals
22 Resolution Act No. 53 (Ga. L. 1952, p. 472), passed during the 1952 Regular Session of the
23 Georgia General Assembly; Resolution Act No. 61 (Ga. L. 1952, p. 480), passed during the
24 1952 Regular Session of the Georgia General Assembly; Resolution Act No. 2 (Ga. L. 1955,
25 p. 4), passed during the 1955 Regular Session of the Georgia General Assembly; Resolution
26 Act No. 45 (Ga. L. 1959, p. 383), passed during the 1959 Regular Session of the Georgia
27 General Assembly; Senate Resolution No. 39, passed during the 1961 Regular Session of the
28 Georgia General Assembly; Resolution Act No. 89 (Ga. L. 1965, p. 559), passed during the
29 1965 Regular Session of the Georgia General Assembly; Resolution Act No. 96
30 (Ga. L. 1967, p. 894), passed during the 1967 Regular Session of the Georgia General
31 Assembly; Resolution Act No. 93 (Ga. L. 1976, p. 184), passed during the 1976 Regular
32 Session of the Georgia General Assembly; and House Resolution No. 105 (Ga. L. 1991,
33 p. 2041), passed during the 1991 Regular Session of the Georgia General Assembly.

1 BE IT FURTHER RESOLVED that the General Assembly urges the legislatures of each and
2 every state that has applied to Congress to call a convention for either a general or limited
3 constitutional convention to repeal and withdraw such applications.

4 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized
5 and directed to transmit an appropriate copy of this resolution to the presiding officers of
6 both houses of the legislatures of each state in the Union, the President of the United States
7 Senate, the Speaker of the United States House of Representatives, each member of the
8 Georgia Congressional delegation, and the Administrator of General Services.
