

The House Committee on Game, Fish & Parks offers the following substitute to HR 1256:

A RESOLUTION

1 Urging the Congress of the United States to consider creating a national preserve or other
2 similar federal property to protect land and other natural resources and promote hunting and
3 fishing in a continuous corridor of the Ocmulgee and Altamaha Rivers in central and south
4 Georgia; and for other purposes.

5 WHEREAS, there exist a number of federal and state government properties in a corridor
6 extending down and along the Ocmulgee River from the Georgia Highway 16 bridge at the
7 Butts County-Jasper County line to that river's confluence with the Oconee River and thence
8 down and along the Altamaha River to the U.S. Highway 1 bridge in Appling County, such
9 public properties including but not being limited to all of the Oconee National Forest south
10 of I-20, Piedmont National Wildlife Refuge, Rum Creek Wildlife Management Area,
11 Ocmulgee National Monument (including the Ocmulgee Old Fields), Ocmulgee Wildlife
12 Management Area, Bond Swamp National Wildlife Refuge, Broxton Rocks Wildlife
13 Management Area, and Moody Forest Natural Area; and

14 WHEREAS, while these public lands along or near the Ocmulgee and Altamaha Rivers are
15 relatively near to each other, they remain fragmented, under different management, and
16 dedicated to different purposes; and

17 WHEREAS, the location and proximity of these current public land holdings along the
18 Ocmulgee and Altamaha Rivers yet present a unique opportunity to achieve, in a single
19 effort, a number of important goals benefiting the general public, preserving valuable natural
20 and historic resources, promoting hunting and fishing, stimulating local economies, and
21 enhancing military operations; and

22 WHEREAS, connecting these public land holdings by acquisition of interstitial private
23 properties along the rivers from willing sellers or by donation but not by exercise of the
24 power of eminent domain, consolidating the public land corridor thus created under federal
25 ownership through conveyances from the state, and unifying the purpose and management

1 of such corridor by conferring national preserve or other federally protected status on the
2 continuous whole would create a great protected river corridor consisting of an integrated
3 system of scenic, historic, and recreational resources for the enjoyment of the nation at large;
4 and

5 WHEREAS, such a national preserve or other similar federal property protecting land and
6 other natural resources also would stimulate local economies through tourism while
7 protecting water supplies and other natural resources, providing roaming range for wildlife,
8 promoting hunting and fishing, and protecting Robins Air Force base from being encircled
9 and trapped by development which could limit mission capability.

10 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
11 the Congress of the United States be and is hereby urged to consider creating a national
12 preserve or other similar federal property to protect land and other natural resources and
13 promote hunting and fishing in a continuous corridor of the Ocmulgee and Altamaha Rivers
14 in central and south Georgia as described and for the reasons stated above.

15 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized
16 and directed to transmit appropriate copies of this resolution to the following members of the
17 Congress of the United States: the Speaker of the House of Representatives; Majority Leader
18 of the Senate; chairperson of the Senate Committee on Energy and Natural Resources;
19 chairperson of the House Committee on Resources; and each member of Georgia's
20 congressional delegation.
