A BILL TO BE ENTITLED  
AN ACT

1 To amend Article 7 of Chapter 2 of Title 40 of the Official Code of Georgia Annotated,  
2 relating to motor vehicle license fees and classes, so as to change certain provisions relating  
3 to fees for operation of vehicles; to change certain provisions relating to restricted license  
4 plates for vehicles; to provide for related matters; to repeal conflicting laws; and for other  
5 purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 Article 7 of Chapter 2 of Title 40 of the Official Code of Georgia Annotated, relating to  
9 motor vehicle license fees and classes, is amended in Code Section 40-2-151, relating to  
10 annual license fees for operation of vehicles and fee for permanent licensing of certain  
11 trailers, by striking paragraph (3) of subsection (a) of said Code section and inserting in its  
12 place the following:

13 "(3)(A) For each private truck in accordance with the owner declared gross  
14 vehicle weight, as follows:

15	(i) Less than 14,000 lbs. ....	20.00
16	(ii) 14,000 to 18,000 lbs. ....	25.00
17	(iii) 18,001 to 26,000 lbs. ....	38.00
18	(iv) 26,001 to 30,000 lbs. ....	45.00
19	(v) 30,001 to 36,000 lbs. ....	70.00
20	(vi) 36,001 to 44,000 lbs. ....	115.00
21	(vii) 44,001 to 54,999 lbs. ....	190.00
22	(viii) 55,000 to 63,280 lbs. ....	300.00
23	(ix) 63,281 lbs. to maximum permitted ....	400.00

24 (B) Subparagraph (A) of this paragraph notwithstanding:

- 1 (i) A straight truck which is not a truck-tractor shall not be classified higher  
2 than \$75.00;
- 3 (ii) A straight truck hauling fertilizer ~~and~~ or agricultural products shall not  
4 be classified higher than \$31.00; and
- 5 (iii) A truck-tractor hauling fertilizer, ~~or~~ milk, or crops as defined in  
6 paragraph (7.1) of Code Section 1-3-3 shall not be classified higher than  
7 \$220.00;"

8 **SECTION 2.**

9 Said article is further amended in Code Section 40-2-152, relating to fees for apportionable  
10 vehicles and restricted license plates for vehicles, by striking subsection (f) of said Code  
11 section and inserting in its place the following:

12 "(f) A truck or a truck-tractor hauling fertilizer, ~~or~~ milk, or crops as defined in paragraph  
13 (7.1) of Code Section 1-3-3 shall be issued a restricted license plate with the fee computed  
14 in accordance with Code Section 40-2-151."

15 **SECTION 3.**

16 All laws and parts of laws in conflict with this Act are repealed.
