

Senate Bill 564

A BILL TO BE ENTITLED  
AN ACT

1 To amend Chapter 5 of Title 40 of the Official Code of Georgia Annotated, relating to  
2 drivers' licenses, so as to provide that a social security number shall not be used by the  
3 Department of Motor Vehicle Safety as a driver's license or identification card number; to  
4 provide for related matters; to repeal conflicting laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 style="text-align:center">**SECTION 1.**

7 Chapter 5 of Title 40 of the Official Code of Georgia Annotated, relating to drivers' licenses,  
8 is amended by striking Code Section 40-5-28.1, relating to use of social security numbers,  
9 and inserting in its place the following:

10 "40-5-28.1.

11 No license or permit issued or renewed on or after July 1, ~~1997~~, 2004, pursuant to this  
12 article shall contain the social security number of the licensee or permit holder ~~unless such~~  
13 ~~person specifically requests the use of such number."~~

14 style="text-align:center">**SECTION 2.**

15 Said chapter is further amended by striking subsection (b) of Code Section 40-5-100, relating  
16 to identification cards for persons without drivers' licenses, authorization to issue cards,  
17 contents, and possession, and inserting in its place the following:

18 "(b) The identification card shall be valid for four years and shall bear the signatures of the  
19 commissioner and the Governor and shall bear an identification card number which shall  
20 not be the same as the social security number, ~~unless the person specifically requests that~~  
21 ~~the social security number be used~~, or, in the case of an individual who is not a citizen of  
22 the United States, the passport number of the person identified or any number the  
23 department deems necessary to implement this Code section."

**SECTION 3.**

Said chapter is further amended by striking paragraph (5) of subsection (a) of Code Section 40-5-150, relating to contents of driver's license, classifications, endorsements and restrictions, information to be obtained before issuance, expiration of license, and renewal, and inserting in its place the following:

~~"(5) The person's social security number if such person has requested the use of such social security number on such license or another~~ A driver's license number or identifier deemed appropriate by the department which shall not be the same as the person's social security number;".

**SECTION 4.**

Said chapter is further amended by striking subsection (b) of Code Section 40-5-171, relating to issuance and contents of identification cards for persons with disabilities, and inserting in its place the following:

"(b) The identification card for persons with disabilities shall bear the signatures of the commissioner and the Governor and shall bear an identification card number which shall not be the same as the applicant's social security number, ~~unless the person specifically requests that the social security number be used,~~ or, in the case of an individual who is not a citizen of the United States, the passport number of the person identified or any number the department deems necessary to implement this Code section."

**SECTION 5.**

All laws and parts of laws in conflict with this Act are repealed.
