A BILL TO BE ENTITLED
AN ACT

1 To amend an Act creating the board of commissioners of Dade County, approved April 4,
2 1991 (Ga. L. 1991, p. 3893), as amended, particularly by an Act approved May 1, 2002
3 (Ga. L. 2002, p. 5339), so as to revise the districts for the election of members of the board;
4 to provide for definitions and inclusions; to provide for submission of this Act for
5 preclearance pursuant to Section 5 of the federal Voting Rights Act of 1965, as amended; to
6 provide an effective date; to repeal conflicting laws; and for other purposes.

7 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

8 **SECTION 1.**

9 An Act creating the board of commissioners of Dade County, approved April 4, 1991
10 (Ga. L. 1991, p. 3893), as amended, particularly by an Act approved May 1, 2002
11 (Ga. L. 2002, p. 5339), is amended by striking subsections (a) and (b) of Section 2 and
12 inserting in lieu thereof new subsections (a) and (b) to read as follows:

13 "(a) For the purpose of electing the members of the board of commissioners, except of the
14 chairperson/county executive, Dade County is divided into four commissioner districts
15 which shall correspond to those four numbered districts described in and attached to and
16 made a part of this Act and further identified as Plan Name: dadeccp1 Plan Type: Local
17 User: staff Administrator: Dade Co.

18 (b) When used in such attachment, the terms 'Tract' and 'BG' (Block Group) shall mean
19 and describe the same geographical boundaries as provided in the report of the Bureau of
20 the Census for the United States decennial census of 2000 for the State of Georgia. The
21 separate numeric designations in a Tract description which are underneath a 'BG' heading
22 shall mean and describe individual Blocks within a Block Group as provided in the report
23 of the Bureau of the Census for the United States decennial census of 2000 for the State of
24 Georgia. Any part of Dade County not included in any such district described in that
25 attachment shall be included within that district contiguous to such part that contains the
26 least population according to the United States decennial census of 2000 for the State of

1 Georgia. Any part of Dade County described in that attachment as being in a particular
2 district shall nevertheless not be included within such district if such part is not contiguous
3 to such district. Such noncontiguous part shall instead be included within that district
4 contiguous to such part that contains the least population according to the United States
5 decennial census of 2000 for the State of Georgia. Except as otherwise provided in the
6 description of any district, whenever the description of such district refers to a named city,
7 it shall mean the geographical boundaries of that city as shown on the census map for the
8 United States decennial census of 2000 for the State of Georgia."

9 **SECTION 2.**

10 The Board of Commissioners of Dade County shall through its legal counsel cause this Act
11 to be submitted for preclearance under the federal Voting Rights Act of 1965, as amended;
12 and such submission shall be made to the United States Department of Justice or filed with
13 the appropriate court no later than 30 days after the date on which this Act is approved by the
14 Governor or otherwise becomes law without such approval.

15 **SECTION 3.**

16 This Act shall become effective upon its approval by the Governor or upon its becoming law
17 without such approval.

18 **SECTION 4.**

19 All laws and parts of laws in conflict with this Act are repealed.
